## ONE HUNDRED NINETEENTH STATED MEETING

#### CALL TO ORDER

The Presbytery was called to order at 10:00 a.m. by the Moderator, Ruling Elder Pamilla Ferrell.

#### **GREETINGS**

Pastor Robert Wood welcomed the Presbytery. Bream Memorial Church was organized in 1910. Various non-profit organizations are housed in the church buildings.

Frank Mansell was elected to serve as Temporary Recording Clerk for this meeting of presbytery. He was nominated by Jim Robinson and the floor was opened for other nominations.

Acting Stated Clerk Jim Robinson announced that no new Teaching Elders have been enrolled in the presbytery since the last meeting. There were no visiting Teaching Elders.

Robinson recognized and welcomed visitors and elder commissioners attending their first Presbytery meeting.

Robinson noted that there are no new corresponding members.

Forrest Palmer, Interim Executive, introduced members of the presbytery staff each of whom spoke about the work that they do: Craig Butler, Claire Butler, Leslie Curtis, Maureen Wright, Susan Sharp Campbell, Lois Coffey, Karen Robinson, and Mark Miller.

#### **QUORUM**

The Acting Stated Clerk presented the proposed amendments to the Constitution of the Presbyterian Church (USA) sent to the presbyteries by the 220<sup>th</sup> General Assembly (2012) for their affirmative or negative vote. A time was provided for discussion. Voting on the amendments came later in the meeting.

The Moderator recognized Lois Coffey who presented the report of the Stewardship Committee. (Appendix C, pages 29-38.)

#### PROCEDURAL MATTERS

Following a recess for lunch the presbytery reconvened at 1:30 p.m. with a hymn and prayer led by the Moderator. The Moderator called on Robinson who presented the Procedural Matters and moved item C3. After receiving a second, Presbytery **adopted** the motion by a two-thirds vote. (Appendix D, page 39.)

#### STATED CLERK'S REPORT

The Moderator recognized Acting Stated Clerk Jim Robinson who presented the Stated Clerk's report. The presbytery received the report as information.

ACTION: Referred to Ministry Committee for action to transfer Rev. Tiedeck.

5. 1/17/13 Letter dated 1/13/13 from the Clerk of Session of the Marsh Fork United Presbyterian Church, Dry Creek, WV, requesting exemption from the requirement for the rotation of elders serving on Session.

ACTION: Referred to Ministry Committee for action.

6. 1/26/13 Received by e-mail allegations of violations of the Sexual Misconduct Policy against a person in pastoral leadership in the WV Presbytery.

ACTION: Asked a member of the Response Team to contact the alleged victim and asked the Presbytery Moderator to name an Investigating Committee in accordance with the WV Policy.

7. 1/29/13 Received the 2011 minutes of the Pickens Presbyterian Church sent 1/23/13 for review.

ACTION: Conducted a review, found them to be complete, without discrepancies, and returned them.

8. 2/20/13 Letter dated 2/12/13 from Lesley Shoup, Synod Stated Clerk, informing WV Presbytery of positions open on Synod level committees.

ACTION: Referred to Nominating Committee for action.

# INFORMATION:

- A. MINUTES. The minutes of the December 8, 2012 meeting of the Presbytery of West Virginia have been approved in accordance with the provisions of the Manual.
- B. PROPERTY. By recommendation of the Trustees and in accordance with provisions of the Manual, the Presbytery Moderator, the Chair of the Leadership Team, and the Acting Stated Clerk met on February 18, 2013 to approve the sale of 10% interest in 11 oil and gas wells left to the First Presbyterian Church, Clarksburg by the estate of Betty Dodd. The net sale amount is approximately \$7,678. Also heard from the Chair of the Trustees about other projects regarding property discussed at the latest meeting of the Trustees.
- C. Contacted Constitutional Services Office of the Office of the General Assembly asking about the status of churches that were dismissed to another denomination, but the receiving denomination did not complete their action to receive the churches. The official position is that those churches have been returned to this presbytery/denomination. That information has been communicated by letter to the three churches; First, Mullins, Grace, Lashmeet, and Melrose, Princeton.
- D. Numerical parity of Teaching and Ruling Elders in the Presbytery. The Book of Order G-3.0301 requires that a presbytery address any imbalance that may exist between the number of resident Teaching Elders entitled to vote and the number of Ruling Elders representing congregations. No imbalance appears to exist in the Presbytery of West

Virginia. At the end of 2012 we had 138 congregations entitled to send 141 Elder Commissioners to meetings of the presbytery. There are 130 Teaching Elders who are members of the presbytery, of which 47 are honorably retired, and thus not required to participate in meetings.

## MISSIONS COMMITTEE REPORT

The Moderator recognized Todd Wright who presented the report of the Missions Committee. There are seven participants for the April 2013 mission trip to Nicaragua; they are Claire Butler, Steve and Barbara Hopta, Greg Kupar, John Nelson, David Pettry and Todd Wright. The Moderator led the presbytery in a commissioning service, concluding with the following unison prayer.

Holy God, you are at one in this place and in all places. We ask your blessing on these your children. May they sense your presence and power as they meet new people and learn new things. May they hear your living Word through the voices of persons who speak your truth and seek your peace. May they experience the mystery of the body of Christ, which is alive across national boundaries and cultural differences. May they be encouraged and renewed daily by your energetic Spirit so that the restorative power of your grace is present with them always. Amen.

In response to the morning's Moment for Mission presentation by Steve Smith of Healthy Kids & Families, presbytery voted to endorse the work of Mr. Smith and the Healthy Kids & Families.

The Missions Committee reported the following additional information about their work.

- A. On January 25, 2013 the new Missions committee met for the first time and explored our tasks now that we are combining elements of CDC, MIS, and SEMC. We decided to meet quarterly at locations around the presbytery. Those meetings would include time for subgroup meetings on international, local, and church related mission; a joint meeting, and a "site visit" for one of the organizations the presbytery supports. Our next meeting will be Feb. 20<sup>th</sup> at Mt. Hope to visit the WVMAW site.
- B. We heard a report from Bob McCutcheon on the January 2013 trip to Nyeri. Wonderful connections were made. They are grateful for our help funding a variety of projects. D&E is exploring a partnership with the University of East Africa and Bob will spend part of a sabbatical teaching there.
- C. We heard a report on the April 2013 trip to Nicaragua and approved using funds in our 2013 budget to underwrite the per diem cost of the seven folks going on the trip; we will also draw on these funds to pay for Claire Butler's air fare.
- D. We dealt with several topics from the former SEMC: agreeing to follow the 2012 schedule of receiving grant requests; deciding to make site visits to WVMAW, Davis Stuart, PROWL at Marshall along with the Girl's Place at Bates Memorial, and the Shack in 2013; and appointing a team to look at the Presbytery's covenant with Davis and Elkins.
- E. Joan Stewart reported about WVMAW's ongoing work in response to a durecho and blizzard, operating out of 8 locations.
- F. We heard from Claire Butler that she is following through on GA's request for peacemaking opportunities to educate congregations with a series of workshops.

The Moderator recognized Sharon Rowe who presented the report of the Administration Committee. The presbytery adopted the recommendation of the committee including the approval of the position description.

## POSITION DESCRIPTION

STATED CLERK Half Time (20 hrs/week)

TITLE: Stated Clerk

PURPOSE: The Stated Clerk shall be the continuing ecclesiastical officer of

the Presbytery.

ACCOUNTABILITY: As an officer of the Presbytery, the Stated Clerk shall be

accountable to the Presbytery for the responsibilities assigned by the *Book of Order*. As a staff member of the Presbytery, the Stated Clerk shall be accountable to the Administration Committee and

supervised by the General Presbyter.

TERM OF SERVICE: Five years, eligible for reelection.

## **RESPONSIBILITIES:**

- 1. The Stated Clerk shall be responsible for the duties assigned in the Book of Order (G-3.0104 minutes, rolls and records; G-3.0108 administrative review of Session records; G-3.0109 –judicial and administrative commissions; D-11.0600 judicial process).
  - a. The Stated Clerk shall be the custodian of all ecclesiastical records of the Presbytery, working with the administrative staff to maintain the records and rolls of the presbytery.
  - b. The Stated Clerk shall work with the Ministry Committee in recording and reporting changes in pastoral relationships, including the establishment and renewal of temporary pastoral relationships.
  - c. The Stated Clerk shall work with the Ministry Committee in establishing pastoral relationships, sharing information with Pastors and Sessions about commissions to ordain and/or install, notifying members of the commission, and receiving and filing the minutes of commissions.
  - d. The Stated Clerk shall conduct the annual Session records review.
  - e. The Stated Clerk shall provide minutes and other records of the Presbytery to the Synod as required and shall ordinarily participate in the Synod's review of presbytery records.
  - f. The Stated Clerk shall provide assistance to Sessions in preparing Annual Statistical Reports and shall prepare and transmit the Presbytery's report to the Stated Clerk of the General Assembly.
- 2. The Stated Clerk shall ordinarily serve as the parliamentarian of the Presbytery.

- 3. The Stated Clerk shall serve as clerk to the Leadership Team, assisting particularly with the planning of presbytery meetings.
- 4. The Stated Clerk shall serve as staff support for the Trustees of the Presbytery.

5. The Stated Clerk shall provide orientation and support for Commissioners to meetings of the General Assembly and shall ordinarily attend General Assembly meetings.

COMPENSATION: Defined in terms of call, reviewed annually by the Administration

Committee and approved by the Leadership Team and the

Presbytery. This position is exempt from overtime.

EVALUATION: An annual performance review by the General Presbyter and the

Administration Committee and a comprehensive review by these

same parties at the end of a five-year term.

#### PERSON DESCRIPTION

The Stated Clerk, in so far as possible, should have these qualifications, characteristics, and abilities:

- 1. Have a personal commitment to and relationship with God.
- 2. Be a Ruling or Teaching Elder in the Presbyterian Church (USA).
- 3. Have a minimum of five years experience in the Presbyterian Church (USA).
- 4. Perceive self as a servant leader and exhibit a working style that is collegial and consultative.
- 5. Have an extensive knowledge of Presbyterian polity and the theology that informs that polity.
- 6. Ordinarily have some experience with the work of a Stated Clerk.
- 7. Be willing and able to fulfill the responsibilities of the office with minimal clerical assistance.
- 8. Have the ability to follow through on details.
- 9. Be available to maintain regular hours in the Presbytery office.
- 10. Have experience with computers and a willingness to learn specific processes currently used in the church.

# LEADERSHIP TEAM REPORT

The Moderator recognized Stephen Baldwin who presented the report of the Leadership Team. The report was received as information by the presbytery.

#### **INFORMATION**

- 1. At the December 2012 meeting, you elected the Leadership Team: Pam Ferrell, Randy Fife, Barbara Accord, Sharon Rowe, Dave Lee, Bob Wood, Agnes Doyle-Kalland, Nancy Tissue, John McKinnon, Todd Wright, Robin Ray, & Cinda Harkless.
- 2. We met for a retreat Feb 15-16 in order to "orient" ourselves, moving from the "Council" model to the new "Leadership Team" model.

- a. A working draft of the "Leadership Team" model and "Leadership Team Member Job Description" follows:
  - i. The Leadership Team acts as the session of the Presbytery by promoting our core values (ministry, mission, and relationships), providing strategic leadership, and entrusting daily management to staff and committees.
  - ii. Because much of our work will be strategic "visioning," we want to meet more often so we can get to know one another personally and spend time discerning God's good plans for our Presbytery.
- 3. Much of our retreat time centered on a book we read and discussed at length: *The Fly in the Ointment: Why Denominations Aren't Helping Their Congregations and How They Can* by J. Russell Crabtree.
- 4. Communion was approved for the PWV Presbyterian Women's Retreat on April 9 at Edgewood (Lewisburg) with Joanne Glaser presiding and for the Staff Retreat at Blessed John XXIII Center on February 19.
- 5. We named a working group (Jim Robinson, Pam Ferrell, & Tina Vial) to update the PWV Manual so that it reflects the Jeremiah 29.11 Group changes overwhelmingly approved by the PWV and enacted over the past year.
- 6. Part of the transition process involves a brand new Nominating Committee. We discussed the purpose and nature of that committee fundamentally shifting from a group that "fills slots" to one which "matches the gifts and passions of the people of the Presbytery of WV with opportunities to serve God." W.D. Hasty agreed to Chair the Nominating Committee. A revised committee description is being drafted now.
- 7. Craig Butler updated us on the development of Clusters. As of now, the following cluster shepherds have been identified: Susan Sharp Campbell (Greenbrier Valley), Elizabeth Campbell-Maleke (Parkersburg), John Bolt (Clarksburg), Joanne Glaser (Mountain Valley), and John McKinnon (Beckley). Craig asked us to provide him a job description for the shepherds, which we are doing.
- 8. We considered all facets of Presbytery meetings. Moving forward, the Clerk and Moderator will work with the General Presbyter to set the agenda for each meeting based on the strategic counsel of the Leadership Team (who will set themes for each meeting).
  - a. The March 2013 meeting at Bream will focus on our relationship with the larger church, including votes on constitutional amendments.
  - b. The June 2013 meeting at First Presbyterian, Charleston will focus on effective ministry within our churches.
  - c. The September 2013 meeting at Fayetteville will focus on missions, hopefully including an outdoor activity on the Friday before the meeting.
  - d. The November 2013 meeting at First Presbyterian, Huntington will focus on relationship-building as we welcome the Moderator of the PCUSA, Neal Presa.

#### PRESBYTERY OF WEST VIRGINIA

Leadership Team, Overview (DRAFT)

## Charge

The Leadership Team is charged to do just that—lead our team...by discerning a vision from our core values, actualizing that vision through our committees and staff, and revising the vision regularly in light of change.

# Responsibilities

- 1. Promote the core values of ministry (service to those inside the church), mission (service to those in the community), and relationship-building (building connections with God and one another)
- 2. Act on major issues before the PWV
- 3. Provide necessary direction to and/or oversight of committees and staff, so they may manage the PWV on a daily basis
- 4. Ensure PCUSA polity is followed decently and in order
- 5. Plan PWV meetings (this includes not simply the logistics of each meeting but securing locations in advance, rotating throughout the clusters)
- 6. Nominate the members of the Nominating Committee

## <u>Members</u>

- 1. The Presbytery shall elect three classes of four members each, totaling 12 members of the Leadership Team. These members should be persons of wisdom, humility, and vision who have earned the trust of the PWV.
- 2. The Nominating Committee will make nominations, supplemented by those from the floor of the appropriate Presbytery meeting. Major committees should be represented, not necessarily by their chairs, but by strong leaders.
- 3. Each term is three years and may be renewed once. At least one year must pass after serving two consecutive terms before serving again.
- 4. The immediate past Moderator of the PWV will chair the Leadership Team. She/he will vote only in the case of a tie.
- 5. Two staff members will attend the meetings of the Leadership Team--the General Presbyter, acting as Head of Staff, and the Stated Clerk, acting as Recorder. Both will have the power of voice but not vote.

# **Meetings**

- 1. The Leadership Team meets at least quarterly in person approximately one month in advance of four regular meetings of the PWV, preferably in rotating clusters.
- 2. The first meeting of the year will be a 24-hour retreat to plan the year ahead.
- 3. Regular meetings should be supplemented by affinity groups as needed on particular issues facing the Leadership Team. Such meetings should make use of in-person, phone, and videoconference meetings.
- 4. Staff members will be invited to attend particular meetings and conversations, based on their area of expertise and service and the agenda before the Leadership Team.

#### PRESBYTERY OF WEST VIRGINIA

Leadership Team, Job Description (DRAFT)

TITLE: Member of the Leadership Team

PURPOSE: Provide strategic leadership for the Presbytery of West Virginia

ACCOUNTABILITY: You are elected by the PWV and shall be accountable to the commissioners thereof. You work in concert with the Chair of the Leadership Team.

TERMS OF SERVICE: A term lasts three years, once renewable

## **RESPONSIBILITIES:**

- 1. Attend all Leadership Team meetings (in person, via phone, and videoconference) and read related packets (usually containing reports from committees and staff members).
- 2. Serve on affinity groups of the Leadership Team, created to address particular issues of importance to the PWV.
- 3. Active participation in your local cluster and surrounding clusters as able, so that you are aware of your church context.
- 4. Make yourself available to committees and staff members for dialogue.
- 5. Attend PWV meetings as able.

#### DESCRIPTION:

Leadership Team members, in so far as possible, should have these qualifications, characteristics, and abilities:

- 1. Hold a deep and abiding relationship with God.
- 2. Lead & think strategically, entrusting management to others.
- 3. Maintain an active personal and communal spiritual life.
- 4. Be honest and hopeful at the same time.
- 5. Abide by the principle of "truth, in order to goodness."

## NURTURE COMMITTEE REPORT

The report was shared in print as information.

- A. **Festival of Faith** will be April 6, 2013. Jack Haberer, editor of *the Presbyterian Outlook* will be the keynote speaker. "United in God's Mission" is the theme. The location is the First Presbyterian Church of Charleston. Packets have been sent to all congregations. **Pre-registration deadline is March 21.**
- B. **Youth Summer Trip:** Presbyterian Youth Triennium, July 15-20 at Perdue University. Six youth have received scholarships. Additional funds are available. **The registration deadline is March 15, 2013.**
- C. **Youth Council** applications will go out in March. Nine youth council members are graduating this year. We also need new adult members.
- D. At our next meeting we will be reviewing the revised **Child Protection policy**, with hopes that it can be approved at the June Presbytery meeting.
- E. Karen Robinson reported the following year-end figures for the **Resource Center** in 2012: Checked in 540, checked out 527
  Items added 218, deleted 374

Patrons added 29, deleted 129 Online Catalogue main: 68 views, Kidz: 5 views.

#### TRUSTEES REPORT

The report was shared in print as information.

The Trustees met on February 7, 2013 at the Presbytery office.

- 1. We will recommend that the Presbytery (represented by the Moderator, Chair and Acting Stated Clerk) approve a request from First Church, Clarksburg to sell a 10% interest in 11 oil and gas wells bequeathed by Betty Dodd for approximately \$7,678.
- 2. We considered a request from The First Presbyterian Church of Ripley to borrow from the First United Presbyterian Church of Ravenswood \$20,000 in order to replace a roof, which said loan is to be secured by a deed of trust. Due to inadequate information, the Trustees are unable to make a recommendation to the Presbytery at this time.
- 3. We considered a request from The First Presbyterian Church, Huntington to sell 23 acres in Putnam County (which the church does not intend to use but is paying approximately \$500 in annual taxes) for \$6,000. Because the tract is assessed for slightly more than \$20,000, we did not have sufficient information about the transaction to conclude that \$6,000 was close to fair market value. Therefore, we are unable at this time to recommend that the Presbytery approve the sale request.
- 4. New and revised Trustee Manuals were provided to all six Trustees.

## INTERIM EXECUTIVE PRESBYTER'S REPORT

The report was shared in print as information.

2103 initiated the new committee structure and cluster development, envisioned by the Jeremiah 29:11 mission plan, adopted by the Presbytery in December 2011. Transition continues, as we move forward into a new way of linking the presbytery with the congregations, pastors and Ruling Elders within the presbytery. Forward progress is being made! The Ministry Committee had a retreat and meeting, January 21-22. The Leadership Team had a retreat and meeting, February 18-19.

## Staff

The full staff continues to meet monthly, with weekly check-ins for office staff as needed. The staff read the same book as the Leadership Team, *The Fly in the Ointment: Why Denominations Aren't Helping Their Congregations and How They Can* by J. Russell Crabtree, focusing on how we can better serve our congregations so that they might be vital, healthy congregations.

The staff had a retreat day on Tuesday, February 19, led by Debbie Rundlett, General Presbyter for Muskingum Valley Presbytery, on the general theme of "Leadership in Changing Times."

New Office Administrator, Leslie Curtis, has initiated a new newsletter, offered twice a month, designed to connect presbytery with its member congregations. Office management is approached with enthusiasm, optimism and a felt hospitality offered every guest who visits the

office. A team approach to the office continues to develop, as the staff works together to support the congregations of this presbytery.

The search committee for the Bluestone Director position has been at work, and the search committee for the Stated Clerk has begun work, as we continue to build a staff team to serve this presbytery.

# **Special functions since the last Presbytery meeting**

- --Since I began as Interim Executive Presbyter, March 1, 2011, I have visited 61 different churches, 2 campus ministries, 1 chaplaincy and a total of 109 different church visits.
- --With 16 persons from the Presbytery of West Virginia attending and a total of over 800 registrants at the APCE Annual Event, I was installed as President of APCE, a five denomination association to support and advocate for educational ministry. My term concludes after the Feb. 2014 Annual Event.



#### APPENDIX D

### PROCEDURAL MATTERS

- A. Principles of Parliamentary Law
  - Courtesy to all
  - Majority rule
  - Justice for all

- One Item at a time
- Respect the rights of the minority
- Partiality for none
- Usually pro and con speakers will alternate and individual speaking will identify his or her position.
- No one is allowed to speak more than once on a pending question until all wishing to speak have been heard; a person can then speak a second time, but no more than twice (unless the body gives special permission by two-thirds vote for a third speech).
- B. Relevant Provisions of Presbytery's Manual (Section III of Manual)
  - 1. "No new business shall be introduced after Presbytery recesses for lunch (unless by twothirds vote Presbytery sets a different deadline for introduction of new business), and any new business not listed on the Docket shall be presented in written form."
  - 2. "...each elder elected an officer, Executive Presbyter, or a member of Council of Presbytery shall be enrolled as a member of the Presbytery for the term of office, whether or not commissioned by his or her session, in accordance with G-3.0306."
  - 3. "The privilege of the floor without vote shall be granted to lay members of Presbytery's committees and to laypersons serving on Presbytery's staff, if not enrolled as members of the Presbytery."
  - 4. "The privilege of the floor without vote shall be granted to professional church educators serving the churches of Presbytery, if not enrolled as members of the Presbytery."

NOTE: The phrase, "privilege of the floor without vote," means that the person has the privilege of speaking on the floor of Presbytery, including debating a motion under consideration, subject to rules and guidelines that govern discussion and debate. However, the person does not have the privilege to make motions or to vote.

Those who have "privilege of the floor without vote" are lay members of committees, lay members of Presbytery staff, church educators, and youth advisory delegates. Those with "voice and vote" privileges are member ministers, elder commissioners, Commissioned Lay Pastors, Executive Presbyter, Stated Clerk, Recording Clerk, Treasurer, Vice-Moderators, Moderator, and Council Members.

- C. Procedural Rules for the meeting of Presbytery (approval by two-thirds vote required to adopt #3).
  - 1. Persons wishing to speak to the Presbytery giving a report, debating a motion, raising questions will do so by using the microphones.
  - 2. Each speaker, after recognition by the Moderator, will give his or her name and church name (or other relationship to the Presbytery if not pastor or elder commissioner from a session).
  - 3. Limitation of Debate 30 minutes per main motion, with each individual limited to 3 minutes per speech.
  - 4. A recommendation from a committee or other entity elected by the Presbytery, upon being presented to Presbytery by an elected member of that entity, is considered to be on the floor for Presbytery's debate, amendment, and disposition without the necessity of a motion placing the recommendation on the floor.
