CALL TO ORDER

The meeting was called to order with prayer at 10 a.m. by Moderator Peter Vial.

GREETINGS FROM BEECHWOOD PRESBYTERIAN CHURCH

Rick Johnson, pastor at Beechwood Church, greeted and extended a warm welcome on behalf of the congregation.

INTRODUCTIONS AND RECOGNITIONS

The Moderator called on the Stated Clerk who welcomed New Teaching Elders, Kyle Key and Edward Thompson, and asked them to sign the Book of Obligations.

Ruling Elders attending Presbytery for the first time were recognized.

STATEMENT OF QUORUM

Stated Clerk Wright stated there was a quorum present of 41 teaching elders and 41 commissioners from churches. (Attendance record in Appendix A, pages 14-20.)

ADMINISTRATION COMMITTEE - PART I

The Moderator recognized Sharon Rowe, Chair of the Administration Committee. Ms. Rowe called on former Presbytery Administrative Assistant Leslie Curtis and thanked her for her service to the Presbytery. A donation was given to the Alzheimer's Association in her honor.

MODERATORIAL APPOINTMENTS

Moderator Vial appointed Nancy Didway, Teaching Elder, Highlawn, St. Albans; Pat Ryan, Teaching Elder, Kuhn Memorial Barboursville; Kathryn McCrary, Ruling Elder, Village Chapel, Charleston; Larry Napier, Ruling Elder, Edgewood, Lewisburg as Temporary Clerks.

He appointed the Leadership Team members present as the Committee on Bills and Overtures.

ANNOUNCEMENTS

The Moderator recognized Nellie Howard, Director of the Resource Center. She highlighted new resources in the Center. The Moderator recognized Mark Miller who highlighted the events to be held soon at Bluestone Camp and Retreat.

EDUCATIONAL FOCUS

The Moderator called on Leadership Team Chair, Randy Fife, who shared that the Leadership Team recently studied the book, <u>UnChristian</u>, which led to a discussion about young adults in the church. Mr. Fife introduced Blake Collins of the Young Adult Volunteer Program Presbyterian Church (USA) who presented information on the program using the framework of *Where is the Program Going? How do We Shape It? and How Can We Partner?* Mr. Collins shared that the paradigm of Believe, Belong and Behave has been changed to Behave, Belong, and Believe – how do we engage young adults through this new paradigm? He encouraged the membership to

go home and ask, "How are we engaging young people in the church?"

MORNING WORSHIP

Morning worship was led by the Administrative Commission to install Edward J. Thompson: Peter Vial, Amy Parker, Cinda Harkless, George Lilley, Cyndi Taylor, and Jim Musgrave. The pianist was Amy Sinclair. Ed Thompson preached the sermon; communion celebrants were Ed Thompson and Maureen Wright. Rev. Dr. Thompson was duly installed as the General Presbyter for the Presbytery of WV.

PRAYER AND HYMN

Following lunch, the Moderator recognized Kari Preslar and Todd Wright who led the Presbytery in a service of remembrance of elders deceased between January 1 and December 31, 2015. (Necrology, Appendix C, pages 23-24.)

Stated Clerk Wright presented the Stated Clerk's report.

PROCEDURAL MATTERS

Stated Clerk Wright presented Procedural Matters and moved the adoption of Item C3, limiting debate to 30 minutes per main motion, with each individual limited to 3 minutes per speech. After receiving a second, Presbytery **adopted** the motion by a two-thirds vote. (Appendix D, page 25.)

BLUESTONE COMMITTEE

Moderator Vial recognized John McKinnon, Chair of the Bluestone Committee who presented the committee's report.

RECOMMENDATIONS:

- 1. **(CA)**The committee recommends the Presbytery approve the Lord's Supper being celebrated at the Spring Getaway worship April 30th, Rev. John C. McKinnon presiding minister.
- 2. The committee recommends the Presbytery approve the Lord's Supper being celebrated at the Guys' Weekend worship April 24th, Rev. Rob Laukoter presiding minister. This was **approved.**

INFORMATION:

- 1. The Bluestone Committee has met four times since our last report; September 8th and October 29th of 2015, and January 5th and February 2nd of 2016.
- 2. The committee has spent time preparing for upcoming events including the Spring Getaway, the Guy's Weekend, and summer camp. Additionally, they have reviewed and edited the Bluestone Committee description in the PWV Manual to bring it more in line with current procedures. A recommendation of revisions has been forwarded to the Leadership Team for consideration.
- 3. The committee reviewed and adopted the 2016 Bluestone budget and was delighted to have five additional members join us in January.
- 4. Last fall Bluestone hosted the Elementary School Retreat, the Fall Getaway, and the Older Youth Retreat. In addition to these presbytery groups, the camp hosted other church groups, an Alcoholics Anonymous retreat (for the 49th consecutive year!), and a reunion.
- 5. Remodeling of cabins 8, 9, and 10 continues.
- 6. The Bluestone Conference Center Inc. Board of Directors met on September 21, 2015 for its annual meeting and on December 1, 2015. The board revised the corporate by-laws and adopted the revised by-laws. The revisions bring the language of the by-laws in line with current terms and structures defined by the PWV Manual.
- 7. The Friends of Bluestone (FOB) is a West Virginia non-profit corporation organized solely to support the ministries of Bluestone Camp & Retreat and is in a covenant relationship with the Presbytery of West Virginia. FOB raised \$42,603 in 2015. Thank you for your support! FOB's next event will be the 5th Annual Bluestone Benefit Golf

Tournament on May 14th at 1:00. The tournament will be at the Scarlet Oaks Course in Poca, WV.

NURTURE COMMITTEE

The Moderator recognized Kari Preslar, Chair of the Nurture Committee. She highlighted events which are forthcoming.

INFORMATION:

- 1. The committee is planning several opportunities for the presbytery including a Leadership Development program and a Child Protection Policy workshop.
- 2. The committee will host a Youth Day of Service early in 2017.
- Presbytery is invited to use the resource Nurturing Faith Ideas sent to pastoral leaders and Clerks of Session in December 2015; the resource is also available online.
- 4. Four outstanding Riner Loans have been paid. The committee continues its work in collecting other outstanding Riner Loans.
- 5. Plans are underway to take high school youth to Triennium this summer. The bus has been secured. Registrations are being taken.
- Plans for the Younger Youth Retreat in March, and the Older Youth Retreat in November were discussed.
- 7. The committee planned worship for today's meeting.

MISSION COMMITTEE

Moderator Vial recognized Robin Blakeman of the Mission Committee. She highlighted events forthcoming.

A representative of Try This WV: Healthy Bodies, Healthy Spirits, Healthy Faith (www.wvhealthyfaith.com) spoke about the program and encouraged participation.

RECOMMENATION:

1. (CA) Recommend the offering of the February 20, 2016 meeting be designated for the Presbyterian Church (USA)'s Young Adult Volunteer Program.

INFORMATION:

- 1. It was decided to divide grants in to three categories.
 - a. Institutional Partnerships: Report back yearly... Do not have to apply every year.
 - b. Mission Partnerships: Report back yearly... Do not have to apply every year.
 - c. Mission Grants: Apply every year, limited to 3 years.

- 2. Review of language, requirements and timing of application process was assigned to a "Grant Review Sub-committee". Doug Jenkins will convene, Barbara Chalfant, Melody Simpson are other members. Details will be reported at the next Presbytery Meeting.
- 3. Greg Kupar agreed to contact Davis and Elkins College to apply for \$1,200 grant gathered from other budgets areas for 2016.
- 4. The committee is planning a presbytery wide event in late August or September, a work experience in Mingo County with West Virginia Ministry of Advocacy and Workcamps (WVMAW). This would be for adults. Robin Ray, Joan Stewart, Greg Kupar and Barbara Accord are to work together on this project. Robin Ray will be the contact for this, rather than Greg Kupar as listed on the flyer.

STEWARDSHIP COMMITTEE

The Moderator recognized Treasurer, Rockland Poole, who reviewed the Presbytery's Financial Reports for 2015 and 2016. (Appendix E, pages 26-44.)

Moderator Vial led the Presbytery in sharing good things happening in local congregations.

ADMINISTRATION COMMITTEE - PART II

The Moderator recognized Sharon Rowe, Chair of the Administration Committee. She introduced Mark Parsons-Justice as the new Office Administrator/Communications. Mr. Parsons-Justice received a warm welcome from the Presbytery.

MINISTRY COMMITTEE

The Moderator recognized Cinda Harkless, Chair of the Committee. The committee recommends approval of the request from Barbara Romfo, Teaching Elder, Member at Large, to be released from the exercise of ordered ministry as a Teaching Elder in the Presbyterian Church (USA). (See *Book of Order G-2.0507*.) The motion was **approved.** Rev. Harkless introduced Barbara Romfo who was thanked for her service to the Presbytery and given well wishes on her journey.

Rev. Harkless called on Larryetta Ellis who spoke about "being church" and the Small Church Conference to be held April 30th. She encouraged attendance at the Conference.

RECOMMENDATIONS:

1. **(CA)** Recommend approval of **Rev. Todd Wright** as Moderator for the **Bream Memorial Church**, Charleston, beginning February 1, 2016.

- 2. (CA) Recommend approval of the Stated Supply covenant between Rev. Robert "Bob" Wood and the Fayetteville Church and, Teaching Elder, as Stated Supply Pastor, from March 1, 2016- December 31, 2016. Terms: 30 hours per week; cash salary \$2,780 per month, of this amount \$780 is designated as housing allowance; utilities up to \$200 per month; auto expense reimbursement at IRS rate up to \$1,800 per year; Board of Pensions (pension and medical); vacation 3 ½ weeks (including Sundays) and continuing education 1 ½ weeks (including Sundays) for 10 month covenant. Duties: weekly worship, Maundy Thursday and Christmas Eve and other special services; oversee staff; program and committee oversight; visitation; regular office hours; officer training at least annually; conduct confirmation as needed; visit shut ins including serving of communion; mission activities; occasional Bible Study; children's sermons. The Session will maintain its individual and corporate duties in the government and discipline of the congregation and oversight of the church's spiritual interests.
- 3. **CA**) Recommend approval of the terms of call: **Rev. Kyle Key** and the **Teays Valley Church.** Terms: cash salary: \$31,666; housing allowance: \$18,000; utility reimbursement: \$3,200; SECA \$4,377.30; auto expense reimbursement at IRS rate up to \$1,000 per year; continuing education: \$1,000 per year; Board of Pensions; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays).
- 4. (CA) Recommend approval of the renewal of the covenant as Stated Supply Pastor for Michael H. Anderson and St. Marys Presbyterian Church through December 31, 2016. Terms: 26 hours/week; \$1,500 per month; housing: \$ 750 per month; auto expense reimbursement at current IRS rate, up to \$500; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays), \$500; pension, family medical, supplemental life insurance for pastor and spouse and dental coverage for pastor and spouse as per Benefits Plan of the PCUSA, estimated cost \$14,781/year. Responsibilities: Sunday worship at 10:45 a.m.; visit members in hospital and shut-in; funerals and marriages as schedule allows; Session Moderator and resource; assist and/or conduct services/studies approved by Session; participate in ministerial alliance; assist with musical programs, all as schedule permits. The Session will maintain its individual and corporate duties in the government and discipline of the congregation and oversight of the church's spiritual interests.
- 5. (CA) Recommend approval the renewal of the covenant as Stated Supply Pastor for Benny Eugene Gurley and McLean Presbyterian Church through December 31, 2016. Terms: 9 ½ hours/week; \$937.50 per month; housing: 40% of this monthly salary designated as housing allowance; auto expense reimbursement at \$0.56/mile; McLean to pay ½ Social Security (FICA); vacation 1 week per quarter (including Sunday); continuing education 2 weeks per year (including Sundays), McLean to pay ½, \$500. Responsibilities: Conduct worship at 9:45 a.m. on Sunday, except 5th Sundays; moderate Session and congregational meetings, attend Presbytery. Assist the Session with Bible study/prayer meeting; pastoral care by home and hospital visits in local hospitals (critical care visits in regional hospitals at discretion of pastor); funerals, weddings. Special services: Easter at McLean and Salem; Christmas Candlelight service at Salem, Christmas Eve at McLean; VCS at McLean (pastor's discretion); monthly covered dish

dinner at McLean (pastor's discretion); homecoming alternating between the two churches; Christmas covered dinner for both churches; "Souper" Bowl offering for Ronceverte Food Pantry; provide Elder training as needed; be involved in communities, visit prospective members after two Elders have visited. The Session will maintain its individual and corporate duties in the government and discipline of the congregation and oversight of the church's spiritual interests.

- 6. **(CA)** Recommend approval of the renewal of the covenant as Stated Supply Pastor for Regel Lanphier Howe Jr and Alderson Presbyterian Church through December 31, 2016. Terms: 20 hours/week; \$1,500 per month as contract worker with no benefits or funds withheld; housing: \$600 of this salary is designated as housing allowance; auto expense reimbursement at IRS rate; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays); \$2,000 toward federal and state taxes. Responsibilities: Conduct worship, special services throughout the year including baptisms, funerals and weddings as required; visit in homes regularly and conduct emergency visitations; moderate Session and work with committees; be present and active in community including the Alderson Ministerial Association; attend presbytery meetings. The Session will maintain its individual and corporate duties in the government and discipline of the congregation and oversight of the church's spiritual interests.
- 7. **(CA)** Recommend approval of the renewal of the covenant as Stated Supply Pastor for **Charles Ferguson and Clothier Presbyterian Church** through December 31, 2016. Terms: 12-15 hours/week; \$800 per month; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays). Responsibilities: conduct Sunday worship; communion; visitation in homes, nursing homes and hospital; weddings, funerals and baptisms as requested. The Session will maintain its individual and corporate duties in the government and discipline of the congregation and oversight of the church's spiritual interests.
- 8. **(CA)** Recommend approval of the renewal of the covenant as Stated Supply Pastor for **Danny Franke and Philippi Presbyterian Church** through December 31, 2016. Terms: 5 hours/week; \$125 per Sunday; auto expense reimbursement at IRS rate; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays. Responsibilities: Conduct worship at 11 am on Sunday or at other mutually agreed upon time; special services if needed; pastoral duties as determined by pastor and Session. The Session will maintain its individual and corporate duties in the government and discipline of the congregation and oversight of the church's spiritual interests.
- 9. **(CA)** Recommend approval of the renewal of the covenant as Temporary Supply Pastor for **Rev.**
 - **Boyd Purcell** and the **Grace Covenant Church, Charleston** through December 31, 2016. Terms: 10 hours per week; salary: \$125 per week; \$50 travel allowance per month; vacation and continuing education: as many Sundays as requested. Responsibilities: Sunday worship; three special services Christmas Eve, Ash Wednesday, Maundy Thursday; provide emergency pastoral care and visitation. The

Session will maintain its individual and corporate duties in the government and discipline of the congregation and oversight of the church's spiritual interests.

- 10. (CA) Recommend approval renewal of the covenant as Ruling Elder commissioned to a Particular Pastoral Service for William F. Brown and Ruffner Memorial Presbyterian Church through December 31, 2016. Terms: \$15,833 per year pro-rated in 24 payments; housing: use of manse; \$500 manse equity allowance; utilities \$1600; SECA offset: \$1940; auto expense reimbursement at IRS rate; Medical dues: \$11,306.28; Pension dues: \$3,164.28; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays), \$1000. Responsibilities: Sunday worship with monthly communion. Attend presbytery meetings. Provide supervision of staff, per agreement with Senior Services Employment Program. Within the Session Committee structure assist with programs and activities will increase the church's witness to the surrounding community and thereby encourage disciples of all ages to be part of the church. Administer the Lord's Supper; administer the Sacrament of Baptism; moderate the Session of the congregation to which he is commissioned; officiate at marriages where permitted by state law; have a voice and vote in meetings of the presbytery (counted as an elder commissioner for purposes of parity). Mentor: David Lee.
- 11. (CA) Recommend approval of the renewal of the covenant as Ruling Elder commissioned to a Particular Pastoral Service for Preston "Pat" Collier and First Presbyterian Church, Kenova, through December 31, 2016. Terms: 15 hours/week, including Sunday mornings and special services; \$1200 per month; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays); reimbursement of other expenses as needed. Responsibilities: Sunday worship and special services, co-lead Bible study, visit sick and shut-ins. Attend presbytery meetings; remain under care of presbytery. Administer the Lord's Supper; administer the Sacrament of Baptism; moderate the Session of the congregation to which he is commissioned; officiate at marriages where permitted by state law; have a voice and vote in meetings of the presbytery (counted as an elder commissioner for purposes of parity). Mentor: Jean Sutton.

The Moderator announced that he has appointed Larryetta Ellis as Acting Chair of the Mission Committee. The current chair, Greg Kupar, has accepted a call in Kentucky. He was thanked for his service.

LEADERSHIP TEAM

Moderator Vial recognized Randy Fife, Chair of the Leadership team.

Mr. Fife explained the role of the Leadership Team and the Overture Task Force. He then called on the Stated Clerk who explained the process of submitting overtures to the General Assembly. He then called on Barbara Accord, Chair of the Overture Task Force, to present the recommendations of the Overture Task Force.

LEADERSHIP TEAM: OVERTURE TASK FORCE REPORT AND RECOMMENDATIONS:

1. Request from Mavis Grant Lilley to concur with General Assembly Overture 38 "On Supporting the Report of the Office of the United Nations High Commissioner for Human Rights Regarding Protecting Individuals from Violence and Discrimination—From the Synod of the Covenant" (Appendix G, pages 48-52.)

The Overture Task Force recommends that the Presbytery take no action to concur with Overture 38.

Rationale

General Assembly Overture 38 has concurrence from the Presbyteries of Detroit and Southern Illinois. The purpose of the concurrence is to assure that the General Assembly will consider an issue. The Leadership Team concurs with the Overture Task Force to take no action to concur with Overture 38.

The motion was **approved**.

2. Request from the Session of First Presbyterian Church, Morgantown, to concur with General Assembly Overture 28 "On Celebrating the Completion of the Six-Year Discernment on Peacemaking—From the Presbytery of Mission" (Appendix G, pages 48-52.)

The Overture Task Force recommends that the Presbytery take no action to concur with Overture 28.

Rationale

General Assembly Overture 28 has concurrence from the Presbyteries of Hudson River and Southeastern Illinois. The purpose of the concurrence is to assure that the General Assembly will consider an issue. With the two concurrences, the Overture will be added to the business of a General Assembly committee. The concurrence of the Presbytery of West Virginia is not necessary.

The Leadership Team concurs with the Overture Task Force to take no action to concur with Overture 28.

The motion was approved.

3. Request from the Session of First Presbyterian Church, Morgantown, to concur with General Assembly Overture 30 "On Choosing to be a Church Committed to the Gospel of Matthew 25—From the Presbytery of the Cascades" (Appendix G, pages 48-52.)

The Overture Task Force recommends that the Presbytery take no action to concur with Overture 30.

Rationale

General Assembly Overture 30 has concurrence from the Presbyteries of Hudson River and Sheppards and Lapsley. The purpose of the concurrence is to assure that the General Assembly will consider an issue. With the two concurrences, the Overture will be added to the business of a General Assembly committee. The concurrence of the Presbytery of West Virginia is not necessary.

The Leadership Team concurs with the Overture Task Force to take no action to concur with Overture 30.

The motion was approved.

INFORMATION:

The Leadership Team met for its annual retreat in Charleston on January 15th and 16th. The Team discussed the book "UnChristian," by David Kinnaman and Gabe Lyons, subtitled "What a new generation thinks about Christianity." The Team discussed the authors' statistical

research, which led them to conclude, in part, that "millions of young (people) are mentally and emotionally disengaging from Christianity," and the book's suggestions of ways to reverse that trend. The discussion led the Team to, among other things, decide on this meeting's educational focus on the Young Adult Volunteer Program. The Team also undertook an "asset mapping" exercise, charting the many assets of the Presbytery of West Virginia, based on the book "The Power of Asset Mapping: How Your Congregation Can Action on its Gifts" by Luther K. Snow. Please take a look at our display of assets and add your ideas to the display.

As part of its business agenda, the Team:

- Appointed a group to review the budget process, educate the Presbytery and communicate its findings at the May meeting.
- Asked each committee, by March 1, to review its budget and educate the committee's members as to budget line items.
- Identified persons to attend the Davis & Elkins Symposium on Faith, Spirituality and Higher Education on March 14. The presbytery's delegation will be joined by General Presbyter Ed Thompson and Stated Clerk Maureen Wright.
- Heard a report of the Relations Committee's Prayer Vision Group on its work and its plans to hold meetings in the Clusters.
- Discussed a report from the Nurture and Ministry Committees on an event to help assist congregations in meeting the Book of Order requirement for Child Protection Policies.
- Planned to review the Presbytery's strategic plan at its next meeting.
- Set the dates for the team's meetings for 2016, maintaining its practice of meeting in the month before each Presbytery meeting, but adding meetings to focus on strategic planning.

GENERAL PRESBYTER

The Moderator recognized Ed Thompson, General Presbyter, who asked for prayers, patience and invitations to member churches. He expressed thanks to the General Presbyter Nominating Committee, the Administrative Commission and to the staff. He introduced staff members stating 'we are here to serve you'.

APPENDIX D – PROCEDURAL MATTERS

A. Principles of Parliamentary Law

- Courtesy to all

- Majority rule

- Justice for all

- One Item at a time

- Respect the rights of the minority

- Partiality for none

- Usually pro and con speakers will alternate and individual speaking will identify his or her position.
- No one is allowed to speak more than once on a pending question until all wishing to speak have been heard; a person can then speak a second time, but no more than twice (unless the body gives special permission by two-thirds vote for a third speech).

B. Relevant Provisions of Presbytery's Manual (Section III of Manual)

- 1. "No new business shall be introduced after Presbytery recesses for lunch (unless by two-thirds vote Presbytery sets a different deadline for introduction of new business), and any new business not listed on the docket shall be presented in written form."
- 2. "...each elder elected an officer, General Presbyter, or a member of Leadership Team shall be enrolled as a member of the Presbytery for the term of office, whether or not commissioned by his or her session."
- 3. "The privilege of the floor without vote shall be granted to lay members of Presbytery's committees and to laypersons serving on Presbytery's staff, if not enrolled as members of the Presbytery."
- 4. "The privilege of the floor without vote shall be granted to certified church educators serving the churches of Presbytery, if not enrolled as members of the Presbytery. Certified church educators who are ruling elders and serving churches of Presbytery shall have voice and vote privileges. (G-2.1103b)"

<u>N</u>OTE: The phrase, "privilege of the floor without vote," means that the person has the privilege of speaking on the floor of Presbytery, including debating a motion under consideration, subject to rules and guidelines that govern discussion and debate. However, the person does not have the privilege to make motions or to vote.

Those who have "privilege of the floor without vote" are lay members of committees, lay members of Presbytery staff, church educators, and youth advisory delegates. Those with "voice and vote" privileges are member Teaching Elders, Ruling Elder commissioners, Certified Christian Educators*, Commissioned Ruling Elders, General Presbyter, Stated Clerk, Recording Clerk, Treasurer, Moderator, Members of Leadership Team and Presbytery Committee chairs.

C. Procedural Rules for the meeting of Presbytery (approval by two-thirds vote required to adopt #3).

- 1. Persons wishing to speak to the Presbytery giving a report, debating a motion, raising questions will do so by using the microphones.
- 2. Each speaker, after recognition by the Moderator, will give his or her name and church name (or other relationship to the Presbytery if not pastor or elder commissioner from a session).
- 3. Limitation of Debate 30 minutes per main motion, with each individual limited to 3 minutes per speech.
- 4. A recommendation from a committee or other entity elected by the Presbytery, upon being presented to Presbytery by an elected member of that entity, is considered to be on the floor for Presbytery's debate, amendment, and disposition without the necessity of a motion placing the recommendation on the floor.

Kyle W. Key - Biographical Statement and Statement of Faith

Biographical Statement

I was blessed to grow up in a Christian family and accepted Jesus Christ as my Savior and Lord at an early age. My faith was nurtured in the First Presbyterian Church of South Charleston, where I grew up. God also brought many people into my life to mentor me and help me understand how to live the Christian life. A major turning point in my life came in the summer of my ninth grade year when many of my friends began to experiment with alcohol and other teenage rebellion. I knew I was a Christian and I didn't participate in their activities, but they were my friends. One night I prayed if God wanted me to stop hanging around with them when they were doing these activities, that He would bring some new friends into my life. That very next Sunday a girl in our church who was a couple of years older than I and who I hardly knew, invited me to a Bible Study. Wow, I thought, God works fast! Through this Bible Study and a whole new group of friends, I learned a great deal about the Christian faith and that it was much more than following a list of do's and don'ts. It was about a personal relationship with Jesus Christ and it could be a lot of fun!

I went to Marshall University where I began as an Accounting Major. God had other plans for me, however. While at Marshall, I got involved with Campus Crusade for Christ. Crusade had a big impact on my life. One, I met my bride- to- be, Chris, and two, after a long process of God pursuing me, I answered His call to go into the pastoral ministry during my sophomore year.

After graduation from Marshall, I attended Gordon-Conwell Seminary for two years and married Chris after her graduation from Marshall. She was a year behind me in school. I then did a fifteen month internship at Riverlawn Presbyterian Church in St. Albans, WV and transferred to Union Theological Seminary at the encouragement of my Presbytery. This internship under Dr. Bill Cain's mentorship greatly impacted me and furthered my understanding of God's call on my life.

After receiving my D.Min. from Union, we moved to Callaway, VA to begin our ministry at Piedmont Presbyterian Church. I have also served for over 7 years as pastor of St. Andrew Presbyterian Church in Elkview, WV, for 11 years at Roxborough Presbyterian Church in Philadelphia, and finally I was called to my latest position where I served for over 7 years as the Associate Pastor of Discipleship at First Presbyterian Church in Harrisonburg, VA. In each of these calls I sensed God's leading and grew in my understanding of ministry and trusting in God for His guidance and direction.

We have faced some personal tragedies along the way that have forced us to lean heavily upon God. These trials and tribulations have helped us to trust God in all situations and to lean not on our own understanding.

Chris and I have been blessed with three wonderful children: Sarah, whom I had the privilege to perform her wedding ceremony this past Oct. 10th, Joshua, and Jonathan. Rounding out the Key clan is a golden retriever yellow lab mix named, Abby, and two cats, Simba and Rascal.

I have recently sensed a strong call to return to my roots in WV as I begin a new chapter of service to my Lord and Savior Jesus Christ.

I love people and hearing their stories of how God is working in their lives. I welcome the opportunity to minister along side others and to watch God work in them and through them. I believe the Christian walk is a never-ending process of learning and growing in our understanding of an

infinite, triune God Who created us and allows us to call Him, Abba, Daddy.

Statement of Faith

I believe in a triune God who is Creator and Lord of all the universe. The Godhead exists in three separate beings, Father, Son and Holy Spirit. They are all eternal and "of one essence". God is all-knowing and all-powerful, and is perfect in all respects. He is intimately involved with His creation and all of history is being worked out according to His perfect will.

Jesus Christ is fully God and fully man. He was conceived by the Holy Spirit and born of the Virgin Mary. He lived a sinless life and died upon the cross for all sinners, as a substitutionary sacrifice; and all who believe in Him are cleansed and justified by His blood. After three days Jesus arose from the dead. He appeared to many people before He ascended into heaven. He is now sitting at the right hand (a place of authority) of God the Father Almighty, and is interceding to the Father on our behalf.

The Holy Spirit is the third person of the Godhead and has been sent to dwell within the believer to guide, instruct, comfort, empower and convict us of sin, righteousness and judgment. It is the Holy Spirit who leads us in sanctification, and it is the Holy Spirit who enables us to carry on the work which Jesus Christ began on earth.

I believe that both the Old and the New Testaments are without error in their original form, and that they were inspired by the Holy Spirit working through men and are a complete revelation of His will for the salvation of all people. "All Scripture is God-breathed and is useful for teaching, rebuking, correcting and training in righteousness, so that the man or woman of God may be thoroughly equipped for every good work" (2 Tim 3:16-17). As we strive to live and make decisions about life, we must be guided by the Holy Scriptures and the Confessional documents of our church.

Humankind was originally created in the image and likeness of God. We fell as a result of disobedience to God. Because of this sin we were separated both physically and spiritually from God. We are all born into sin, and can only be saved through the atoning work of Jesus Christ. Those who repent of their sins and accept the saving blood of Christ are "born again", or 'born from above". Those who are born again receive the gift of the Holy Spirit, eternal life and are adopted into the family of God. Those who do not repent or believe in Him do not receive the saving work of Jesus Christ, and will be judged guilty and sentenced to eternal separation from God-that is Hell.

It is God's desire that everyone be saved, filled with the Holy Spirit, separated from sin, and dedicated to His service. As we strive to do so, we will find the full and abundant life that He intended for us to have.

The Church is made up of believers and is under the authority of Jesus Christ. We have been commissioned by Him to go into all the world proclaiming the gospel and to continue the ministry that He began. In the local church believers are to join together to worship God, study His Word, pray, partake of the sacraments, be equipped for ministry, find support and encouragement through fellowship, and proclaim the Good News through word and deed.

The two sacraments that we celebrate are baptism and communion, both instituted by Christ himself. The Holy Spirit is mysteriously present in both sacraments to nurture God's people. Through baptism, we are reminded that our sins have been washed away through the work of Christ. We are initiated into the family of God. In baptism we are invited to live as children of God. Through communion, we share in the life, death, and resurrection of Jesus Christ. At the Passover meal, Jesus actually broke the bread and shared the cup and commanded that we "do this in remembrance of Him". When we participate in communion, we are strengthened and encouraged to live our daily lives knowing that this is but a glimpse of what lies ahead. These sacraments are visible signs of an invisible grace. The sacraments are a means of grace that draw us into a closer relationship with the Living Lord.

One day Jesus Christ will return to earth. This time He will come to gather His own to Himself, and will conquer evil once and for all. There will be a bodily resurrection of both the just and the unjust. The just will be eternally with God and the unjust will be eternally separated from Him.

APPENDIX G - OVERTURES

Overture 038

On Supporting the Report of the Office of the United Nations High Commissioner for Human Rights Regarding Protecting Individuals from Violence and Discrimination—From the Synod of the Covenant.

The Synod of the Covenant overtures the 222nd General Assembly (2016) of the Presbyterian Church (U.S.A.) to:

- Express its appreciation for the Report of the Office of the United Nations High Commissioner for Human Rights, "Discrimination and violence against individuals based on their sexual orientation and gender identity" (May 4, 2015), and commend this report to congregations and presbyteries for study and action.
 - Commit the Presbyterian Church (U.S.A.) to support the goals expressed in the Report:
 - To protect individuals from violence
 - B. To prevent torture and ill-treatment
 - C. To decriminalize homosexuality and to repeal other laws used to punish individuals on the basis of sexual orientation and gender identity
 - D. To protect individuals from discrimination on grounds of sexual orientation and gender identity
 - E. To protect rights to freedom of expression, association, and assembly and to take part in the conduct of public affairs
- Direct the Office of Public Witness to identify and encourage legislation to accomplish
 the above goals in the United States and U.S. territories, giving attention to the strategies
 enumerated in the report.
- Direct the Presbyterian Ministry at the United Nations to pursue ways to advocate for these goals within the United Nations system, giving attention to the strategies enumerated in the report.
- Communicate these goals to World Mission personnel, as well as other PCUSA-related organizations engaging in global mission activities.
- Direct the Presbyterian Mission Agency to consider context-sensitive ways to help mission co-workers address issues of safety and respect for LGBT persons.
- Direct the Stated Clerk to communicate this action to the Ecumenical Agencies to which the General Assembly belongs and our ecumenical partners, encouraging consideration and adoption of similar actions.
- Direct the Office of Immigration Issues to develop resources that are responsive to the particular needs of LGBT immigrants, and to provide support to congregations wishing to welcome LGBT persons seeking asylum.

Rationale

In 2011, the United Nations High Commissioner for Human Rights submitted a report to the U.N. Human Rights Council, describing a pattern of discrimination and violence against people in all regions on the basis of their sexual orientation and gender identity.

An updated report dated May 4, 2015 included approaches to overcoming violence and discrimination, applying existing international human rights law and standards. The full report is available at http://www.un.org/en/ga/search/view_doc.asp?symbol=A/HRC/29/23&referer=/english/&Lang=E.

The goals listed in the May 4, 2015 report are consistent with the PC(USA)'s longstanding commitment to civil rights for lesbian, gay, bisexual, and transgender persons. These goals should guide the PC(USA) in its ministries.

Specific strategies enumerated in the report are:

- A. To encourage all nations to address violence by:
- (a) Enacting hate crime laws that establish homophobia and transphobia as aggravating factors for purposes of sentencing;
- (b) Conducting prompt, thorough investigations of incidents of hatemotivated violence against and torture of LGBT persons, holding perpetrators to account, and providing redress to victims;
- (c) Collecting and publishing data on the number and types of incidents, while providing for the security of those reporting;
- (d) Prohibiting incitement of hatred and violence on the grounds of sexual orientation and gender identity, and holding to account those responsible for related hate speech;
- (e) Training law enforcement personnel and judges in gender-sensitive approaches to addressing violations related to sexual orientation and gender identity;
- (f) Ensuring that police and prison officers are trained to protect the safety of LGBT detainees, and holding to account State officials involved or complicit in incidents of violence;
- (g) Banning "conversion" therapy, involuntary treatment, forced sterilization and forced genital and anal examinations;
 - (h) Prohibiting medically unnecessary procedures on intersex children;
- (i) Ensuring that no one fleeing persecution on grounds of sexual orientation or gender identity is returned to a territory where his or her life or freedom would be threatened, that asylum laws and policies recognize that persecution on account of sexual orientation or gender identity may be a valid basis for an asylum claim; and eliminating intrusive, inappropriate questioning on asylum applicants' sexual histories, and sensitizing refugee and asylum personnel.
- G. To encourage all nations to address discrimination by:
- (a) Revising criminal laws to remove offenses relating to consensual samesex conduct and other offenses used to arrest and punish persons on the basis of their sexual orientation and gender identity or expression; ordering an immediate moratorium on related prosecution; and expunging the criminal records of individuals convicted of such offenses;
- (b) Repealing so-called "anti-propaganda" and other laws that impose discriminatory restrictions on freedom of expression, association and assembly;
- (c) Ensuring that anti-discrimination legislation includes sexual orientation and gender identity among prohibited grounds, and also protects intersex persons from discrimination;
- (d) Integrating analysis of violations based on sexual orientation and gender identity in national plans of action, thereby ensuring coordination and adequate resourcing of related activities, accountability for perpetrators, and redress for victims;

- (e) Sensitizing health-care workers to the health needs of LGBT and intersex persons, including in the areas of sexual and reproductive health and rights, suicide prevention, HIV/AIDS, and trauma counselling;
- (f) Establishing national standards on non-discrimination in education; developing anti-bullying programs and establishing helplines and other services to support LGBT and gender-non-conforming youth; and providing comprehensive, age-appropriate sexuality education;
- (g) Ensuring that housing policies do not discriminate against tenants based on sexual orientation and gender identity; and establishing shelters for homeless LGBT persons, with specific attention to youth, older persons and those in emergency situations;
- (h) Providing legal recognition to same-sex couples and their children, ensuring that benefits traditionally accorded married partners including those related to benefits, pensions, and taxation and inheritance are accorded on a non-discriminatory basis;
- (i) Issuing legal identity documents, upon request, that reflect preferred gender, eliminating abusive preconditions, such as sterilization, forced treatment and divorce;
- (j) Supporting public education campaigns to counter homophobic and transphobic attitudes, and addressing negative, stereotypical portrayals of LGBT persons in the media;
- (k) Ensuring that LGBT and intersex persons and organizations are consulted with regard to legislation and policies that have an impact on their rights.

Presbyterians are not of one mind about the teaching of Scripture concerning same-sex relationships, but all can agree that every human being should be afforded respect, dignity, and safety.

Overture 028

On Celebrating the Completion of the Six-Year Discernment on Peacemaking—From the Presbytery of Mission.

At its Stated Meeting on October 24, 2015, at Presbyterian Pan American School in Kingsville, Texas, Mission Presbytery approved the following overture to be sent to the 222nd General Assembly (2016) for its consideration and approval:

"The Presbytery of Mission overtures the 222nd General Assembly (2016) of the Presbyterian Church (U.S.A.) to:

- 1. Celebrate with gratitude and joy the completion of the six-year discernment process initiated by the 219th General Assembly in 2010 to 'seek clarity as to God's call to the church to embrace nonviolence as its fundamental response to the challenges of violence, terror, and war' and to 'identify, explore, and nurture new approaches to active peacemaking and nonviolence;
- 2. Call upon Presbyterians at all levels of the church to employ the understandings and insights gained by this process to meet the challenge of the 219th General Assembly to respond to and prevent violence on the local level, the national level, and the international level through prayer, direct action, and

advocacy; and to address sexism, racism and other patterns of oppression as tasks of peacemaking and justice seeking;

3. Recognizing that discerning God's will is an ongoing task, commit to continue to seek clarity as to God's call to the church to embrace nonviolence as its fundamental response to the challenges of violence, terror, and war; and to continue to explore and nurture new approaches to active peacemaking and nonviolence as the peacemaking witness and ministry of the church grows.

Rationale

In response to several overtures on peacemaking, the 219th General Assembly (2010) initiated a six-year process of church-wide discernment on peacemaking. Congregations, presbyteries, seminaries, colleges, and conferences have participated and responded. His overture asks the 222nd General Assembly to continue the process of discernment and innovation as an ongoing and essential part of peacemaking programs at all levels of the church.

Overture 030

"On Choosing to be a Church Committed to the Gospel of Matthew 25—From the Presbytery of the Cascades.

The Presbytery of the Cascades overtures the 222nd General Assembly (2016) of the PC (USA) to:

Recommit ourselves at the congregational, the mid-council governing bodies, and the national levels of our church to locate ourselves with the poor, to advocate with all of our voice for the poor, and to seek opportunities to take risks for and with the poor (in the soup kitchens and catholic worker houses, among the immigrants, with those working to end mass incarceration, and with those who seek to protect all of us, especially the poorest of the poor around the world, from the vagaries of climate change).

Call on our churches to commit to a year of bible study focused on issues of social justice.

Call on our Presbyteries and Synods to examine their own practice, placing these commitments at the center of their concerns, and to streamline the way that issues of immediate significance can be forwarded to the General Assembly by adopting procedures so that overtures and proposals on peacemaking and social justice concerns from sessions and committees may be considered quickly.

Facilitate the processes by which these concerns can be brought before us as a national body by resisting new barriers to overture submissions such as additional concurrences, tighter deadlines, or new overture topic restrictions at any General Assembly.

Commit to focusing a significant block of the time allotted for future General Assemblies on creating opportunities in consultation with the Committees on Local Arrangements to engage all of the commissioners, delegates, and observers in acts of service to and with communities at risk.

Assure that there are voices of those who are most at risk from within our church and outside of it (including interfaith voices), who are invited to share with and challenge the assembly, both in the plenary and committee sessions.

Create a "cycle of social engagement" that will assure that concerns around confronting racism, environmental concerns, standing against violence and militarism, and advocating for the dispossessed come before the Assembly on a regular and consistent basis, soliciting overtures from presbyteries before each General Assembly on topics of the most immediate concern.

Rationale

This is a moment of great opportunity for our church. Momentum is building within our denomination and throughout our society to courageously confront the challenges of our time. A new Civil Rights movement, a new Peace movement, a new Economic Justice movement is on the rise and we are in a position to stand in solidarity with the poor in a uniquely powerful way. It is a time for us to define who we will be for decades to come. May we choose to be a church committed to the gospel of Matthew 25:

In the Parable of the Ten Bridesmaids Jesus tells a story about the church waiting for the moment of the Lord's arrival. Some of those who are waiting are prepared when the time comes, and some are not. The zeitgeist of our age is one of rapidly changing and endlessly creative activism exemplified by the Black Lives Matter movement. Let us be like the bridesmaids whose lamps are trimmed - ready to seize the moment.

In the Parable of the Talents Jesus tells a story about a bold slave who was punished for refusing to participate in the empire value of domination. Increasingly we see brave individuals and groups calling out the powerful and standing against the rampant exploitation in our marketplaces, in our prisons, and on our streets. Let us resist evil like that slave, and go stand on the margins of society - in the outer darkness.

In the Parable of the Judgment of the Nations Jesus tells a story about how he is encountered among "the least" - the poorest, the most isolated, the imprisoned, the sick, and the hungry. We hear with sober conviction Jesus declaring that a church which fails to serve with and for the poor does not know Him. We agree with Pope Francis who stated that a church that is not actively supporting and serving the needs of the poor has no right to call itself church at all and should be prepared to give up its tax-exempt status to operate as a church. Let us be counted among the sheep who met their King as a stranger.

We see the Spirit blowing through our society, bringing to fruition seeds of peace and justice long dormant. The harvest will be plentiful. Let us heed the call to service, and recommit ourselves to the proclamation of the gospel of Jesus Christ in deeds as well as in words.
