ONE HUNDRED THIRTY SECOND STATED MEETING

CALL TO ORDER

The meeting was called to order with prayer at 10:03 a.m. by Moderator Peter Vial.

ELECTION OF STATED CLERK PRO TEM

The Moderator recognized Randy Fife, Chair of Leadership Team, who moved that Ed Thompson serve as Stated Clerk Pro Tem for the meeting. The motion was seconded and approved after determining there were no nominations from the floor.

GREETINGS

Mark Miller, Director of Bluestone Camp and Retreat, greeted and extended a warm welcome. He recognized men who recently attended the Guys Weekend and all persons who ever volunteered at Bluestone.

INTRODUCTIONS

The Moderator called on the Stated Clerk Pro Tem who welcomed New Teaching Elders Rebecca Mihm, Fleming Memorial and Rachel Shepherd, Marlinton and asked them to sign the Book of Obligations. He made a motion to seat Rebecca Davis, a member of the Charlotte Presbytery, as a Corresponding Member for the duration of the meeting. The motion was seconded and adopted.

Ruling Elders attending Presbytery for the first time were recognized.

STATEMENT OF QUORUM

Stated Clerk Pro Tem Thompson stated there was a quorum present of 49 teaching elders and commissioners from 39 churches. (Attendance record in Appendix A, pages 73-79.)

He appointed the Leadership Team members present as the Committee on Bills and Overtures.

ANNOUNCEMENTS

The Moderator recognized Nellie Howard, Director of the Resource Center who highlighted the new resources in the Center. The Moderator recognized Robin Ray of the Mission Committee who highlighted the WVMAW mission trip in August. Susan Sharp Campbell reported for the Nurture Committee. She highlighted the NONES Workshop in November and the Child Protection Policy Workshop in September.

DOCKET

Stated Clerk Pro Tem Thompson presented the docket and moved its adoption. After receiving a second, Presbytery adopted the docket. (Appendix B, pages 80-81.)

EDUCATION PRESENTATION

The Moderator called on Susan Sharp Campbell who introduced Dr. Rebecca Davis, Professor f

Religion at Presbyterian College. She presented a program *Protecting Our Children*. She highlighted the incidence of child abuse, as well as the devastation of false accusations. She stressed that parents trust the church to do due diligence in caring for their children and that the church has taken vows to be responsible for all children. All Presbyterian Church (U.S.A.) congregations are required to have a Child Protection Policy and to follow it. By doing so, we are saying we love all children.

MORNING WORSHIP

Morning worship was led by Mike Burton, Liturgist; Andy Rice, Preacher; Joan Stewart and Chris Kilbert, Communion Celebrants; and Mark Parsons-Justice, Pianist.

PRAYER AND HYMN

Following a lunch break, the Moderator reconvened Presbytery with the announcement that \$857.56 was collected for WVMAW. Todd Wright led the Presbytery in prayers, followed by a hymn.

STATED CLERK

Stated Clerk Pro Tem Thompson presented the Stated Clerk's report.

PROCEDURAL MATTERS

Stated Clerk Pro Tem presented Procedural Matters and moved the adoption of Item C3, limiting debate to 30 minutes per main motion, with each individual limited to 3 minutes per speech. The motion received a second. (Appendix C, page 82.)

John Minihan made a motion to amend the original motion with no limitation of debate for each main motion, with each individual limited to 10 minutes per speech. The amendment was defeated.

John Minihan made a motion to amend the original motion with limitation of debate at 45 minutes per main motion, with each individual limited to 10 minutes per speech. The amendment was defeated.

John Minihan made a motion to amend the original motion with limitation of debate at 30 minutes per main motion, with each individual limited to 10 minutes per speech. The amendment was adopted by a two-thirds vote.

GENERAL PRESBYTER

The Moderator recognized General Presbyter, Ed Thompson. He commented on his recent activities. Dr. Thompson lifted up and asked for prayers for the 222^{nd} General Assembly to be held in June in Portland, OR and for the Presbytery's commissioners. The work of presbytery staff was highlighted. He also provided some explanation about the role of Administrative Commissions in light of the Ministry Committee's recommendation to establish an Administrative Commission at First Presbyterian Church, Huntington.

MINISTRY COMMITTEE

The Moderator recognized Cinda Harkless, Chair of Ministry Committee. She thanked all the persons who worked on the Small Church Conference and the Fayetteville Church for hosting

the conference. Rev. Harkless also thanked Shelly Barrick Parsons and the Task Force that provided the New Pastors Orientation at Festival of Faith.

Cinda Harkless recused herself from presenting and participating in the debate of the recommendation regarding First Presbyterian Church, Huntington due to a conflict of interest.

Susan Perry, committee member, made the following motion.

That the Presbytery of West Virginia appoint an Administrative Commission.

- a. The purpose of the Administrative Commission shall be to act on behalf of the presbytery on all matters regarding the First Presbyterian Church of Huntington (hereinafter referred to as First Huntington);
- b. The Administrative Commission shall be composed of both teaching elders and ruling elders from this Presbytery. Specifically, the teaching elders shall be Nancy Didway and John Holland and the ruling elders shall be Randy Fife, (Bream Memorial, Charleston) Barbara Hopta (First, Charleston), and Cherrie Sizemore (Village Chapel, Charleston)
- c. A quorum of the commission members will be a majority of the membership of the commission;
- d. The presbytery, by this action, shall delegate to the commission the following powers, to take effect upon the passage of this motion:
 - 1. Access to all church records, including but not limited to: membership rolls, minutes of Session and all boards and committees, financial records, membership directories, newsletters, and materials distributed for congregational information for First Huntington;
 - 2. Authority to call congregational meetings (G-1.0502) and to obtain current and accurate membership lists from the church for this purpose;
 - 3. Authority to engage appropriate legal counsel;
 - 4. Authority to develop and put into place ways to hear the joys and concerns of the membership of First Huntington in order to identify and clarify reported difficulties of First Huntington including, but not limited to, Listening Teams so that it might be better able to develop and suggest "appropriate actions to resolve the reported difficulties" (G-3.0303 d (1)) within the congregation;
 - 5. Authority to determine on behalf of the Presbytery, after a thorough investigation and after full opportunity to be heard has been accorded to the Session, if the Session is able to exercise its authority in the church (G-3.0303);
 - 6. If the commission determines, after investigation and opportunity to be heard, that the Session is unable to exercise its authority in the church (G-3.0303), the commission shall then have authority to assume the full powers and original jurisdiction of the Session. In the event that such a situation occurs, the commission shall be empowered to deal with any other matters that the Session would ordinarily be empowered to address;

7. To report its actions and findings to the Presbytery of West Virginia and the Leadership Team in addition to reporting to the session and congregation of Huntington as their work progresses.

Rationale: Since the fall of 2015, the Ministry Committee has received numerous reports from concerned members of the congregation and staff of the First Presbyterian Church of Huntington. The concerns were varied in nature, both in the matters that were addressed and in the manner in which they were received. Some of these concerns came from persons who felt excluded from the spiritual life of the church because their opinions differed from those of the head of staff.

These persons expressed feelings of being "talked about" by other members of the church. They also expressed concerns that statements made in confidence to pastoral staff persons had been shared with others. After discussing these matters, the Ministry Committee voted to ask the Session of First Huntington for permission to conduct a Listening Event. This event would have provided an opportunity for persons from First Huntington to speak directly with teams of ruling and teaching elders from other churches of the presbytery. This initial request was rejected, but the proposed Listening Team was invited to make a presentation to a meeting of the Session of First Huntington.

On January 10, 2016 the majority of the members of the proposed Listening Team appeared at the meeting of the Session of First Huntington. The request was again made to permit the proposed Listening Team to invite persons who wanted to share joys or concerns about First Huntington to meet with the proposed Listening Team, acting in pairs. The proposed Listening Team offered to share any findings that it might make with the Session of First Huntington and with the Ministry Committee.

While the Session members listened and engaged in dialogue with the proposed Listening Team, the Session ultimately voted to reject the request. The Session at some later date apparently voted to conduct their own version of Listening Teams and received training from Kanawha Pastoral Counseling Center on listening skills.

It is the understanding of the Ministry Committee that the listening opportunity was not announced from the pulpit and that no letter was sent to the members of First Huntington to advise them that such an opportunity was available to them. Instead, notice was only given in the church newsletter.

While this series of events has played out, congregation members and staff have continued to contact members of the Listening Team and the Ministry Committee to express their disappointment in being unable to fully share their concerns with persons who would be perceived as neutral parties. Some have expressed fear of retaliation if they participate in the Session-led Listening Team opportunity, and they have urged the Ministry Committee to act independently. The continuing concerns mirror the concerns received earlier.

It is acknowledged that this congregation is currently engaging in a period of study and discernment to determine whether they wish to remain within the Presbyterian Church (U.S.A.) denomination. However, this circumstance, while mentioned by several of the persons who have called, has had little bearing on the recommendation of the Ministry Committee. The primary

concern of the Ministry Committee remains the reported difficulties in the areas of spiritual nurture of all members, confidentiality and pastoral care as exercised by the staff, and the administrative functioning of the session.

The Ministry Committee seeks to fulfill the responsibility given to it by this presbytery "to serve as a pastor and counselor to the teaching elders and congregations of the presbytery" and "to facilitate the relations between the presbytery and its congregations." (G-3.0307)

Since it has heard troubling reports about events within the life of this congregation and is unable to independently speak to persons in this church, therefore, the Ministry Committee respectfully requests that the Presbytery of West Virginia appoint an Administrative Commission so that it can investigate and propose ways to resolve the reported difficulties in this congregation. It will report to each meeting of the Leadership Team and of the Presbytery of West Virginia and will present reports to the Session and congregation of Huntington First as their work progresses.

Ms. Perry explained the authority of the Presbytery regarding congregational discord and its duty to advise sessions. Commissioners spoke for and against the motion.

John Minihan and Jane Nicholas distributed information from First Presbyterian Church, Huntington. (Appendix D, pages 83-91.)

Jane Nicholas moved to amend the motion to Strike d 2, 3, 5, and 6. The motion was seconded.

Time was called. John Minihan moved to extend debate time an additional 30 minutes. The motion was seconded and defeated. John Minihan moved to extend debate time an additional 15 minutes. The motion was seconded and defeated.

The motion to amend the motion to Strike d 2, 3, 4, and 5 was voted on and defeated.

John Minihan moved to amend Item b. in order to allow individuals on the proposed Administrative Commission be named jointly by the Session of First Presbyterian Church, Huntington, and the Ministry Committee. The motion was seconded. Commissioners spoke for and against the motion. The motion was defeated.

The main motion to appoint an Administrative Commission as stated above was voted on; it was approved by vote of 55 to 26, with 1 abstention.

John Minihan moved to Stay Presbytery's enforcement of the Administrative Commission until appeal to and action by the Synod. The motion was seconded and defeated.

COMMISSION TO DISSOLVE THE BRUSH CREEK PRESBYTERIAN CHURCH

The Moderator recognized Doug Heidt, Chair of the Administrative Commission to Dissolve the Brush Creek Presbyterian Church. He introduced Ellen Dawson, member of the commission, who reported briefly on the history on the Church and introduced Delores Cook, the last remaining member.

The report of the Administrative Commission follows.

- 1. The Commission has worked with the Clerk of the Session, Delores Cook, transferring to the Presbytery all minutes and records of the Brush Creek Church, which will be forwarded to the Presbyterian Historical Society, and affirming that all members have transferred or will transfer their membership to another church, with the assistance of the Presbytery.
- 2. The Trustees of Presbytery are in the process of researching possibilities for the sale of the property including the church building, and will report to Presbytery when they have recommendations.
- 3. The Commission and the Trustees have consulted with the Clerk of the Session regarding the disposition of property, and report that as long as she can remember, the congregation has been active in its support of Davis Stuart (a Presbyterian residential treatment center for teens and their families since 1919, at Lewisburg, not long after the Brush Creek Church began). As the church declined in size, it had been their hope and desire that if the church ever had to sell its property that the proceeds would be given to Davis Stuart. The Commission concurs in this request by the Brush Creek Church, and recommends it to Presbytery. The Commission also reports some contents and equipment have been given to Davis Stuart, and that the steeple bell will be installed outside the new Dining Hall there as a gift from the church.
- 4. The Commission hereby asserts the claim of the Presbytery to any property of the church not known at this time or property which may come to the church as the beneficiary of a will or trust.
- 5. The Commission joins the request of the Clerk of the Session in her request that in place of a service in the church building, the life and ministry of the Brush Creek Presbyterian Church be celebrated during the May 19, 2016 meeting of Presbytery.
- 6. The Commission requests that the Presbytery express its thanks to and lift its prayers for Dolores Cook, a member of this body, the Clerk and last remaining member of the Brush Creek Church, who has been a member of that church all her life, who played the piano for worship since she was a little girl, and whose enthusiastic participation in the life of her congregation and the wider church has been an inspiring witness to the eternal Love of Jesus Christ.
- 7. The Commission requests that The Brush Creek Church be dissolved, as of this date, May 19, 2016. Thanks be to God.

The Presbytery adopted the report. A celebration of the life and work of the Brush Creek Church was led by Moderator Vial.

A motion was made, seconded and approved that the history of the church be entered as part of the record of the meeting. (Appendix E, pages 92-99.)

LEADERSHIP TEAM

The Moderator recognized Randy Fife, Chair of the Leadership Team. He highlighted work which is being done ecumenically in communities and within clusters and encouraged continuation of this type of relational work.

Mr. Fife introduced Mark Parsons-Justice who presented the Presbytery's new Communication Plan which was developed at the request of the Leadership Team. Entitled *Building Bridges*, it stresses a relational or two-way approach to communication. He explained the use of the presbytery's Twitter hashtag, #MyPWV, and other social media, a survey to be completed, web conferencing, video technology and other pieces that will be forthcoming. Mr. Parsons-Justice closed by sharing that Together Everyone Accomplishes More = TEAM.

Mr. Fife introduced Nancy Didway who provided an update on the Presbytery's Prayer Vision Initiative. She highlighted the SEEKING GOD'S VISION WORKSHOPS being held.

Items for the Presbytery's INFORMATION:

The Leadership Team met on March 9 and April 19. At both meetings, the Team discussed the Presbytery's progress on the Jeremiah 29:11 and Strategic Plans. At the April meeting, the Team invited committee chairs to participate in a discussion of the presbytery's progress in implementing these plans, and to provide input going forward. In addition, the Team took up the following items of business:

- The progress of the small group studying the budgeting process, and the Mission Committee's plan to present its process for receipt of grant requests at Presbytery. The Team also received information from committee chairs about each committee's review of its budget.
- The plans of the Leadership Development Coordinating Team (comprised of members of the Nurture and Ministry Committees and staffed by Susan Sharp Campbell) towards developing courses and topics pertinent to the Strategic Plan's goal of providing a program of leadership development for pastoral leaders including teaching elders, authorized lay pastors, commissioned ruling elders and certified Christian educators.
- The progress of the subgroup of the Leadership Team to draft language to amend the Presbytery Manual to provide a process for consideration of overtures and concurrence requests in the future, specifically noting that such language is expected to be presented at the August meeting of Presbytery for a first reading.
- Considered potential educational pieces for future meetings.
- Appointed a subgroup to determine locations for future Presbytery meetings.
- Heard a presentation and approved a plan by Mark Parsons-Justice for improving communications within our Presbytery.
- Reviewed an update of the Prayer Vision Initiative.

• Reviewed a draft docket for this meeting of Presbytery.

- 2. Spring Getaway: 30 people participated representing six churches. Program emphasis was on Appalachian Crafts and Music, led by Pastor John McKinnon and special presenter, Tish Westman of Beckley. Pastor Denny Dodson led Sunday morning worship, May 1.
- 3. The primary summer leadership and counseling staff have been hired. There is still need for kitchen and lifeguard support staff. Please refer any interested individuals to email the Bluestone Camp Director, Mark Miller at mark@bluestonecamp.com.
- 4. Summer Staff training will begin on June 3. The first camper session will begin on June

12 and run Sunday to Saturday for four weeks concurrently.

The Moderator recognized Treasurer, Rocky Poole, who presented the Presbytery's Financial Reports for the first quarter, which were positive. (Appendix G, pages 102-116.)

NEW BUSINESS

The Moderator recognized Larryetta Ellis, Chair of the Mission Committee, who reported that within the Funds of the Presbytery of West Virginia there were excess funds received and designated by presbytery for the R.H.I.N.O. mission trip to New Orleans and that there were deficit funds from other mission trips sponsored by the presbytery. She moved that the excess designated funds from the R.H.I.N.O. mission trip be used to cover the deficits from the Nicaragua and Restore/Shore mission trips and that the balance be made available for future mission trips. The motion was seconded and approved.

ADJOURNMENT

Presbytery was adjourned at 4:25 p.m. with a charge and benediction by the Moderator.

APPENDIX C – PROCEDURAL MATTERS

- A. Principles of Parliamentary Law
 - Courtesy to all

- One Item at a time

- Majority rule

- Respect the rights of the minority

- Justice for all

- Partiality for none
- Usually pro and con speakers will alternate and individual speaking will identify his or her position.
- No one is allowed to speak more than once on a pending question until all wishing to speak have been heard; a person can then speak a second time, but no more than twice (unless the body gives special permission by two-thirds vote for a third speech).
- B. Relevant Provisions of Presbytery's Manual (Section III of Manual)
 - 1. "No new business shall be introduced after Presbytery recesses for lunch (unless by twothirds vote Presbytery sets a different deadline for introduction of new business), and any new business not listed on the docket shall be presented in written form."
 - 2. "...each elder elected an officer, General Presbyter, or a member of Leadership Team shall be enrolled as a member of the Presbytery for the term of office, whether or not commissioned by his or her session."
 - 3. "The privilege of the floor without vote shall be granted to lay members of Presbytery's committees and to laypersons serving on Presbytery's staff, if not enrolled as members of the Presbytery."
 - 4. "The privilege of the floor without vote shall be granted to certified church educators serving the churches of Presbytery, if not enrolled as members of the Presbytery. Certified church educators who are ruling elders and serving churches of Presbytery shall have voice and vote privileges. (G-2.1103b)"

<u>NOTE</u>: The phrase, "privilege of the floor without vote," means that the person has the privilege of speaking on the floor of Presbytery, including debating a motion under consideration, subject to rules and guidelines that govern discussion and debate. However, the person does not have the privilege to make motions or to vote.

Those who have "privilege of the floor without vote" are lay members of committees, lay members of Presbytery staff, church educators, and youth advisory delegates. Those with "voice and vote" privileges are member Teaching Elders, Ruling Elder commissioners, Certified Christian Educators*, Commissioned Ruling Elders, General Presbyter, Stated Clerk, Recording Clerk, Treasurer, Moderator, Members of Leadership Team and Presbytery Committee chairs.

- C. Procedural Rules for the meeting of Presbytery (approval by two-thirds vote required to adopt #3).
 - 1. Persons wishing to speak to the Presbytery giving a report, debating a motion, raising questions will do so by using the microphones.
 - 2. Each speaker, after recognition by the Moderator, will give his or her name and church name (or other relationship to the Presbytery if not pastor or elder commissioner from a session).
 - 3. Limitation of Debate 30 minutes per main motion, with each individual limited to 3 minutes per speech.
 - 4. A recommendation from a committee or other entity elected by the Presbytery, upon being presented to Presbytery by an elected member of that entity, is considered to be on the floor for Presbytery's debate, amendment, and disposition without the necessity of a motion placing the recommendation on the floor.

APPENDIX D DOCUMENTS FROM FIRST PRESBYTERIAN CHURCH, HUNTINGTON

Timeline

Aug. — Presbytery begins receiving calls from concerned members of FPC.

Calls are referred to the Ministry Committee who name a Listening Team to receive calls. When concerned persons contact the Presbytery office, they are given the contact information for members of the Listening Team.

FPC Huntington is <u>not</u> made aware of phone calls from concerned members and is <u>not</u> aware that a Presbytery Listening Team has been created and assigned to receive calls. The Ministry Committee does not inform FPC until November 5.

The Book of Order states: "The Session is the council for the congregation." "The Session shall have responsibility for governing the congregation and guiding its witness to the sovereign activity of God in the world..." (G-3.0201)

- Nov. 4 -- A concerned member of FPC sends 4 page letter to Session outlining concerns, including the creation of a Task Force to study our relationship with the denomination. This same letter is mailed anonymously to every member of FPC encouraging people to contact Rev. Frank Mansell and Pam Ferrell of the Presbytery and includes *specific* contact information for each. This is <u>before</u> any information is communicated to FPC by the Presbytery.
- Nov. 5 Dr. Minihan and Dr. Kent, the Pastor and Clerk of FPC, meet with Rev. Jim Robinson and Randy Fife and, are informed for the first time that the Ministry Committee has been receiving calls since August. It is stated that a total of 10-12 calls have been received. Dr. Minihan asks about the nature of alleged complaints. None are given except the allegation that at Congregational Meetings the floor is never opened to nominations for church officers. Dr. Minihan immediately forwards PDF copies of the congregational minutes to Rev. Jim Robinson demonstrating otherwise.

Randy Fife proposes Listening Teams from the Ministry Committee be established at FPC. Dr. Minihan invites the Listening Team to visit with the Session as this is the first the church has heard about any concerns.

Nov. 12 -- Email correspondence from Rev. Jim Robinson is received accepting a meeting with the Session. In the correspondence the Session is complimented regarding its establishment and handling of a Task Force to study denominational concerns and affiliation. "Your Task Force process of education and discernment seems to be really solid, and we feel encouraged about what we have seen and heard about it."

- Nov. 17 -- At a special Session before worship (for the purpose of receiving new members) the FPC Session votes to invite the Ministry Committee Listening Team to the January stated meeting.
- Nov. 18 -- Letter from Ministry Committee Vice-Chair, Susan Perry, reiterating information shared by Rev. Jim Robinson and Randy Fife and detailing a plan <u>already in place</u> from the Ministry Committee to act (prior to any dialogue with the Session). The Letter (in part) reads:

An appropriate time and place <u>will</u> be established for listening sessions to take place. The Listening Team <u>will</u> compile a report of what they have heard and <u>will</u> present that to the Ministry Committee with recommendations, and also share the report with the FPC Session. The Ministry Committee <u>will</u> hear that report and then decide any action to take. Any action will be fully communicated to the leadership at FPC..." (emphasis mine)

Please note this is all prior to any dialogue with the FPC Session and that the planned Listening Teams are identical to the ones now being proposed under the authority of an Administrative Commission, with additional powers, including being able to assume Original Jurisdiction.

- Dec. 3 -- Presbytery Packet mailed to all churches in the Presbytery includes information about reported difficulties at FPC (again, prior to any dialogue with the Session).
- Dec. 8 -- Letter from FPC Session is sent to Susan Perry asking for specifics of what will be discussed and the nature of the communications received from concerned members by the Ministry Committee.
- Dec. 16 -- A follow-up email / 2nd request is sent to Susan Perry again asking for specifics so there can be genuine dialogue with the Session.
- Jan. 4 -- Letter received from Susan Perry outlining topics to be discussed (almost a month after the initial request). This correspondence is received only a few days before the meeting with Session. It is also noteworthy that the very first item listed in the items to be discussed is the creation of a Task Force at FPC to study the church's relationship with the denomination. FPC had been previously assured that the existence of the Task Force was not major concern.

It is also noteworthy that the items of concern listed in Susan Perry's letter were almost *verbatim* from the letter sent to the FPC Session and later anonymously to the entire congregation on November 4.

Jan. 10 -- Session meeting with Listening Team. The Session dialogued with Listening Team and afterward discussed Listening Team member, Jean Summerfield's experience of 2x2 teams from the Session used to address any member

concerns. The Presbytery Listening Team promises to refer all calls back to Session and FPC Elder Shepherds on the Session.

The Session never voted to deny the Listening Team's request, as alleged in today's Presbytery packet. No vote was ever taken by the Session. Instead the Session discussed setting up their own listening teams to hear and address any member concerns.

- Jan. 10 -- Email correspondence from Rev. Jim Robinson stating, "I was encouraged by our meeting this evening."
- Jan. 25 -- Email correspondence from Susan Perry stating, "I will be reporting on the positive meeting that we had with First Huntington's Session."
- Jan. 25 -- Letter from Dr. Minihan to FPC Session about facilitating our own listening team process by contracting with Kanawha Pastoral Counseling Center.
- Jan. 25 -- Email to Susan Perry explaining upcoming proposal for specialized training and the creation of our own listening teams.
- Jan. 26 -- Acknowledgement of email by Susan Perry and thanks expressed for such a quick response.
- Jan. 29 -- Follow-up lunch with Rev. Jim Robinson, Pam Ferrell and Jean Summerfield. Information shared about proposed plan to have KPPC training. Positive response from Rev. Robinson and expression of thanks for the time spent with them.
- Jan. 31 -- At its stated meeting (held one week earlier than normal) the FPC Session approves contracting Sky Kershner, Director of the Kanawha Pastoral Counseling Center to train in NVC and Empathy Listening at a cost of over \$1,000.
- Feb. 12 -- Second Letter sent by the same concerned FPC member (as above on Nov 4) to FPC members and the Presbytery, again voicing complaints (including the existence of a Task Force and the "gay issue"). Encourages FPC members to continue contacting the Presbytery to express dissatisfaction and again includes contact information for Pam Ferrell.
- Feb. 25 -- Email communication from Dr. Minihan to Susan Perry and Rev. Jim Robinson expressing frustration at this member's continued letters to the congregation and Presbytery's continued dialogue with FPC members.
- Feb. 26 -- Email received from Susan Perry noting that Presbytery has received 2 calls and the letter from the concerned member and has shared with those contacting the Presbytery FPC's plan for special training and subsequent Elder-led listening teams from the Session. Susan also notes that the Ministry Committee will likely

not dissolve the Presbytery Listening Team until the "Session fulfills the assurance that was made to us that the Session, acting in teams, would hear the concerns of your people."

- March 13 -- Training with Sky Kershner of KPPC. Note that March 13th was the *earliest* date Mr. Kershner and the Session could meet together. Session attendance was 100% and came after Sunday School, worship and a funeral/committal service by Dr. Minihan.
- March 31 -- April Church Newsletter published informing the congregation of Elder-led Listening Teams to be available for any congregational concerns.
- April 3 -- FPC Elder Listening Teams established for the purpose of initiating contact with concerned members. (Please note the publication date of the newsletter was the Thursday before the Sunday Session meeting. Even though elders were not officially paired until Sunday, the events were basically simultaneous).
- April... -- Elders (paired in two's) meeting with concerned members. Note: in most cases FPC elders initiated contact.
- April 29 -- May Church Newsletter published continuing to inform the congregation of Elder-led Listening Teams to be available for any congregational concerns.
- May 1 -- Regular Session meeting. Initial reports from Elder-Listening Teams. A June 9, date set for Elder Listening Teams to complete their work and report back at a special called meeting of the Session.

To date, FPC elders have had "9" listening session with a total of 13 concerned members. 5 more listening sessions are being scheduled. These numbers are consistent with the Presbytery's report of receiving calls from 10-12 concerned members.

Please note that the concerned member responsible for sending letters to the Session and members of FPC and the Presbytery (on Nov. 4 and Feb. 12) has refused to meet with the Session or Elder-led listening teams despite repeated invitations from the Session and Elder listening teams.

May 10 -- Presbytery information stating intention of asking for the establishment of an Administrative Commission with the powers to establish their own Listening Team and additional vast powers over the church – including the right to assume Original Jurisdiction over the Session. There was no prior indication to the FPC Session of this intended action.

The above timeline is provided to demonstrate the following:

1. That the Ministry Committee had been fielding calls from 10-12 members of FPC for several months and had established their own Listening Team prior to any knowledge by the FPC Session or any dialogue with the Session to ascertain the nature of these calls.

Violation of G-3.0201, which states: The Session is the council for the congregation," and that, "The Session shall have responsibility for governing the congregation and guiding its witness to the sovereignty of God in the world, so that the congregation is and becomes a community of faith, hope, love and witness" (G-3.0201).

- 2. That prior to any dialogue with the Session, the Ministry Committee had already determined a specific plan of action. This plan is similar to the one being proposed by today's motion for an Administrative Commission with the addition of unjustifiably broad powers over the church, including the right to assume Original Jurisdiction.
- 3. That the Ministry Committee had been in contact with at least one concerned member of FPC and given that member the names and contact information of Presbytery personnel to call. This information was mailed to the FPC congregation prior to any disclosure on the part of the Ministry Committee that they had been receiving calls.
- 4. The Presbytery had published information in the December 2015 Presbytery packet about "reported difficulties" at First Presbyterian Huntington. This was more than a month <u>before</u> the Ministry Committee Listening Team had ever met with the Session.
- 5. That upon hearing the Ministry Committee's concerns, although general in nature, the FPC Session embarked on a detailed plan to address the concerns of its members. This plan included adopting the suggestion of Listening Team member, Jean Summerfield's experience of elders teams initiating contact with concerned members.
- 6. At its own expense, the FPC Session contracted with the Kanawha Pastoral Counseling Center to train in NVC and Empathy Listening at a cost of over \$1,000. The rationale for this training was to provide Session members with the best tools possible for dialoguing with any concerned members.
- 7. Upon completion of training with KPCC, the FPC Session made the congregation aware that pairs of elders were available to meet to discuss any concerns. These meetings have been on-going and the number of meetings having taken place (9) and still to be scheduled (5) is consistent with the reports of calls from 10-12 concerned members.
- 8. That the Session of First Presbyterian Church is managing its affairs wisely and in good order, and that request for an Administrative Commission with broad powers, including the right of assuming Original Jurisdiction (taking over the church) is unjustified and out of order.

FPC has a **passion** to share the message of **Jesus Christ** by serving as His hands and feet in our community and around the world.

In 2015 and 2016, a total of over \$400,000 is devoted to our mission projects - both locally and abroad.

Local Missions

- ➤ Harmony House FPC members serve 3 meals a month to 100-125 homeless individuals at Harmony House; also FPC provides breakfast foods 2 days a week.
- ➤ 'Helpington' is a neighborhood cleanup project started with another downtown church in 2011. This spring the project involved 4 churches and 253 people cleaning a 23-block area on Huntington's west side.
- ➤ **New Beginnings Crisis Pregnancy Center** During Lent, we collected "Baby Bottle Offering" to contribute \$1,885 to support mothers in a crisis pregnancy situation.
- ➤ Blessings in a Backpack Recognizing that many children's meals are provided primarily at school, and they have inadequate food resources on weekends: FPC has partnered with 3 other churches to provide 240 Central City Elementary students with a backpack containing snack meals every Friday.
- ➤ Empty Bowls An annual mission of selling handmade ceramic bowls with a soup lunch. Bowls are donated from several sources including FPC's own Skip Seibel and his wife Karal. This year the project raised \$17,000 for Fighting Hunger Foodbank in Huntington.
- ➤ Christmas International House FPC was the founding church of CIH in 1965 by Rev. Pete Peterson. We have a long history of hosting up to 25 international students each year during the holiday period while their university dormitories are closed. Church members have them in their homes for meals, take them to group activities (ice-skating, caving, laser tag, roller skating, sledding, sporting events, movies, and more), prepare meals with and visit with the students during their holiday stay. Several non-believers have accepted Jesus as their Savior after experiencing Christ's love through our members.
- ➤ Christmas Day Dinner This program was developed to allow other meal program providers to have Christmas Day off with their families. Many FPC families make serving the homeless and shut-ins in Huntington a priority on the birthday of our Lord. This past Christmas we prepared and served or delivered

- **800 meals!** In addition, we witness the true meaning of Christmas through Scripture lessons and carols to our dining room guests. Guests are encouraged to take a gift of mittens, gloves, or scarves and a handmade pillow.
- ➤ World Changers Each summer, 300 youth and adults spend a week in Huntington working on homes. FPC hosts 3 crews of 12 participants each. This involves having them for worship and lunch on Sundays and providing lunchtime meals at their worksites for 5 days.
- Cridlin Food Pantry FPC donates at least 96 food items every month.

Outreach Ministries and Mission Partners

- ➤ Cabwaylingo Presbyterian Chapel FPC supports the monthly food bank and clothing closet for about 200 families. We help to provide lay pastors for worship and support various youth and children activities throughout the year.
- ➤ **Loved Ones Group** is a community outreach support group for people who have a loved one who is suffering with addictions. FPC offers this group which meets once a week.
- ➤ Narcotics Anonymous FPC hosts 2 meetings per week with 8-12 individuals attending each.
- ➤ **Alcoholics Anonymous** FPC hosts 2 meetings per wk with average of 46 individuals on Mondays and 8-10 on Saturdays.
- ➤ Recovery Point Huntington Lauded in WV for its success in treatment of alcohol and/or drug addiction, Recovery Point has partnered with FPC as a location for clients to "trudge" to class which will meet twice daily, five days a week. Project Coordinator is a member of FPC.
- ➤ Young Life Huntington—FPC provides office and meeting space for this important ministry to adolescents. 30-40 youth attend each gathering.
- ➤ Young Lives A group of Young Life for teenage mothers. FPC provides nursery care and a meeting place each month.
- ➤ **Riverview Manor** FPC provides monthly worship services at this downtown assisted living apartment building. Also, FPC provides a monthly meal and entertainment evening and transports residents for shopping twice a month.
- ➤ **Habitat for Humanity** FPC hosts multiple groups that come to Huntington to participate in this worthy ministry including: Boston College group, Johns Hopkins group, Mechanicsburg, PA group, Bike-n-Build groups.

Foreign Missions

- ▶ **Peru Mission Trip** This July is our 19th year of mission work in the Iquitos, Peru area; we are taking 9 people. Over the years, FPC has donated and installed over 300 water filters in the village of Gallito. Each week our groups are there we teach 60 children in Bible school, see about 300 patients in the medical clinic, and perform construction projects on the church and village homes.
- ➤ **Uganda Mission Trip** After our first group of 9 people went in 2013, FPC adopted the Village of Lapinollyo. This is our third year to provide financial and spiritual support including paying the pastor and helping to build a church facility. This year, a group of 10 FPC members and senior pastor are planning to go in October.

Brush Creek Presbyterian Church: A History

The history of Brush Creek Presbyterian Church begins in the town of Ridgeview, West Virginia, where the community had a one room log schoolhouse, a teacher, and approximately thirty children from the area who were students. "As yet we had no church or Sunday school, but occasionally a preacher would come in and have meetings in our schoolhouse. Our folks decided we needed a Sunday school for the children, but no house was available." ¹ So that the children's books would not be misplaced or misused, the community leaders asked Oliver Eastep if they could use his blacksmith shop as a location for the church and Sunday school. Because Mr. Eastep was no longer using his shop, he quickly agreed.

"They cleaned it out to make room for the Sunday school class," says Eastep's granddaughter Delores Cook. She continues, "They got logs and made seats. It didn't even have a floor."²

After the work of clearing out the blacksmith shop, cutting lumber, and sending out the invitations, a few people, all of whom were lovingly referred to as "Uncle" brought families together there in Ridgeview. "Uncle Oliver, Uncle Joe Epling and Uncle Esthel Snodgrass organized our Sunday school, and we were very happy people. Our only literature was cards for the children that had Bible story questions and answers all on the one card."

In the summer of 1902, Rev. George Reaugh arrived to visit the Sunday school class. He and Rev. R.H. Rogers, who were both sent there by the Synod, held a series of meetings while overseeing the instruction. The church history documents several people accepted Christ during those meetings. It

was obvious that the Holy Spirit was moving, so the leaders started considering what it would mean to actually undergo the work of constructing a church building. Delores Cook explains, "a man named Ballard Hurley donated land on which a church building could be constructed. This property was about 1 mile from where the current church is located."

As the community grew, Mr. Reaugh invited a woman named Mate Edna Peabody to come assist him in with work in the area. In addition, a Sunday school missionary commissioned by the Synod named Rev. Charles Humble came to teach and reach out to the families living in Ridgeview. A few more teachers and missionaries in the region, D. J. Gillanders, R. H. Rogers, and a "Miss Clarke" also contributed to the Sunday school classes and meetings. The minutes of the church's organization read, "As a result of the work done by these Sunday School Missionaries and the Bible Teachers eighteen person petitioned the Presbytery for the organization of a Presbyterian Church." This petition was presented at the Presbytery meeting in Charleston on October 21, 1905. A committee was appointed to visit the building site and bring the community together for planning. A few weeks later, Rev. D. Alex. Henry, Secretary of the Board of Sunday School Work, went to Ridgeview to preach and preside over the organizational meetings that day. The minutes, as recorded by W. B. Sterrett, reflect that nine individuals were received by letter of transfer and nine people were received by profession of faith and baptism. "Mr. Ward Ferrall and D. J. Gillanders were elected and ordained Elders. The Church chose the name of The Presbyterian Church of Brush Creek."

Fourteen years after the congregation was established, the congregation members became active in their support of the Davis-Stuart School, a Presbyterian residential treatment center for teens and their families. "George N. Davis and his wife, Mary Estelle Kinports Davis donated their 574-acre farm near Lewisburg, WV to the Synod of West Virginia...to serve as a home for orphaned and dependent children. The home was chartered in 1919 to a board of directors."

Over the years, the congregation of Brush Creek Presbyterian Church not only supported regional missions and organizations, they held weddings, funerals, baptisms, and dedications, held Bible Studies, and organized a Vacation Bible School in the summertime. "We even hosted a Presbytery meeting," states Delores Cook, the current Clerk of Session. "Our little church, can you imagine? That was quite a few years ago."

As a child, Cook remembers Dr. Linus E. Brown and his wife Jenny coming to the church. She recalls, "They would go into the schools, and Mrs. Brown would play a keyboard. He would have a little Bible story and she would play that little keyboard and we would sing." As a student at Brush Creek grade school, Cook describes the school and the little bridge that went across the creek that she could see from her classroom. "I would be excited to death when I knew it was there day to come to school and would see them coming across the bridge with that little keyboard," says Cook.

The years brought change in the valley, but Brush Creek Presbyterian Church remained. Members of the church decided that the only location in town that had sufficient acreage for a building and parking

was near the manse where Dr. and Mrs. Linus Brown were living. The 2 ½ acre plot of land was sold to the church for the small sum of \$500.00. To save on the cost of construction, they actually were able to use some of the timber on the property. "They set a day and asked for anyone who would like to help cut timber to come along." In order to finance the church building, the members asked for donations, had fundraisers, and also contributed their own "sweat equity." The current church building was dedicated in 1952.

"In our little town of Ridgeview, we used to have a post office, a grade school, a coal company, a company store, and we had another little store that was in the same building where the post office was. And the church. That was our community," says Cook. She proudly explains how the church was served the people there, even in the midst of an economic downturn. "We hosted many work groups from various parts of United States who came to serve the people in the valley. And, many people don't know this, but we were one of the first churches in the area to have a rummage sale. We got items donated from as far away as New York." She says that the Women's Association got the proceeds from these sales, and they purposely sold items for 10 cents each so that the residents could afford to make purchases. "If there was a need there, we would try to fill it. If there was a need for an electric bill or gas bill, for food or for clothing, we would reach out. And we didn't just reach out materialistically, we also reached out spiritually." 10

Cook continues, "When the church was built we had a lot of people that attended. When the coal company closed, some people moved away. The young people moved because of the downturn in the economy. Those of us who are left, well, I must be the only one. I think that God kept me here because I played the piano, and I attended the church. This was my home and I stayed."¹¹

On Saturday, July 20, 2002, the congregation of Brush Creek Presbyterian Church hosted a 100 Year Celebration from 6:30-8:30 pm. The program began with a welcome and prayer led by Rev. Harley Tweed, and included a presentation about the church's history, an introduction of former pastors, and special music.

Sadly, the population of Ridgeview continued to decline, and the church members started moving away, becoming shut-ins, or passing away. It was clear that the few members who were left in the area could not pay for the maintenance of the building or a pastor anymore. Therefore, after much prayer and deliberation, a decision was made to close the church. The final Service of Worship at Brush Creek Presbyterian Church was held on October 25, 2015, with Rev. Ralph "Jed" Alfred presiding.

"It's almost like pouring liquid out of a bottle. After so long the last drop is the last drop. I guess I am the last drop," says Cook, with a sigh. After reminiscing and sharing stories, she concludes, "We used to be a thriving church. But I want people to know the reasons we got down to one drop is because new people didn't move in." 12

As the church is closed and officially dissolved, it is important to remember the past and celebrate what the Lord has done for the people who made a home in the town of Ridgeview. Consider the

people who, over the 100-plus years of existence, taught a Sunday school class; shared a prayer request; learned a new song at Vacation Bible School; sang "Silent Night" on Christmas Eve; grieved for family member; celebrated on Easter morning; proclaimed the Word of God; participated in The Lord's Supper; signed up to cook a meal for a neighbor; sang in the choir; made a repair in the church sanctuary; or generously placed money in the offering plate.

Delores Cook wrote an acrostic poem about her beloved church in August of 1997, entitled "Past, Present, and a Challenge for the Future: Brush Creek." It is shared here as a tribute to the work the Lord has done through the people Brush Creek Presbyterian Church.

Beautiful are the memories of the Brush Creek Church
Reverence to God has been first and foremost
Ushered in with patience, love, faith and hope
Seemingly revealed from records and notes
Heavenly messages carried out by God's people

Contained a direction for both young and old
Revive us again are the words I am hearing
Every day is His day to bring souls to Him
Energize us today with Your love and guidance and our
Keeping Your commandments will be our challenge for the Future.¹³

The Light of Christ in the Coal River Valley

Brush Creek Presbyterian Church in Ridgeview, West Virginia is part of the Presbyterian Church (U.S.A.)'s pioneering efforts to spread the Good News of the Gospel in the Southeastern United States. Numerous articles, Presbytery Reports, Minutes from Presbytery meetings, and Minutes from the meetings of the Board of National Missions, Home Missions, and Women's Missions tell the stories of the missionaries that were in the region—all of whom had a role in establishing Brush Creek Presbyterian Church, as well as many other congregations. These missionaries, and therefore, Brush Creek Presbyterian Church, are part of the story of our denomination's rich mission history here in the state of West Virginia.

Rev. Dr. Christopher Humble, Martha Priscilla Spencer, and Mr. George Reaugh were among the individuals who were called to ride on horseback and travel on foot into the Coal River Valley and the mountains south of Charleston.

[Rev. Dr. Christopher Humble]

A member of the First Presbyterian Church of Colcord, lovingly known as "Aunt Moll" began praying daily that a minister would come to their town, a remote area in Raleigh County. According to their history, she began her prayer vigil in 1887, knowing that the Clear Fork Valley was mostly inaccessible. "Ministers visited infrequently, and this made isolation more painful, according to Aunt Moll. 'Others used to bring the light and take it away again,' she was quoted as saying in a 1928 edition of the Presbyterian publication *Home Missions*. 'Then it was blacker then ever.'"¹⁴

However, she persisted in prayer, and in 1893, the Synod's new Sunday School Missionary arrived. His name was Dr. Christopher Humble. Aunt Moll's story declares that Dr. Humble "came over the top of Kayford Mountain," and that he had been appointed by the Synod "to bring the light to the wilderness." ¹⁵

Author John Somerndike wrote the following in 1912, in his book *On the Firing Line with the Sunday School Missionary:*

Think what this means to the future of this region. Is it not to the lasting credit of our church that she sends forth messengers to perform this Christlike service?

In studying the conditions and the progress of missionary effort in this field mention should be made of the noble and self denying labors of Dr. Christopher Humble of sacred memory.

In 1895, the Board of Publication and Sabbath School Work first secured the services of Dr. Humble placing him in charge of Sunday school missions among the mountaineers of West Virginia, Kentucky, and Tennessee. For fourteen years Dr. Humble labored faithfully in that field,

living the life of the people in those mountain fastnesses, and ministering to their needs in many ways. With rare patience, with sweet and gentle spirit, and yet with a firmness, born of true conviction, this man of God wrestled with the difficult problems confronting him. The mountain work in those days was not yet organized.

With the aid of the missionary funds of the Board, he succeeded in gathering a force of eighteen or twenty Sunday-school missionaries, locating them at strategic points. From their labors, the results have been truly marvelous. Dr. Humble also originated the plan and organized the work of the women Bible readers of the Woman's Board of Home Missions whose labors have been blessed of God in following and developing the missions planted by the Sunday school missionaries.

Dr. Humble was beloved by all the mountaineers. He understood them and they trusted him implicitly. Many benighted souls in those dark mountain cabins found peace and freedom as the light of God's love dawned upon them through the Christlike character and faithful words of this man who opened the Book to them and gently led them out of their ignorance and superstition. The memory of this hero of the Cross remains fresh and honored among these appreciative people.

This was his appeal in their behalf:

Long these people have waited silently except to God. Is it for the Presbyterian Church they are waiting? So God's providence seems to say for truly its word is, 'Behold, I have set before thee a door opened.' Shall we enter while the door is open or shall we permit this noble people at our very doors now awakening to be the prey of immorality, Mormonism, or other forms of godlessness? May the voice of God move our church and move her now to the rescue of our mountain brethren and their children. ¹⁶

Rev. Dr. Christopher Humble used his gifts as an organizer, recruiter, teacher, missionary, and pastor. His efforts allowed for others to live out their own call to share the Good News of the Gospel in the mountains and valleys of West Virginia. He truly believed God had opened doors for Christ's light to be shared in that region. Dr. Humble's tireless efforts are to be remembered, celebrated, and gratefully acknowledged.

|Martha Priscilla Spencer|

In 1895, in response to many appeals, the General Assembly of the Presbyterian Church had authorized the Board of Home Missions to commission women as Bible readers and community workers. "The need for such service had been especially urged by Dr. Humble, and by members of Parkersburg Presbytery, who saw the slow progress being made in isolated communities when only occasional preaching could be provided." There was a need for daily interactions with people in their homes, and

Dr. Humble knew he needed not only more people, but those who could provide good leadership. An article in a 1926 issue of *The Presbyterian Magazine* tells us that authorization was given for the Presbyterian Church to make roads where there were none, for at that time, the railroad did not reach the Coal River Valley. The author explains, "At the Moody Bible Institute in Chicago was a woman of unusual Christian and educational background, of strong physical power, a woman equipped with a sweet but indomitable spirit—Martha Priscilla Spencer."

Spencer, who came from a large Quaker family in Pennsylvania, moved to Kansas where she not only studied, but also worked as a teacher and superintendent. She then continued her schooling in Boston and Philadephia in the early 1880s. But God was calling her to full time mission work. So she moved to Chicago for training at the Moody Bible Institute. "...in 1890 [she] entered Moody Institute, and it was there that Dr. Humble, in search of an intrepid spirit, unafraid of hardship, found her and challenged her to pioneer work. Her response was immediate, and October of 1895 found her in the Coal River Valley, commissioned by the Board at a salary of \$300 per year." 18

It is clear that her willingness, determination, and calling led her to this region, but also gave her the sustaining grace she needed to tirelessly travel and so readily serve. "Miss Spencer went out into the valleys and coves over a circuit of some fifty miles to the points now known as Colcord, (then Lawson), Dorothy, Jarrold's Valley, up Marsh Fork to Dry Creek, up Clear Creek to Fulton, and later to Cabin Creek," writes Bennett on behalf of the Board of National Missions. Describing Spencer as "dauntless" and "cherished," Bennett continues:

To her came the mothers for advice and the daughters for encouragement, to isolated homes and lonely families and to all who were spiritually needy went the Bible woman. She organized six Sunday school and kept them alive by personal leadership, developing helpers as rapidly as possible. 'Most of the journeys were made on foot, though occasionally by the use of a neighbor's steed. The very stones were sometimes agonizingly familiar, yet as the mountains were round about, so the Lord hovered and protected His own.¹⁹

Reflecting on the legacy of Martha Priscilla Spencer's many talents and years of service, Bennett writes, "When God creates a need He also creates the person to meet that need."²⁰

|Mr. George Reaugh|

In July of 1902, Mr. George Reaugh visited a Sunday School that had been started in Oliver Eastep's Blacksmith shop in Ridgeview, WV.

Reaugh was supported by Tenth Presbyterian Church in Philadelphia, Pennsylvania. A 1903 New York Observer article entitled "Presbyterianism in Philadelphia" explains, "During the past five years this church has expended for all purposes above \$200,000 an average of more than \$40,000 a year. Nearly

\$10,000 is annually divided almost equally between the Home and Foreign Boards."²¹ This congregation allowed Mr. Reaugh to work as a Sunday school missionary, and was one of 30 missionaries supported by these special offerings who were establishing Sunday Schools in the mountains of West Virginia.

Only a few years after Mr. Reaugh arrived in Ridgeview, his report to the Board of Home Missions of the Presbyterian Church at the General Assembly reflected that the Sunday School in that community was one of many in the area that had been established. His report states, "When I came to Boone County, I could learn of but two Sabbath schools in operation. I have organized twenty-five. We have now seven permanent Sabbath schools and of the fifteen summer schools, ten are ours."²²

This movement of sending organizers for Sunday schools (or Sabbath Schools) was a strategy that had been in place since the end of the 1800s, yet many congregations, and their members, were unaware of the ways in which the churches in such rural areas were established. The leadership of these movements did what they could to communicate the need for both people and for finances.

Somerndike explains and encourages it in his 1912 publication:

The Presbyterian Church at large has been sadly lacking in knowledge of Sunday school missionary work. It is a form of missionary effort which has a sphere distinctly its own, cultivating fields beyond the reach of the activities of any other benevolent board of the church, and producing results that should satisfy the most exacting....this cause, which is so far reaching in its influence upon the future of our national and church life before Christians everywhere [is] one which should be earnestly and generously supported both as a religious and as a patriotic duty.²³

The Lord called people to faithfully and obediently carry the light of Christ into the mountains of the Coal River Valley, and the established congregations and leadership of the denomination supported this work through financial donations, training, and prayer. As a result, Brush Creek Presbyterian Church became one of the many beacons of the Gospel. Mr. Reaugh forged the way for a small Sunday school meeting in a blacksmith's shop to grow into a willing Body of Christ in Ridgeview. He also became a leader, teacher and pastor in that town, opening the way for over a century of ministry to be lived out by the people who made that town their home.

APPENDIX F

MISSION COMMITTEE GRANTS

There are three different kinds of grants that are accessed through the work of the Mission Committee.

- Mission Grants: Funds that are budgeted each year to support Mission activity in the Presbytery of WV. There are three categories of funding: Institutional Partnerships, Mission Partnerships, Mission Startups.
- **Brick and Mortar Grants:** Funds from the Presbytery Budget for Building needs, primarily emergency needs.
- **Hunger Action Grants:** Funding available through the generosity of our congregations giving to through the "Centsability Offering."

Brick and Mortar Grants:

- 1. In general related to program or building needs.
- 2. Usually take a minimum of three months to process.
- 3. Mission Committee approves the concept
- 4. Mission Committee then passes it on to Stewardship and Trustees; they approve based on fund availability.
- 5. There is a rolling deadline.
- 6. Funding renews at the beginning of the year. \$15,000 per calendar year for all projects funded through this grant.
- 7. Remember: Receiving a grant can help you as you seek to find other grant possibilities.

Mission Grants:

The deadline for all categories is early fall. Grant applications will always be due on the first Tuesday following Columbus Day to receive funding for following calendar year. Annual reports are due by September 1 each year. Grants are ordinarily paid in four quarterly installments. Grants are divided into three categories:

- 1. Mission Start up Grants: Apply every year, limited to 3 consecutive years. If an organization has been funded 3 consecutive years that organization will need to wait for at least one calendar year before reapplying.
- 2. Institutional Partnerships: Report back yearly, but do not have to apply every year.
 - a. An annual report is required each year. The Report should include:
 - a basic mission statement from organization,
 - A statement of what were funds were used for
 - How the organization communicated within the presbytery at large about their ministry.
 - A plan for the following year.
 - b. A reminder will be sent in early June from the presbytery office. Reports are due no later than September 1 and will be read at the September meeting of Mission Committee.
- 3. Mission Partnerships: Report back yearly, but do not have to apply every year.
 - a. An annual report is required each year. The Report should include:
 - a basic mission statement from organization,
 - A statement of what were funds were used for

- How the organization communicated within the presbytery at large about their ministry.
- A plan for the following year.
- b. A reminder will be sent in early June from the presbytery office. Reports are due no later than September 1 and will be read at the September meeting of Mission Committee.

At the conclusion of the year please submit the following as a report. If this is not your first year applying for the grant please attach your report from last year.

- 3. Number of people benefited.
- 4. Projected benefit of the program of the year ahead.

When a grant from any category is approved:

The Mission Committee will send letter announcing the funding of the request, the amount and a request to the organization to report to Presbytery in one of the following ways:

- a. A newsletter article
- b. A video for link for our website,
- c. Photos.
- d. A display at a presbytery meeting
- e. An oral report at a presbytery meeting
