ONE HUNDRED SEVENTEENTH STATED MEETING

CALL TO ORDER

The Presbytery was called to order at 10:00 a.m. by Moderator Stephen Baldwin.

GREETINGS

Pastor Todd Wright welcomed Presbytery and told about the beginnings of the church.

Acting Stated Clerk Jim Robinson recognized and welcomed ministers new to the Presbytery and invited them to sign the Book of Obligations: Elise Neal, First Church, Fairmont; and Julie Sterling, Buckhannon.

Robinson introduced and welcomed visiting minister David Bower.

Robinson recognized and welcomed visitors and elder commissioners attending their first Presbytery meeting.

WORSHIP

The meeting began with worship and celebration of the Lord's Supper led by John Nelson, Liturgist; Barbara Hopta, Preacher; Todd Wright and Kari Preslar, Celebrants; and Musicians Carolyn Perrine, Sharon Curnutte and youth and young adult string players: Erin Chiparo, Jake Jacobs, Lillie Jacobs, and Samuel Stickler. An offering of \$902 was received for Denver Presbytery's response to the recent shootings in Aurora, Colorado.

PROGRAM

Mary Odin and Pamilla Ferrell led Presbytery in an informational program about the new Presbyterian hymnal *Glory to God*. They were assisted by Carolyn Perrine, Organist, and Don Parker, Guitarist.

GENERAL ASSEMBLY COMMISSIONERS' REPORT

The Moderator recognized General Assembly Commissioners Joyce Armentrout, Carl Pattison, Ken Bibbee, and Peter Vial who presented the General Assembly Commissioners' report. They spoke about some of the issues that came before General Assembly and their sense of the state of the denomination. They showed a video report by Tory Parker who was the Young Adult Advisory Delegate. Commissioners Joyce

Armentrout, Ken Bibbee and Carl Pattison also provided written reports. (Appendix A, pages, 110-113.)

MINUTE FOR MISSION

The Moderator recognized Claire Butler who presented a Minute for Mission about the Peacemaking Offering. Butler showed video giving information about the offering.

AFTERNOON PRAYER

After a recess for lunch, Presbytery reconvened with Afternoon Prayer led by Robert G. Newman and Moderator Stephen Baldwin. The task force previously appointed by the Moderator to study the Fellowship of Presbyterians and Evangelical Covenant Order of Presbyterians was commissioned. Members of the task force are W.D. Hasty and Shelly Barrick-Parsons, Co-Chairs; Doug Jenkins, Maureen Wright, Pam Ferrell, Mike Lykens, and Nancy Didway. Consultant is Dean Thompson, and staff support is Craig Butler.

ANNOUNCEMENTS

The Moderator recognized several people who gave announcements about resources and activities of the Presbytery.

STATEMENT OF QUORUM AND ENROLLMENT

Acting Stated Clerk Robinson reported that a quorum was present of Ruling Elders from 64 churches and 56 Teaching Elders. (Appendix B, pages 114-120.)

Robinson led Presbytery in a brief orientation.

MODERATORIAL APPOINTMENTS

Moderator Baldwin appointed Ed Hamilton, Elizabeth Campbell, Jackie Blankinship, and John Sonnenday as Temporary Clerks and members of the Presbytery Worship, Review and Polity Committee present as a Committee on Bills and Overtures.

PROCEDURAL BUSINESS

Robinson presented the Procedural Matters as printed in the docket and moved item C. 3 concerning the limitation of debate. After receiving a second, Presbytery **adopted** the motion by a two-thirds vote. (Appendix C, pages 121-122.)

Now that the proper procedures are known, the expectation is that they will be followed from now on.

The Moderator recognized Shelley Barrick-Parsons who spoke about the progress being made on the Westminster House in Morgantown.

MISSION INTERPRETATION AND STEWARDSHIP COMMITTEE

The Moderator recognized Todd Wright who presented the report of the Mission Interpretation and Stewardship Committee.

RECOMMENDATIONS:

1. (Consent Agenda) We recommend that the offering for the September 11, 2012 meeting of Presbytery be designated as for the **Presbytery of Denver's response to the shootings in Aurora,** specifically their support of the Aurora Public Mental Health Fund which is providing free counseling for the survivors. Julie Swaney, chaplain at University Hospital, wrote, "A number of our patients who have been discharged are using their services so ... I think they would be incredibly grateful for the assistance and support."

2. (Consent Agenda) We recommend that **Yelba Rivera**, coordinator for CEPAD (the Nicaraguan Council of Churches), be granted time to report on their ministries and invite people to take part in the presbytery trip to Nicaragua in April 2013.

Wright introduced Yelba Rivera from CEPAD, the Nicaraguan Council of Churches. Rivera showed pictures of her family and co-workers and explained the work of CEPAD. CEPAD works in six regions, aiding communities in need, providing training so communities can be self-sustained. The organization also works with persons dealing with alcoholism and domestic violence.

COUNCIL

The Moderator recognized George Lilley, Jr. who presented the report of Council.

RECOMMENDATION:

1. That Presbytery adopt the 2013 Budget (Appendix F, pages 135-139.)

Lilley moved recommendation 1. Presbytery **adopted** the recommendation.

- A. Council concurred with Personnel and Administration's recommendation that the position of Bluestone Director be lodged under the jurisdiction of P&A, included in the Personnel and Administration budget; and report to the General Presbyter. This recommendation was consistent with the Jer. 29:11 report. The Chair of Council will name an ad hoc committee to study the nature of Bluestone Conference Center Inc. in relation to Presbytery. Council concurred that P&A be enabled to modify the position descriptions for Presbytery staff in accord with the Jer. 29:11 report previously approved by Presbytery.
- B. Heard that the Committee on Ministry is recommending to Presbytery that the minimum terms of call for teaching elders and Certified Christian Educators be increased by 3%, and that congregations be encouraged to consider a 3% increase for those working above minimum.
- C. Melrose, Mullins, and Grace, Lashmeet churches have paid their negotiated fees and their property has been deeded to them.
- D. Heard from Camps, Conferences, and Retreat Ministries recommending that Presbytery pursue a capital campaign. The Chair of Council agreed to appoint a committee to study the needs for and feasibility of a Presbytery capital campaign. CCRMC noted the need to renew the covenant with Friends of Bluestone which expires December 31, 2012. The Chair of Council will appoint a committee.

- E. Approved Joanne Glaser to celebrate the Sacrament of Communion at the Fall Gathering of Presbyterian Women in Flatwoods.
- F. Heard from the Moderator that a task force had been named as requested by COM and approved by Presbytery to study the policies and teachings of the "Fellowship of Presbyterians" and "A Covenant Order of Evangelical Presbyterians" and report their findings to the Presbytery.

PRESBYTERY WORSHIP, REVIEW AND POLITY COMMITTEE

The Moderator recognized Kathryn McCrary who presented the report of the Presbytery Worship, Review and Polity Committee.

RECOMMENDATION:

1. That the Presbytery approve the following Manual change:

That Certified Christian Educators serving in educational ministries under Presbytery's jurisdiction, who are ordained Ruling Educators, be given voice and vote at all Presbytery meetings.

The Worship Review and Polity Committee further recommends that this change be included in the Manual re-write that will be presented as a whole for approval once the reorganization under Jeremiah 29:11 is complete.

McCrary moved recommendation 1. Presbytery **adopted** the recommendation.

INFORMATION about the Manual change:

Justification:

This policy was approved by amendment to Book of Order (G-2.1103b), and was supported by this Presbytery.

Effect:

According to a review of our records, the following would be affected by approving this recommendation: Forrest Palmer*, Cindy Taylor, and Karen Robinson. Other positions would be covered, but the persons in that office have voice and vote through other provisions, such as Susan Sharp Campbell as a pastor and Associate Presbyter for Christian Education is a Teaching Elder.

(*Already has vote by virtue of his position in the Presbytery.)

Fife asked Ken Atkins to come forward to be recognized on the occasion of his retirement. Fife led Presbytery in a brief time of worship, and the Moderator declared Atkins Honorably Retired. Atkins addressed Presbytery briefly.

RECOMMENDATION:

INTERIM EXECUTIVE PRESBYTER, FORREST PALMER

General Assembly

Since the last Council meeting on May 10 at Davis Memorial Presbyterian Church in Elkins, the 220th General Assembly has met in Pittsburgh. Our commissioners and YAAD (Young Adult Advisory Delegate) prepared diligently for their roles. We had training, which I led, at the presbytery office. We consulted by email on details. I worked out a lunch time together for us to gather together at First Presbyterian, Pittsburgh, as a way of touching base with each other and to hear reports on their standing committee work. Our YAAD, Tory Parker, carried our presbytery banner in the opening worship service and was the first presbytery banner down the aisle! As a new venture for me, I wrote a daily blog, reflecting on what I saw at the Assembly, including some pictures within the blog. The Presbytery of West Virginia was present at this General Assembly:

- --our commissioners and YAAD.
- --volunteers from this presbytery, helping to host, sing in the mass choir, welcome people, clean up after communion and a variety of hosting service.
- --the bus on Saturday bringing people to experience the opening worship service and the election of the Moderator.
- --Staff present to observe Jim Robinson and I were seated in the presbytery section of tables and attended many hours of the plenary sessions. Karen Robinson and Claire Butler were also present at the General Assembly.
- --Kris Haig (First, Morgantown) worked on the design of the opening worship service.
- --Elizabeth Campbell (First, Williamstown and Waverly Bethel) played saxophone in the volunteer band, leading worship.

I was able to meet the new Moderator, Neal Presa and extended an invitation for him to come visit this presbytery, especially since we were not able to host Cynthia Bolbach, due to her cancer surgery and chemotherapy. (Cyndi did lead worship and preached at the opening worship service – and was grateful for the many prayers and expressions of support she received, including from this presbytery.) Neal personally indicated to me that he has interest in coming to participate with WVMAW, and Joan Stewart is engaged in conversation with the Moderator on how that might take place – including the possibility of a YAAD gathering here in this presbytery, focused on service and mission, with WVMAW. He invited me to become his Facebook friend, and I have done that! Stay tuned!

All in all, I perceived there was a sense that this Assembly knew that the denomination had gone through major change with the adoption of the New Form of Government and in changing the ordination standards. The Assembly debated many items before it, including some very close votes. There was a sense that this Assembly did not go back to where we were but did not make any more major changes, discerning how God is calling us into the future. Our commissioners and YAAD will share their experiences with the

presbytery on September 11. I heard expressions of gratitude and energy coming from our commissioners and YAAD from their experience at the General Assembly.

Synod

Bruce Stevens, our Synod Executive, is on sabbatical leave but also still responding to matters on a limited basis. Our Synod, in response to the storms and power outages we encountered, sent this presbytery \$10,000 to assist in the recovery effort. Joan Stewart as WVWAW continue to assist with the recovery effort. We are grateful that we are in a Synod that assists the presbyteries, as well as gratitude toward Joan and WVWAW in response to the storms.

Presbytery

Jeremiah 29:11 plan and transition – Many elements are being discussed on how we effect the various recommendations, approved by presbytery on December 1, 2011. The Transition Team, chaired by George Lilley, has sub groups are meeting, discussing and moving forward, while also stopping to ask important questions of discernment needed. It was noted that as we move forward, certain elements of the plan might need to be tweaked, which may change priorities within our structure, staff and budget. While some feel within the presbytery that the changes from the Jeremiah plan are not what they wish, others say the plan did not introduce more major change!

As I continue to visit churches within the presbytery, I see great evidence of effective mission and vitality, being the people God has called to make a difference in the lives of people. We value relationships, we value a sense of family and we value faith. May God bless us as we continue to discern together what God is calling us to be and to do.

TRUSTEES

INFORMATION

A. As authorized at the June 11 Presbytery meeting, the transfer of land containing a former community center to the trustees of the Clear Creek Presbyterian Church has been completed.

- B. As authorized at the June 11 Presbytery meeting, all of the Presbytery's right, title and interest in and to the real estate of the Melrose and Grace (Lashmeet) Presbyterian Churches has been transferred to the respective trustees of those churches.
- C. As previously authorized by the Moderator, Chair and Acting Stated Clerk, the sale of the property of the former Kopperston Presbyterian Church for \$64,000 has been completed.

TRANSITION TEAM

- 1. Elizabeth Campbell will lead in developing communications for TT and listen/answer pastoral concerns. John Bolt, Nancy Tissue and Forrest Palmer will assist. This group can help with formulating what TT needs to report to the Presbytery now, by whom and in what format?
- 2. Transition Team Sub Committee Updates:
 - a. The Structure Committee recommended a cluster structure with the creation of a ninth Cluster to include churches in Teays Valley and to change the name of the Lewisburg Cluster to Greenbrier Valley Cluster. TT proposed that education about Clusters and building relationships be the focus of the December morning portion of Presbytery. Whether or not Presbytery must approve Clusters remains unanswered.
 - b. Cluster Shepherds The Presbytery Structure Committee with assistance from the Transitional Associate for Congregational Development and Nominating will take the lead in recruiting Cluster Shepherds. TT recognizes that the Jer. 29:11 Plan is not specific on how Shepherds are finally determined.
 - c. Relations (Communication) John Bolt reported that this Sub Committee has developed and sent out a survey to each church inquiring of its communication capabilities and needs. Forty-two congregations responded to the survey but more work needs to be done to broaden the response. A reminder survey will be sent out. The Presbytery may be receiving donated computer hardware in the near future.
 - d. Committees/Affinity Groups With the Budget having been developed, Committees are moving ahead with their merger activities.
- 3. Report from Liaisons to:
 - a. Nominating Additions, corrections and deletions are being made to the current directory as a baseline for new Nominating activity. Nominating Committee was asked to help in the call of the new Leadership Team.
 - b. Personnel and Administration Office Administrator and Bluestone Director positions are in recruitment process. Sharon Rowe noted that

- progress has been slower than projected but has been conducted with utmost care.
- c. Bluestone moving forward with the camping season and with new responsibilities.

APPENDIX A GENERAL ASSEMBLY COMMISSIONER REPORTS

Those of us who served as Commissioners to the 220th General Assembly of the Presbyterian Church, U.S.A. from this Presbytery have been assigned the task of reporting back to all of our fellow WV Presbyterians on this unique and wonderful experience. I have to say it is difficult to even know where to begin. In giving this report, I have chosen not to delve too much into details of the business that was conducted at the Assembly or the specific votes taken and their outcomes. There are myriad reports available on the GA website and other places for any of you who are interested in that kind of information. Instead, I will make some observations about the things I saw and felt and learned as I participated in this momentous event.

First of all, the experience of being in one place with somewhere in the neighborhood of 6,000 other Presbyterians was quite incredible. Although I generally tend to be very shy and reserved when finding myself amid large groups of people I do not know, that was not the case here. Despite the reality of being dropped into a HUGE crowd of total strangers, I had the amazing feeling of being totally comfortable walking right up to and speaking with anyone at any time. Somehow that feeling of all being Presbyterians together overcame any feelings of shyness or anxiety and I found myself starting conversations with complete strangers on a regular basis. In addition, I spoke on the floor in my committee several times and even spoke on the floor at a plenary session of the entire General Assembly once! This ultimate expression of the connectionality we Presbyterians value so greatly was certainly something to behold.

Some of us Commissioners joked on more than one occasion about the various meetings of GA being like Presbytery meetings on steroids. And in truth, there really was a great deal of similarity to our local gatherings of Presbytery, just enacted on a much larger scale. As participants, we learned much about the vagaries of Presbyterian polity and the way we typically do business as a denomination, some of it good and some of it not so good. One of the things I learned is that the Parliamentary Procedure process (based on Roberts Rules of Order), by which we guide our meetings, is really geared toward and/or leads to a very adversarial, rather than a more healthy, trust based, consensus building, approach to decision making. I learned from my work on my assigned committee (Review of Biennial Assemblies) that, if approached with the attitude that we will make the rules work for us rather than us for them (or as one of my fellow committee members humorously put it, "Robert's Rules were made for man, not man for Robert's Rules"), then that effect can be significantly lessened if not entirely eliminated. Unfortunately, I also learned, much to my deep disappointment, that the rules of Parliamentary Procedure can also be manipulated in a way that, while strictly speaking, might be "legal", is not in keeping with the utmost ethical and Christlike behavior that I expected from a group of self-avowed Christians who, presumably, came to this Assembly to represent what is best in our denomination.

As I was paired by staff from the Office of the General Assembly with a roommate unknown to me prior to arrival, another adventure I had was that of living for a week with

a person who had very different views than I did on several key issues up before this Assembly. By being thrown together as "potluck roommates" as my erstwhile roomie put it, we had the opportunity to experience building connections and discussing issues in a positive way with someone who had very different opinions than our own on some very difficult and divisive topics.

All in all, I have to say that I came away from this experience with both great hope and great fear for the future of our denomination. The great hope comes from the excitement of having been in the midst of so many amazing Presbyterians who are doing their best to engage the difficult issues and questions that currently face us in good faith and with a view toward moving forward in greater peace and harmony. The great fear comes from seeing how seriously divided we still are on some very crucial issues and how some people, even supposedly Christian people, will attempt to manipulate the system in ways that are less than Christlike in order to get their own way and to suppress the voices of those with differing views. We can only hope that, with God's help and by listening to His voice, we will find better ways of building trust, embracing diversity, working together, embodying the Holy Spirit, and being Church in the future.

With thanks to you all for the honor and privilege of serving as a Commissioner to the 220th General Assembly, and with a special thanks to my fellow GA Commissioners and YAAD from the Presbytery of WV, and the Presbytery officers, staff, and volunteers who were there to support and encourage us throughout that busy and eventful week.

I was very apprehensive about serving on the, Committee 5 Mid Council Issues and going to the General Assembly. There was much to enjoy, and be proud of that happened during the work of the 220th General Assembly.

He could not try and locate or contact her, the North Koreans would detain him or kill his sister, if they found out who he was, and most likely both.

We think we have it rough until meeting someone that has a story like that. Then we appreciate just what we have in our country.

Yes our denomination has much divisiveness within at this time. My prayers and hopes are that God continues to work on all our hearts and minds and leads us to join together once again reminding us, we live in this world but we are not of this world, by this we should live in love, peace, and harmony.

Yours in Christ Ken Bibbee, Jr. My history with the Evangelical Lutheran Church, a tradition of 58 years, makes the term "connectionalism" a difficult term for me to understand. However, I experienced it vividly and mightily first hand at this 220th General Assembly in Pittsburgh, PA. I will discuss this term further as my report progresses.

From the opening worship service, I was surrounded by thousands of individuals lifting voices and hands in praise to the Almighty. The worship at Fox Chapel Presbyterian Church (my wife's home area) made me feel like a member of the "family". Strong rapport was achieved with members of my committee (Board of Pensions, Board of Publication and Presbyterian Foundation) and that was also like "family". I experienced suppport, encouragement and caring within the Presbyterian Church (USA). I was one of the clan, and appreciated.

I further admired the freedoms granted to individuals to express themselves, even though many others might have already stated a similar opinion. It seemed as though hours went by as speakers stood in long lines before the six microphones to address the assembly. Often prayer was offered which made these repetitions more understandable (and tolerable?). Yet, issues were dealt with in an orderly fashion. Primarily, the vote of the commissioners on major topics was "no". However, there were a few "yeses": 1001 new worshipping communities in the next decade; expansion of college ministry outreach; and a name change from General Assembly Mission Council to Presbyterian Mission Agency.

I was pleased to witness the GA posting cost projections when new ideas for programing were expressed. I believe this was significantly beneficial, as it encouraged the commissioners to think hard and seriously about priorities related to doing the Will of God in the next two years.

A return to "connectionalism" is now appropriate. On Friday, July 6th, I learned that my wife, Rachel, had been hospitalized in New York. Votes on some very important issues had been extremely close, and there were several issues yet to be decided. Should I leave or stay? Three different groups of Presbyterians - one from Settle, WA; one from Washington, PA; and our own group from WV - prayed for both of us, listened compassionately and supportively to my anxiety and concerns, and gave me blessings that sent me on my all-night drive of 500 miles to be with Rachel. The support continued via e-mails, telephone calls, and cards, all expressing hope, love and "connectedness" during this very traumatic time. A lasting and positive impression has been made.

APPENDIX C PROCEDURAL MATTERS MOTION BASICS

- A. Principles of Parliamentary Law
 - Courtesy to all

- One Item at a time

- Majority rule

- Respect the rights of the minority

- Justice for all

- Partiality for none
- Usually pro and con speakers will alternate and individual speaking will identify his or her position.
- No one is allowed to speak more than once on a pending question until all wishing to speak have been heard; a person can then speak a second time, but no more than twice (unless the body gives special permission by two-thirds vote for a third speech).
- B. Relevant Provisions of Presbytery's Manual (Section III of Manual)
 - 1. "No new business shall be introduced after Presbytery recesses for lunch (unless by two-thirds vote Presbytery sets a different deadline for introduction of new business), and any new business not listed on the Docket shall be presented in written form."
 - 2. "...each elder elected an officer, Executive Presbyter, or a member of Council of Presbytery shall be enrolled as a member of the Presbytery for the term of office, whether or not commissioned by his or her session, in accordance with G-3.0306."
 - 3. "The privilege of the floor without vote shall be granted to lay members of Presbytery's committees and to laypersons serving on Presbytery's staff, if not enrolled as members of the Presbytery."
 - 4. "The privilege of the floor without vote shall be granted to professional church educators serving the churches of Presbytery, if not enrolled as members of the Presbytery."

NOTE: The phrase, "privilege of the floor without vote," means that the person has the privilege of speaking on the floor of Presbytery, including debating a motion under consideration, subject to rules and guidelines that govern discussion and debate. However, the person does not have the privilege to make motions or to vote.

Those who have "privilege of the floor without vote" are lay members of committees, lay members of Presbytery staff, church educators, and youth advisory delegates. Those with "voice and vote" privileges are member ministers, elder commissioners, Commissioned Lay Pastors, Executive Presbyter, Stated Clerk, Recording Clerk, Treasurer, Vice-Moderators, Moderator, and Council Members.

- C. Procedural Rules for the meeting of Presbytery (approval by two-thirds vote required to adopt #3).
 - 1. Persons wishing to speak to the Presbytery giving a report, debating a motion, raising questions will do so by using the microphones.
 - 2. Each speaker, after recognition by the Moderator, will give his or her name and church name (or other relationship to the Presbytery if not pastor or elder commissioner from a session).
 - 3. Limitation of Debate 30 minutes per main motion, with each individual limited to 3 minutes per speech.
 - 4. A recommendation from a committee or other entity elected by the Presbytery, upon being presented to Presbytery by an elected member of that entity, is considered to be on the floor for Presbytery's debate, amendment, and disposition without the necessity of a motion placing the recommendation on the floor.

Steps of the Motion

- 1. Commissioner rises and addresses the Moderator.
- 2. *Moderator* recognizes commissioner and grants the floor.
- 3. Commissioner makes motion. (Commissioner may not debate before the motion is seconded.)
- 4. Another commissioner seconds the motion without recognition from the moderator.
- 5. *Moderator* states the motion.
- 6. *Moderator* calls for debate. (Maker of the motion has the privilege of first debate.) All speakers must address the moderator and be recognized by the moderator.
- 7. *Moderator* states the motion.
- 8. *Moderator* takes the vote and announces the vote and the results of the vote.
- 9. *Moderator* states the next order of business.

Seven Useful Motions

- 1. **Amend.** There are *only* three forms of simple amendment.
 - a. To delete or strike out
 - b. To add or insert
 - c. To strike out and insert

The words proposed for deletion or addition *must be consecutive words*. When the amendment does not involve consecutive words or is longer than a paragraph, the motions "to substitute" (a form of amendment) is used. This is a difficult motion and should *never* be used when the simple form of amendment can be used.

- Commit or Refer. To commit or refer back to committee for further study and amendment
 allows the consultative process to be used in greater depth. When this motion is made, it needs to
 state clearly what committee; appointment of the committee, if necessary; the task of the
 committee; and report time.
- 3. **Postpone to a Particular Time.** This motion takes precedence over the preceding two and has the power to grant additional time to a particular member or committee or do further study or consultation. It should always be used in preference to "table" because it permits debate on the propriety of postponement.
- 4. **Limits on Debate.** The assembly always has the power and the moderator the right of suggestion, to limit debate to a particular hour, or extend or shorten speeches according to the necessity of the moment. Limits on the length of speeches are advisable in instances where the issue before the assembly is highly divisive and many members wish to speak.
- 5. **Previous Question.** The maker of the motion "to move the previous question" (close debate and immediately take the vote) must be recognized by the moderator and the motion must receive a second. *It is never in order when called from the floor.* This motion should never be considered when it is used to prevent legitimate debate.
- 6. Lay on the Table. This motion is seldom necessary. The motion "to postpone" is always preferable because of its lower rank and its "debatability". Misuse of the subsidiary motion can be a strategy that seriously abridges the rights of the assembly because of its high rank and its adoption by majority vote without debate. The moderator is obliged to explain carefully to the assembly the implications of this motion should it be made.
- 7. Consideration by Paragraph or Seriatim. Consideration by paragraph or seriatim is an incidental motion that may be suggested by the moderator or any two members of the assembly, allowing for orderly consideration of a complex proposal with several different parts, clarifying for the assembly the controversial aspects of the proposal. Each paragraph of the proposal can be amended without finally adopting the new wording until final action on the main motion is amended.
