# **Presbytery Highlights**

Meeting of the Presbytery of West Virginia May 18, 2017

The Presbytery met at Bridgeport Presbyterian Church, Bridgeport, with **Moderator** Susan Perry presiding. The meeting was opened with prayer by the Moderator. The Presbytery was welcomed by the Rev. Robin Ray, pastor of the church. The highlights of the meeting are shared below.

**<u>Engaged</u>** in a celebration of the 500<sup>th</sup> Anniversary of the Reformation through video, quiz bowl and song.

**Worshipped** with Kim Trisel (Ruling Elder/Certified Associate Christian Educator, First, Fairmont) and Father Benedict Kapa (All Saints Catholic Church, Bridgeport) as liturgists. Teaching Elders Barbara Accord (Davis Memorial, Gassaway) and James Morley (Chaplain, Member at Large) presided at the celebration of the Lord's Supper. The service commemorated the 500<sup>th</sup> Anniversary of the Reformation.

**Received** an offering of \$936 for West Virginia Ministry of Advocacy and Workcamps.

<u>Listened</u> to an announcement from Nellie Howard, **Resource Center Director**, who shared several new resources including *Stepping Stones: A Refugee Family's Journey* and *Who Counts?: 100 Sheep, 10 Coins and 2 Sons.* Ms. Howard encouraged commissioners to visit the Resource Center Display and to visit the center at the Presbytery office.

<u>Approved</u> the Consent Agenda which included such items as approving the requests for excused absences, new Terms of Call for installed pastors, renewal of Temporary Supply covenants and renewal of covenants for Ruling Elders Commissioned to a Particular Pastoral Service, session moderators and an Authorized Lay Preacher to officiate at the Lord's Supper.

<u>Received</u> the report of the **Stated Clerk**, Maureen Wright, who updated presbytery on the work with the Presbyterian Church of the Covenant, Hurricane, session's request to be dismissed to the Evangelical Order of Presbyterians (ECO). The congregation voted to be dismissed. As

approved by presbytery at its meeting in February a team of three (Teaching Elder Jim Robinson, Ruling Elders Betsy Crockett, and Jack Dilley) are working with three people selected by the church to negotiate a recommendation on the property. The negotiators are waiting for an appraisal of the property. Ms. Wright also shared a chart that records the results of the 2016 Statistical Reports and Session Record Reviews.

<u>Heard</u> the report of the **General Presbyter**, Ed Thompson. Rev. Thompson shared the West Virginia Council of Churches' video summarizing the council's listening sessions on substance abuse and encouraged pastoral leaders to attend the council event, Clergy Consultation on Substance Abuse. His report also included joys and concerns from around the Presbytery.

<u>Approved</u> the report of the Administrative Commission to dissolve the McLean Presbyterian Church, Ronceverte. Chair of the commission, Cam Harkness presented the report and called on Ruling Elder, Sam Masters, who shared a brief history of the church.

<u>Approved</u> the report of the Administrative Commission to dissolve the Montgomery Presbyterian Church, Montgomery. Chair of the commission, Doug Jenkins presented the report and directed presbytery to the brief history of the church found in the packet. The report also included highlights of the church's history in pictures.

<u>Aprroved</u> the report of the Administrative Commission to dissolve the First Presbyterian Church, Terra Alta. Chair of the commission, John Bolt presented the report which included highlights of the church's history in pictures. Clerk of Session, Luther "Bud" Parrack and his wife, were recognized.

<u>Recognized</u> the three dissolved churches with a litany of celebration of their Ministry and Witness; the litany was led by **Moderator**, Susan Perry and **General Presbyter**, Ed Thompson.

<u>Listened</u> to **Good News from the Pews** where Ruling Elder Commissioners from churches throughout the presbytery shared good news of mission and ministry.

<u>Heard</u> a verbal report of **Bluestone Committee** from committee member, Parry Johnson (Laity, Riverlawn). The committee is working to develop,

update and implement policies that keep all children and youth at Bluestone safe. Mr. Johnson encouraged presbytery to continue to register campers for the upcoming camp season.

<u>Heard</u> the report of the **Ministry Committee** presented by chair, Cinda Harkless. Presbytery unanimously approved the recommendation of the committee that the Rev. Skip Seibel be called as Pastor and Head of Staff of First Presbyterian Church, Huntington. The recommendation of the committee to restore Sharon Bell as Minister of Word and Sacrament/Teaching Elder was approved following a time of sharing by Ms. Bell. A time of reaffirmation of Rev. Bell's ordination vows was led by Moderator Perry.

<u>Accepted</u> the financial reports presented by **Treasurer**, Rocky Poole. Mr. Poole shared the 2017 top 20 churches by pledge and the 2017 top 20 churches by giving per member.

<u>Listened</u> to the report of the **Mission Committee.** The committee called on the Director of the **West Virginia Ministry of Advocacy and Workcamps**, Joan Stewart, to share the exciting work going on throughout the presbytery. The **Glenville Presbyterian Church** was recognized by Robin Blakeman of the **Stewardship of Creation Ministry Team Affinity Group**, as a Presbyterian Church (U.S.A.) Earth Care Congregation.

The meeting was adjourned with prayer by Moderator Perry.

For Information: Leadership Team; Nurture, Relations and Vocations Committees; and Trustees provided printed reports. Highlights of these reports include: The Leadership Team's request of the Stewardship Committee to develop a budget to be presented to presbytery at its August meeting. The Vocations Committee reported the withdrawal of Inquirer Jessica Lopez. The committee also announced a new Authorized Lay Preacher/Commissioned Ruling Elder training to begin in September 2018. The Trustees granted the request to support First Presbyterian Church, Kingwood's application for a grant from the State Historic Preservation Office.
