

#### ONE HUNDRED TWENTY SIXTH STATED MEETING

#### CALL TO ORDER

The meeting was called to order at 10:00 a.m. by Moderator Joan Stewart

#### **GREETINGS**

Pastor Elise Neal of the First Presbyterian Church greeted and welcomed Presbytery on behalf of the church.

Stated Clerk Maureen Wright welcomed new teaching member, Karen Kinney serving the Glenville Presbyterian Church who signed the Book of Obligations. She also welcomed Mary Ann Collins Stauffer, member of National Capital Presbytery and recommended her seating as a Corresponding Member for this presbytery meeting. This was **approved** unanimously.

The Moderator recognized Ruling Elders attending Presbytery for the first time.

Morning worship and celebration of the Lord's Supper was led by Judy Shaver, Liturgist; John Koerner, Preacher; Julie Sterling and Leonard Hood, Celebrants; John Morrison, Music Director; and Members of the Cambridge Handbell Choir, the Chancel Choir and the Children's Choir.

#### **ANNOUNCEMENTS**

The Worship offering totaled \$894.

Nellie Howard, Director of the Resource Center, provided information on new resources available.

#### **PRESENTATION**

Mission Committee Chair, Todd Wright led Presbytery in expressing its gratitude for the work of Claire Butler who served as the Interim Associate for Mission and whose tenure is ending at the end of the year.

Rev. Wright then introduced the program *Responding to Poverty in our Community* which began with two short skits presented by the committee. He then introduced Lisa Wotring of West Virginia Healthy Kids & Families Coalition who shared her work with presbytery.

#### PRAYER AND HYMN

After a break for lunch, Moderator Stewart reconvened Presbytery with a hymn sing and prayer.

#### **QUORUM**

Stated Clerk Wright stated there was now a quorum present of 38 Teaching Elders and Ruling Elder Commissioners from 30 churches.

Due to the lack of a quorum for voting in the morning session the two motions approved at that time were moved again and passed unanimously.

Doug Kupar was appointed Temporary Clerk in place of Doug Jenkins.

#### **INFORMATION:**

- 1. The minutes of the August 19, 2014 Presbytery meeting have been approved in accordance with the Manual of Presbytery.
- 2. Statement on the balance of Teaching Elders and Ruling Elders in the presbytery. The

Book of Order in G-3.0301 requires that a presbytery address any imbalance that may exist between the number of voting Teaching Elders and the number of voting Ruling Elders. No significant imbalance appears to exist in the Presbytery of West Virginia. As of December 1, 2014 there are 135 congregations entitled to send 138 Ruling Elders to meetings of the presbytery. There are 123 Teaching Elder members of presbytery.

- 3. The Rolls and Registers of Presbytery as of December 1, 2014 are attached (Appendix D, pages 169-170).
- 4. Voting on the proposed amendments to the constitution of the Presbyterian Church (USA) will take place at the February 28, 2015 meeting of presbytery. Churches are strongly encouraged to elect the Ruling Elder Commissioner who will attend this meeting as soon as possible. The amendment booklets will be mailed to churches on January 2, 2015. This mailing will also include other resources for study and preparation. The Nurture Committee is offering several Equipping Disciples events to help Teaching Elders, Ruling Elders and church members study the proposed Confession of Belhar; the details of these events are found on one of the flyers distributed at registration. The presbytery newsletter will also feature resources as we all prepare to discern the guidance of the Holy Spirit. Teaching Elders are reminded of their role in assisting the Ruling Elder Commissioners from their churches to be informed commissioners to this meeting.
- 5. Announced the Trustees approved a request from First Presbyterian Church Morgantown, to provide an easement on their parking lot for fire truck access.
- 6. Announced the appointment of Judge James Rowe to the Presbyterian Church Study Team on Reforming Drug Policy.

#### **INFORMATION:**

- 1. Planning continues for the upcoming events that are sponsored by Nurture.
- 2. Due to the positive feedback from the Play-o-logy event, another day will be scheduled for August 2015.
- 3. Plans are underway for an Equipping Disciples event on the Belhar Confession to be held at the end of January or early February in various locations around the state. Susan Sharp Campbell will adapt the curriculum.

#### Ministry – Mission – Building Relationships

We celebrate and give thanks to God for our 135 congregations, who bring light into the communities in this presbytery! With every church focused on ministry, mission and building relationships (our core value), we truly make a difference within the communities in which our churches reside.

#### Some highlights:

- The West Virginia Institute for Leaders in Ministry began in early September 2014, meeting monthly, with our nine participants learning leadership skills, which will benefit our presbytery. The new initiative grew out of a focus on leadership development, from our Presbytery's Leadership Team.
- Addressing hunger within our communities is a focus of so many of our congregations, through food pantry ministries. The Mission Committee and our Hunger Action Enabler help to resource and support these efforts. Todd Wright serves as the chairperson for the Mission Committee.
- Clusters continue to develop, with Cluster Shepherds volunteering to help build relationships, pastoral care and mission opportunities within closer geographical areas within the presbytery. Susan Sharp Campbell led a training session for Cluster Shepherds on August 29 at First Presbyterian, Charleston. Nancy Tissue brings enthusiasm and energy as the chairperson of the Relations Committee.
- Bluestone hosted weekend groups following the successful 2014 camp season and has re- seeded the "football field," following our first ever successful band camp, which brought new revenue to the Bluestone program. John McKinnon, a former camp director, serves as the chairperson for the Bluestone Committee.
- "Playology" has brought together a diverse group of church leaders and members, incorporating church recreational and creative ideas to strengthen the church life of our congregations. The Nurture Committee develops with, in addition to many other nurturing opportunities. Kari Preslar serves as the Chairperson for the Nurture Committee.
- The Ministry Committee works so hard to bring light into sometimes tough situations, as well as supporting our congregations in times of transitions. The dedicated, faithful members of this committee serve us all, and we thank them all, including the chairperson, Cinda Harkless and lead staff, Craig Butler.
- Our presbytery staff is focused on resourcing and serving our presbytery committees,

churches, pastoral leaders and members. Since the adoption of the Jeremiah 29:11 plan on December 11, 2011, we have had five new staff persons come aboard, with more transition yet to come. Our Administration Committee works hard in these search efforts, ably led by Sharon Rowe.

Ms. Rowe recognized Julie Sterling, chair of the search committee for the Associate for Mission. Rev. Sterling introduced and welcomed Barbara Chalfant to the Presbytery.

#### REPORT OF THE MINISTRY COMMITTEE

The Moderator recognized Peter Vial who reported for the Committee.

#### **RECOMMENDATIONS:**

- 1. **(CA)** Approval of the covenant for Student Pastor **Daniel Geohagan and the Parsons Presbyterian Church** through December 31, 2014. Terms: Cash salary: \$1,000 per month including travel expenses; vacation or other leave negotiated upon request. Responsibilities: Sunday worship; Bible Study; visitation of sick and shut in members; attend Session meetings; youth/community ministry time. Supervisor: Peter Vial.
- 2. (CA) Approval of Temporary Supply Pastor covenant for United Church of Christ Pastor, Rev. Kay Albright, and the Grace Covenant Church, Charleston through December 31, 2015. Terms: Cash salary: \$125 per week; \$50 travel allowance per month; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays); any additional Sundays as requested. Responsibilities: Sunday worship; Special services: Ash Wednesday, Maundy Thursday, and Christmas Eve; provide emergency pastoral care and visitation.
- 3. (CA) Approval of the covenant as Ruling Elder commissioned to a Particular Pastoral Service of Interim Ministry for James Musgrave and First Presbyterian Church, Logan through December 31, 2014. Terms: Cash salary: \$618 per month; housing: \$1236 per month; auto expense reimbursement at IRS rate, vacation: one week for the three month period. Mentor: Vaughan Smith.
- 4. (CA) Approval of the covenant as Ruling Elder commissioned to a Particular Pastoral Service for John Yeager and the Eleanor Presbyterian Church from January 1 to December 31, 2015. Terms: Cash salary: \$300 per month; housing \$700 per month; auto reimbursement at IRS rate; vacation 5 weeks (including Sundays); continuing education 2 weeks (including Sundays). Responsibilities: preach 45 Sundays per year; teach Sunday school; moderate session; lead Lenten studies as requested; visitation; home and hospital visits as needed; administer the sacraments; officiate at weddings where permitted by state law; lead funeral services; participate in the life of the church and presbytery; have voice and vote in meetings of presbytery (counted as an elder commissioner for purposes of parity). Mentor: John Holland.
- 5. (CA) The renewal of the covenant as Ruling Elder commissioned to a Particular Pastoral Service for **Jeff Barton and Trinity Presbyterian Church** through December 31, 2015, be approved. Terms: 18 hours/week; 26 Sundays and Christmas Eve; \$300 per week; \$7800 year; auto expense reimbursement at IRS rate; out of pocket expense if requested by Session; vacation 1 week for every 13 Sundays served; can accumulate up to 2 weeks; continuing education: only with Session pre approval. Responsibilities: On 26 Sunday mornings in 2015, generally every other Sunday, conduct an adult Bible study and worship service. Lead Christmas Eve service. Prepare the bulletin for worship services. Administer the Lord's Supper; administer the Sacrament of Baptism; moderate the Session of

- the congregation to which he is commissioned; officiate at marriages where permitted by statelaw; have a voice and vote in meetings of the presbytery (counted as an elder commissioner for purposes of parity). Mentor: David Lee.
- 6. (CA) The renewal of the covenant as Ruling Elder commissioned to a Particular Pastoral Service for William F. Brown and Ruffner Memorial Presbyterian Church through December 31, 2015, be approved. Terms: \$15,833 per year pro-rated in 24 payments; housing: \$6000 fair rental; \$500 manse equity allowance; utilities \$1600; SECA offset: \$1940; auto expense reimbursement at IRS rate (\$0.555) up to \$2359; Medical dues: \$8400; Pension dues: \$2720 vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays), \$1000. Responsibilities: Sunday worship with monthly communion. Attend presbytery meetings. Provide supervision of staff, per agreement with Senior Services Employment Program. Within the Session Committee structure assist with programs and activities will increase the church's witness to the surrounding community and thereby encourage disciples of all ages to be part of the church. Administer the Lord's Supper; administer the Sacrament of Baptism; moderate the Session of the congregation to which he is commissioned; officiate at marriages where permitted by state law; have a voice and vote in meetings of the presbytery (counted as an elder commissioner for purposes of parity). Mentor: David Lee.
- 7. **(CA)** The renewal of the covenant as Ruling Elder commissioned to a Particular Pastoral Service for **William F. Brown and South Park Presbyterian Church** through December 31, 2015 be approved. Terms: As needed; estimated at 3 hours a month; \$125 per month. Responsibilities: Administer the Lord's Supper; administer the Sacrament of Baptism; moderate the Session of the congregation to which he is commissioned; officiate at marriages where permitted by state law; have a voice and vote in meetings of the presbytery (counted as an elder commissioner for purposes of parity); lead worship the first Sunday of every month. Mentor: David Lee.
- 8. (CA) The renewal of the covenant as Ruling Elder commissioned to a Particular Pastoral Service for Nancy Bulla and Union Presbyterian Church through December 31, 2015, be approved. Terms: 20 hours/week; \$21,800/year; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays). Responsibilities: Lead worship each Sunday and on Christmas Eve. Visit members, lead Bible study, lead outreach evangelism, and attend presbytery meetings. Administer the Lord's Supper; administer the Sacrament of Baptism; moderate the Session of the congregation to which she is commissioned; officiate at marriages where permitted by state law; have a voice and vote in meetings of the presbytery (counted as an elder commissioner for purposes of parity). Mentor: Doug Heidt.
- 9. **(CA)** The renewal of the covenant as Ruling Elder commissioned to a Particular Pastoral Service for **Preston "Pat" Collier and First Presbyterian Church, Kenova**, through December 31, 2015, be approved. Terms: 15 hours/week, including Sunday mornings and special services; \$1200 per month; auto expense reimbursement at IRS rate optional; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays), \$400. Responsibilities: Sunday worship and special services, co-lead Bible study, visit sick and shut-ins. Attend presbytery meetings; remain under care of presbytery. Administer the Lord's Supper; administer the Sacrament of Baptism; moderate the Session of the congregation to which he is commissioned; officiate at marriages where permitted by state

- law; have a voice and vote in meetings of the presbytery (counted as an elder commissioner for purposes of parity). Mentor: Jean Sutton.
- 10. (CA) The renewal of the covenant as Ruling Elder commissioned to a Particular Pastoral Service for Roger Eskins and Comfort Presbyterian Church through December 31, 2015, be approved. Terms: 20-30 hours/week; \$800 per month; auto expense reimbursement at IRS rate up to \$400/month; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays), \$500/year. Responsibilities: Sunday worship, weekly Bible study, hospital and home visitation, choir leader, funerals as requested. Administer the Lord's Supper; administer the Sacrament of Baptism; moderate the Session of the congregation to which he is commissioned; officiate at marriages where permitted by state law; have a voice and vote in meetings of the presbytery (counted as an elder commissioner for purposes of parity). Mentor: Ron Buckalew.

#### **RECOMMENDATIONS:**

- 1. The following are proposed changes to the Presbytery Manual. They were presented at the August 19 Presbytery meeting as a first reading. Changes are shown in italics.
  - a. In section III Responsibilities, powers and meetings of Presbytery, Membership, paragraph 3:

"The privilege of the floor without vote shall be granted to certified church educators and other certified church workers serving churches of Presbytery, if not enrolled as members of the Presbytery..." (G-2.1102)

Explanation: Church business administrators and church musicians may be certified through their respective Presbyterian professional organizations. The *Book of Order* allows them privilege of the floor if approved by Presbytery.

Randy Fife moved that Item 1a be approved. Motion was approved.

b. Insert a new paragraph 2 in the same section:

Churches with memberships of 1 to 500 may send one ruling elder commissioner to meetings of Presbytery. Churches with memberships of 501 to 1,000 may send two ruling elder commissioners. Churches with memberships of 1,001 to 1,500 may send three ruling elder commissioners.

Explanation: The current *Book of Order* no longer states the number of ruling elder commissioners churches are to send to meetings of Presbytery, leaving that decision to each Presbytery. Motion was **approved**.

2. The Leadership Team has the responsibility of nominating persons to the Presbytery Nominating Committee. We nominate the following:

- 1. Approved the celebration of the Lord's Supper at the annual Ministry Committee retreat in January, 2015 at Blessed John XXIII Pastoral Center, Charleston.
- 2. In September, the Leadership Team met in special session to review the progress of the Presbytery in transitioning to the Jeremiah 29:11 Plan. This was shared with presbytery.

One concern that the LT discussed at length is the loss of the former congregational development committee. This responsibility was assigned to the Ministry Committee, but the Ministry Committee has such a full workload that it cannot address congregational development. We also feel the deep loss of the work of the former Quadrant Presbyters and the relationships they had with the churches in their charge. They were valuable resources to the congregations. The LT has formed an *ad hoc* group to explore the possibility of forming staff positions for Regional Presbyters who would serve much as the Quadrant Presbyters did. This group is being formed with representation from Ministry Committee, Administration Committee, Relations Committee and Stewardship Committee.

3. An *ad hoc* committee of John Holland, George Lilley and Pam Ferrell, along with Rocky Poole and Forrest Palmer, was formed and is charged with determining criteria for distributing Synod funds to help churches with added Board of Pensions expenses in 2015.

## APPENDIX E PROCEDURAL MATTERS

A. Principles of Parliamentary Law

- Courtesy to all

- Majority rule

- Justice for all

- One Item at a time

- Respect the rights of the minority

- Partiality for none

- Usually pro and con speakers will alternate and individual speaking will identify his or her position.
- No one is allowed to speak more than once on a pending question until all wishing to speak have been heard; a person can then speak a second time, but no more than twice (unless the body gives special permission by two-thirds vote for a third speech).
- B. Relevant Provisions of Presbytery's Manual (Section III of Manual)
  - 1. "No new business shall be introduced after Presbytery recesses for lunch (unless by two-thirds vote Presbytery sets a different deadline for introduction of new business), and any new business not listed on the docket shall be presented in written form."
  - 2. "...each elder elected an officer, General Presbyter, or a member of Leadership Team shall be enrolled as a member of the Presbytery for the term of office, whether or not commissioned by his or her session."
  - 3. "The privilege of the floor without vote shall be granted to lay members of Presbytery's committees and to laypersons serving on Presbytery's staff, if not enrolled as members of the Presbytery."
  - 4. "The privilege of the floor without vote shall be granted to certified church educators serving the churches of Presbytery, if not enrolled as members of the Presbytery. Certified church educators who are ruling elders and serving churches of Presbytery shall have voice and vote privileges. (G-2.1103b)"

<u>N</u>OTE: The phrase, "privilege of the floor without vote," means that the person has the privilege of speaking on the floor of Presbytery, including debating a motion under consideration, subject to rules and guidelines that govern discussion and debate. However, the person does not have the privilege to make motions or to vote.

Those who have "privilege of the floor without vote" are lay members of committees, lay members of Presbytery staff, church educators, and youth advisory delegates. Those with "voice and vote" privileges are member Teaching Elders, Ruling Elder commissioners, Certified Christian Educators\*, Commissioned Ruling Elders, General Presbyter, Stated Clerk, Recording Clerk, Treasurer, Moderator, Members of Leadership Team and Presbytery Committee chairs.

- C. Procedural Rules for the meeting of Presbytery (approval by two-thirds vote required to adopt #3).
  - 1. Persons wishing to speak to the Presbytery giving a report, debating a motion, raising questions will do so by using the microphones.
  - 2. Each speaker, after recognition by the Moderator, will give his or her name and church name (or other relationship to the Presbytery if not pastor or elder commissioner from a session).
  - 3. Limitation of Debate 30 minutes per main motion, with each individual limited to 3 minutes per speech.
  - 4. A recommendation from a committee or other entity elected by the Presbytery, upon being presented to Presbytery by an elected member of that entity, is considered to be on the floor for Presbytery's debate, amendment, and disposition without the necessity of a motion placing the recommendation on the floor.

## APPENDIX F ASSOCIATE PRESBYTER FOR MISSION JOB DESCRIPTION

The Associate Presbyter for Mission will work for the Presbytery of West Virginia in the areas of Older Adult Ministries, Hunger Action and Social Justice. He or she will work as an advocate, pastor and educator, assisting in the mission needs of the Presbytery, as well as mission issues supported by the PCUSA. This position will be divided as follows: ½ time Older Adult Ministry, ¼ time Hunger Action, ¼ time Social Justice. It is understood that this is a rough estimate and that time may vary based on the needs of the WV Presbytery.

**ACCOUNTABILITY:** He/she shall be accountable to the Presbytery of West Virginia and will be

supervised by the General Presbyter.

**RELATIONSHIPS:** The Associate Presbyter for Mission will relate directly to the

Mission Committee.

**COMPENSATION:** Specified in the letter of appointment and reviewed annually by

the Administration Committee.

**EVALUATION:** An annual performance review and evaluation by the

Administration Committee.

**TERMINATION:** By mutual consent of the Associate Presbyter for Mission and the

Presbytery, or by action of Presbytery, upon written recommendation of

the Administration Committee (G-3.0110). Fair and adequate notification shall be given to the Associate for Mission and to the

Presbytery.

#### PERSON DESCRIPTION

The Associate Presbyter for Mission should have these qualifications, characteristics, and abilities:

- 1. A personal commitment to and relationship with God.
- 2. A strong biblical grounding in the Christian faith.
- 3. Membership in Presbyterian Church (USA) and an appreciation for the beliefs and faith commitments of others. Preference will go to Teaching or Ruling Elders within the PCUSA.
- 4. Demonstrated skills and experience in communicating with groups and individuals.
- 5. Ability to respond appropriately and constructively to conflict and to promote understanding and reconciliation.
- 6. Knowledge of governmental, church-related and independent resources available to older adults and their caregivers, hunger action initiatives and social justice programing.
- 7. The ability to find and maintain a balance between the various aspects of this position and its multiple relationships.
- 8. The ability to travel within West Virginia.

#### MINISTRY WITH OLDER ADULTS

**1/2 TIME** 

**PURPOSE:** The Associate Presbyter for Ministry with Older Adults shall encourage and support ministry with older adults within the Presbytery of West Virginia. One major aspect of this ministry will be working with congregations to assist in the development of appropriate responses

to older adult needs and opportunities. A second major aspect will be as resource person for program development to meet the needs of residents of facilities under contract to Presbyterian Housing Foundation of West Virginia, Inc., and to provide support to resident managers and social service coordinators employed by Presbyterian Housing Foundation of West Virginia, Inc.

#### RESPONSIBILITIES

- A. To develop and provide seminars that will meet the needs of residents of facilities under contract to Presbyterian Housing Foundation of West Virginia, Inc. Subject areas may include, but not be limited to, health, insurance, finance and law.
- B. To acquire and share knowledge of social and financial resources available to older adults through governmental and church related entities.
- C. To assist in the provision of pastoral care for residents of facilities under contract to Presbyterian Housing Foundation of West Virginia, Inc., using both Presbyterian and ecumenical resources.
- D. To offer supportive counsel to resident managers and social service coordinators employed by Presbyterian Housing Foundation of West Virginia, Inc., as they seek to deal with problems and frustration in their work.
- E. To serve as a communication link between Presbyterian Housing Foundation of West Virginia, Inc., residents, and resident directors as needs and issues require.
- F. To be an advocate for ministry with older adults in the Presbytery of West Virginia
- G. To consult with local congregations and assist them in designing ministries with and for older adults.
- H. To be a resource in the training of local church leaders in appropriate responses to the needs and opportunities of older adults.
- I. To develop and provide seminars that will meet the needs of congregations.
- J. To assist ministers with members of their congregation who are in crisis situations.

#### **RELATIONSHIPS:**

The Associate Presbyter for Ministries with Older Adults will work closely with the resident managers and social services coordinators, and in consultation with the General Presbyter and other Presbytery staff. He/she will work collaboratively with the Mission Committee. It is anticipated that 60% of the person's time will be used in response to Presbytery-related needs and 40% will be used in response to West Virginia Management-related needs.

## ASSOCIATE FOR PRESBYTER FOR MISSION - HUNGER ACTION ENABLER 1/4 TIME

#### **PURPOSE:**

The Associate Presbyter for Mission, Hunger Action Enabler, shall interpret and implement within the Presbytery of West Virginia the denomination's hunger action program at the local, regional and national level with emphasis on these five aspects: direct food relief, development assistance, education and interpretation, public policy, and lifestyle integrity.

#### **RESPONSIBILITIES:**

- A. Be a spokesperson for Hunger Action within the Presbytery through:
  - 1. Cents-Ability assistance to congregations in the adoption and promotion, general promotion within the Presbytery, implementation of adopted uses of the funds.
  - 2. Resourcing and training establish resource files, disseminate relevant

- information, develop and train a Hunger Network, provide education and training to local congregations.
- 3. Project Development assist in local congregations/agencies, seek areas of need, work with established projects.
- 4. Resource and report to the Hunger Action Ministry Team regularly and to the Mission Committee and/or Presbytery as requested.
- B. Serve as a link between the Presbytery and other governing bodies and agencies in the areas related to Hunger Action.
- C. Serve as staff resource for the Self-Development of People Committee.

## ASSOCIATE PRESBYTER FOR MISSION - SOCIAL JUSTICE MINISTRY 1/4 TIME

**PURPOSE:** 

The Associate Presbyter for Mission, Social Justice, shall interpret and implement within the Presbytery of West Virginia the denomination's Social Justice Ministry focuses at the local, regional and national level. He or She will support and assist in developing the Social Justice ministries within the congregations of the WV Presbytery and educate the Presbytery on social justice issues embraced by the denomination.

#### **RESPONSIBILITIES:**

- B. Be a spokesperson for Social Justice Ministry within the Presbytery through:
  - 1. Maintaining the Mission database featuring mission opportunities within the WV Presbytery.
  - 2. Resourcing and training establish resource files, disseminate relevant information to provide education and training to local congregations.
  - 3. Project Development assist in local congregations/agencies, seek areas of need, work with established projects.
  - 4. Emergency/ Disaster Assistance-work with the denomination in emergency situations to assist congregations within the Presbytery.
  - 5. International partnerships-assist with the education, development and promotion of the Presbytery's international partnerships within the Presbytery. He or She will also be actively involved in mission trips to partnering Presbyteries.
  - 6. Resource and report to the Mission Committee regularly and/or Presbytery as requested.
- C. Serve as a link between the Presbytery and other governing bodies and agencies in the areas related to Social Justice Ministry. This will include working as a resource in connection to the PCUSA's National Office in Washington D.C and the United Nations.
- D. Work in connection with the WV Council of Churches and with the General Presbyter who is the Presbytery's Board representative.
