# How Can I Participate?

Having fulfilled your financial obligations at your church home, you may want to consider a special "above and beyond" gift to the Presbytery of West Virginia. For example, an outright designated gift, assignment of an insurance policy, a bequest in your will, or a special gift arrangement.

#### Insurance

An existing or a new insurance policy may designate the Presbytery of West Virginia as beneficiary or receiver of proceeds.

#### Bequest in your Will

"I give and bequeath to the Presbytery of West Virginia Mission Funds the sum of \$\_\_\_\_\_\_ (or 'the remainder of my estate' or 'the securities or other property described herein, namely, \_\_\_\_\_\_'), for the Presbytery of West Virginia Mission Fund (or you may name your own fund) of the Presbytery of West Virginia."

### Tax Advantages of Gifts to the Mission Funds

- Gifts to the church are fully tax deductible, as permitted by law.
- When you give appreciated assets, you may not be required to pay taxes on the capital gain.
- For estate tax purposes, your net taxable estate will be reduced by the amount of your gift.

#### Oversight of Bequest and Restricted Funds is the Responsibility of the Presbytery's Investment Sub-Committee
