CALL TO ORDER

The meeting was called to order with prayer at 10:00 a.m. by Moderator Susan Perry.

GREETINGS FROM FIRST PRESBYTERIAN CHURCH

Doug Jenkins, Interim Associate Pastor of First Presbyterian Church, Charleston, greeted and extended a warm welcome to the Presbytery on behalf of the members and Session.

EDUCATIONAL FOCUS

The Moderator called on the Stated Clerk, who introduced the time of education on the proposed amendments. Commissioners and visitors were divided into assigned small groups with facilitators who led them in discussion about each of the proposed amendments to the Constitution of the Presbyterian Church (USA). At the conclusion of the small group time commissioners and visitors were invited to observe the wide variety of Mission displays in the Mission Fair.

MORNING WORSHIP

Morning worship was led by Patricia Jarvis, Temporary Supply Pastor at First Presbyterian Church, Dunbar, Liturgist; Karen Kinney, Teaching Elder, Glenville Presbyterian Church, Preacher; Patterson Lyles, Teaching Elder, Kanawha United Presbyterian Church and Cherrie Sizemore, Commissioned Ruling Elder, Elk Hills Presbyterian Church, Communion Celebrants; and Mary Odin, Music Staff, First Presbyterian Church, Charleston, Music Leader.

ANNOUNCEMENTS

Nellie Howard, Resource Center Director, shared information about new resources and invited commissioners to visit the Resource Center's display.

INTRODUCTIONS AND SEATING OF CORRESPONDING MEMBERS

Ruling Elder Commissioners attending presbytery for the first time were introduced. There were no new corresponding members or visiting teaching elders present.

STATEMENT OF QUORUM

Stated Clerk Wright stated there was a quorum present of 44 teaching elders and ruling elder commissioners from 28 churches. (Attendance record in Appendix A, pages 25-31.)

ELECTION OF A RECORDING CLERK PRO TEM

The Stated Clerk explained the significance of the color of one's nametag; commissioners with voice and vote are identified by bright green nametags. Stated Clerk Wright then moved that George Lilley be elected Recording Clerk Pro Tem for this meeting. The motion was seconded and **passed**.

DOCKET

The Moderator presented the docket and received a motion and second on its adoption. The Presbytery **adopted** the docket. (Appendix B, page 32-33.)

MODERATORIAL APPOINTMENTS

Moderator Perry appointed Nancy Bulla, Commissioned Ruling Elder (CRE), Union Presbyterian Church; Mandy Lester, Ruling Elder (RE), Gilbert Presbyterian Church; David Richards, Teaching Elder (TE), Second Presbyterian Church, Huntington; Mike Seely, TE, First Presbyterian Church, Parkersburg; John Yeager, CRE, Eleanor Presbyterian Church as Temporary Clerks

She appointed the Leadership Team members present as the Committee on Bills and Overtures.

PRAYER AND HYMN

Following lunch, the Moderator recognized members of the Nurture Committee who led the Presbytery in a service of remembrance of elders deceased between January 1 and December 31, 2016. (Necrology, Appendix C, pages 34-37.)

REPORT OF THE STATED CLERK

The Moderator recognized Stated Clerk Wright who moved that presbytery grant authority for Moderator Perry; General Presbyter, Ed Thompson; Ministry Committee Chair, Cinda Harkless; and the Stated Clerk to appoint three persons to negotiate the property issues of **Presbyterian Church of the Covenant** on behalf of the presbytery. (Related to Ministry Report, Information, 14) The motion was seconded and the following rationale was provided:

The Presbytery of West Virginia Policy for Dismissal of Congregations Seeking Dismissal to Another Reformed Body states that "All financial property issues (fiscal and physical) and ongoing mission support issues must be negotiated with Presbytery prior to a vote by Presbytery on dismissal. In the event of a sufficient congregational vote for dismissal, the Presbytery and the session will each authorize particular persons (three from each body) to serve as a negotiating team." The policy does not designate the committee or persons with authority to appoint Presbytery's representatives for property negotiations.

The Ministry Committee's report of Items for Presbytery's Information, notifies presbytery that it has received a request from the **Presbyterian Church of the Covenant**, Hurricane, to be dismissed to the Covenant Order of Evangelical Presbyterians. In accordance with the policy the committee has appointed a special committee to meet with the congregation. (See page 17, item 14.) The special committee has begun its work. The approval of this motion would allow for the dismissal process to continue without delay following a congregational vote for dismissal. A final recommendation regarding dismissal will be presented to presbytery for vote.

The motion was adopted.

The Stated Clerk presented the following report.

INFORMATION:

- 1. The proposed amendments to the Constitution of the Presbyterian Church (U.S.A.) sent to the presbyteries by the 222nd General Assembly will be presented for consideration, debate and voting at this meeting. In past years a printed booklet of amendments was available to all commissioners. However the Office of the General Assembly has chosen to be good stewards of available resources and per capita dollars so printed booklets are not available. The booklet has been prepared and is posted electronically; the link to the booklet may be found at: pcusa.org/amend/. Commissioners are responsible for printing their own booklets.
- 2. The Presbytery of West Virginia approved the sale of the manse of Presbyterian Church of Our Savior in accordance with the Manual of Presbytery with a meeting of the Chair of Trustees; James Rowe; 2016 Moderator, Peter Vial; 2016 Leadership Team Chair, Randy Fife; and the Stated Clerk. This action was taken on August 26, 2016.
- 3. The minutes of the November 17, 2016 Presbytery meeting have been approved in accordance with the Manual of Presbytery.

PROCEDURAL MATTERS

The Stated Clerk presented Procedural Matters and moved the adoption of Item C3, limiting debate to 30 minutes per main motion, with each individual limited to 3 minutes per speech. After receiving a second, Presbytery **adopted** the motion by a two-thirds vote. (Appendix E, page 39.)

VOTE ON AMENDMENTS

Moderator Perry recognized the Stated Clerk who explained the process for voting on the Amendments to the Constitution. A motion was made regarding 16c 1-8 that all eight be voted on together after the body's consideration of all. The motion was seconded and **passed.**

REPORT OF THE GENERAL PRESBYTER

The Moderator recognized the General Presbyter, Ed Thompson. He gave thanks to First Presbyterian Church, Charleston, for their hospitality, the Mission Committee for the Mission Fair and to everyone for being present. After reviewing two years of attendance, 44 churches have not sent anyone to a Presbytery meeting; this is a concern. Five churches had ruling elder members at all meetings: Bream Memorial; Edgewood; First Presbyterian Church, Clarksburg; Village Chapel; and First Presbyterian Church, Williamstown. He also reviewed financial contributions, concluding that we do have work to do to strengthen relationships and communication. Amy Robinson, the new Director of Communications and Office Administrator, will enhance communication. Becoming "paper less" is an objective for the Presbytery. Paper communications will continue to be provided for those making requests.

REPORT OF THE VOCATIONS COMMITTEE

The Moderator recognized Kevin Starcher, Chair of the Vocations Committee, to present the report of the Vocations Committee.

who welcomed Elizabeth Stone to give a brief autobiographical statement and then be examined.

RECOMMENDATION:

1. That the Presbytery proceed to examine Elizabeth Stone a candidate from the Presbytery of West Virginia seeking ordination to serve the Bradley Presbyterian Church, Bradley.

The Committee reviewed a sermon, statement of faith, exegetical work and biography of Ms. Elizabeth Stone. Noting that she has fulfilled all the requirements set forth in G-2.0607 regarding preparation for ministry, the committee conducted a thorough examination of her readiness for ordination. Ms. Stone's autobiographical statement and Statement of Faith are included in the packet. (Appendix F, pages 40-41.)

Rev. Starcher called on Ms. Elizabeth Stone, Candidate for Ordination, to stand before the Presbytery for examination. Ms. Stone has been called to serve the Bradley Presbyterian Church. Ms. Stone introduced herself and gave a statement of faith and described her sense of call to the ministry. Rev. Starcher then asked Ms. Stone questions addressing polity, worship and sacraments, theology and Christian faith, to which she responded. Moderator Perry invited the body to ask questions of the candidate.

A motion was made that Ms. Stone's examination be sustained. Ms. Stone was excused while the motion was considered. The motion was adopted unanimously. Ms. Stone returned to the

room whereupon she was welcomed by the Presbytery.

- 10. (CA) Recommend approval of the Stated Supply covenant between Elizabeth Stone and Bradley Presbyterian Church, Bradly. Terms: 10 hours per week; salary \$1,253 per month, housing allowance \$300; auto reimbursement at the IRS rate; vacation: 4 weeks (including Sundays); continuing education: 2 weeks (including Sundays), \$41 per month. Responsibilities: Sunday worship and special services; serve communion quarterly, for special services, and in homes of members as needed; visit shut ins, hospitals, nursing homes and prospective members as needed; funerals and weddings as requested; baptisms; other responsibilities at the discretion of the pastor. The Session will maintain its individual and corporate duties in the government and discipline of the congregation and oversight of the church's spiritual interests.
- 11. (CA) Recommend approval of the renewal of the covenant as Ruling Elder commissioned to a Particular Pastoral Service for **Jeff Barton and Trinity Presbyterian Church** through December 31, 2017. Terms: 18 hours/bi-weekly; 26 Sundays and up to six special services; cash salary \$300 per week, \$7,800 year; auto expense reimbursement at IRS rate; out-of-pocket expense if requested to the Session; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays). Responsibilities: On 26 Sunday mornings in 2017, coordinated with the worship committee chair, conduct worship service. Prepare the bulletin for worship services. Administer the Lord's Supper; administer the Sacrament of Baptism; moderate the Session of the congregation to which he is commissioned; officiate at marriages where permitted by state law; have a voice and vote in meetings of the presbytery, (counted as an elder commissioner for purposes of parity). Mentor: David Lee.
- 12. (CA) Recommend approval of the renewal of the covenant as Ruling Elder commissioned to a Particular Pastoral Service for William F. Brown and South Park Presbyterian Church through December 31, 2017. Terms: As needed; estimated at three hours a month; cash salary \$125 per month. Responsibilities: Conduct worship service on the first Sunday of each month to administer the Lord's Supper; administer the Sacrament of Baptism; officiate at marriages where permitted by state law; provide pastoral care only when lay supply pastor and ruling elders are not available; pray for the church; have a

- voice and vote in meetings of the presbytery, (counted as an elder commissioner for purposes of parity). Mentor: David Lee.
- 13. (CA) Recommend approval of the renewal of the covenant as Ruling Elder commissioned to a Particular Pastoral Service for Nancy Bulla and Union Presbyterian Church through December 31, 2017. Terms: 20 hours/week; cash salary \$1,817/month; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays). Responsibilities: lead worship and preach 4/5 times per month and on Christmas Eve and Maundy Thursday; officiate at funerals. Visit members, lead Bible study, lead outreach evangelism, and attend presbytery meetings. Administer the Lord's Supper; administer the Sacrament of Baptism; moderate the Session of the congregation to which she is commissioned; officiate at marriages where permitted by state law; have a voice and vote in meetings of the presbytery, (counted as an elder commissioner for purposes of parity). Mentor: Doug Heidt.
- 14. (CA) Recommend approval of the renewal of the covenant as Ruling Elder commissioned to a Particular Pastoral Service for William Dunfee and Westminster Presbyterian Church, Vienna through December 31, 2017. Terms: 25 hours/week; cash salary \$60,295/year; auto expense reimbursement at IRS rate; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays); reimbursement of preparation/study materials and continuing education. Responsibilities: Sunday worship and special services; visitation; community events; funerals. Administer the Lord's Supper; administer the Sacrament of Baptism; moderate the Session of the congregation to which he is commissioned; officiate at marriages where permitted by state law; have a voice and vote in meetings of the presbytery, (counted as an elder commissioner for purposes of parity). Mentor: Ken Calebaugh.
- 15. (CA) Recommend approval of the renewal of the covenant as Ruling Elder commissioned to a Particular Pastoral Service for Roger Eskins and Comfort Presbyterian Church through December 31, 2017. Terms: 20 to 30 hours/week; cash salary \$800/month including auto expense reimbursement at IRS rate \$400/month; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays), \$500. Responsibilities: Sunday worship, hospital and home visitation, choir leader, funerals as requested, weekly Bible study. Administer the Lord's Supper; administer the Sacrament of Baptism; moderate the Session of the congregation to which he is commissioned; officiate at marriages where permitted by state law; have a voice and vote in meetings of the presbytery (counted as an elder commissioner for purposes of parity). Mentor: Ron Buckalew.

Responsibilities: Worship including Sundays, Maundy Thursday, Ash Wednesday, Christmas Eve. Visit shut-ins, potential members, and

members in times of crisis. Provide a monthly report to the session on visits and recommendations. Provide Bible School classes within weekly time expectation and play active role in Vacation Bible School. Take active role in planning and executing congregational developmental activities. Participate in and report on the Fayette County Ministerial meetings. Assist the Session as Bible study leader on Monday mornings and keep office hours on Wednesday mornings. Administer the Lord's Supper; administer the Sacrament of Baptism; moderate the Session of the congregation to which she is commissioned; officiate at marriages where permitted by state law; have a voice and vote in meetings of the presbytery (counted as an elder commissioner for purposes of parity).

- 17. (CA) Recommend approval of the renewal of the covenant as Ruling Elder commissioned to a Particular Pastoral Service for Interim Ministry James Musgrave and First Presbyterian Church of Logan through December 31, 2017. Terms: 20 hours/week (usually Sunday-Tuesday); \$2083.34 per month, of which \$1,236 is for housing allowance; auto expense reimbursement at IRS rate; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays). Responsibilities: Sunday worship and other services approved by session. Visit shut-ins, potential members, and members in times of crisis. Lead funeral services; administer the Lord's Supper; administer the Sacrament of Baptism; moderate the Session of the congregation to which he is commissioned; officiate at marriages where permitted by state law; have a voice and vote in meetings of the presbytery (counted as an elder commissioner for purposes of parity). Mentor: Cinda Harkless.
- 18. (CA) Recommend approval of the renewal of the covenant as Ruling Elder commissioned to a Particular Pastoral Service for **David Pettry and First Presbyterian Church of Colcord** through December 31, 2017. Terms: 12 hours per week; \$100 per week; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays). Responsibilities: lead worship two Sundays per month, rotate the fifth Sundays; visitation; funerals; administer the Lord's Supper; administer the Sacrament of Baptism; moderate the Session of the congregation to which he is commissioned; officiate at marriages where permitted by state law; have a voice and vote in meetings of the presbytery (counted as an elder commissioner for purposes of parity).
- 19. (CA) Recommend approval of the renewal of the covenant as Ruling Elder commissioned to a Particular Pastoral Service for **Kari Preslar and Falls View Presbyterian Church** through December 31, 2017. Terms: Time flexible; \$565 per month; auto expense reimbursement at IRS rate; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays), \$200. Responsibilities: Worship on Sunday and at special seasons. Visit sick members in Charleston when possible; Bible study upon request; administer the Lord's Supper; administer the Sacrament of Baptism; moderate the Session of the congregation to which she is commissioned; officiate at marriages where permitted by state law; and have a voice and vote in meetings of the presbytery (counted as an elder commissioner for purposes of parity). Mentor: Todd Wright.
- 20. (CA) Recommend approval of the renewal of the covenant as Ruling Elder commissioned to a Particular Pastoral Service for Robert Lynn Randolph and Spring Creek

Presbyterian Church through December 31, 2017. Terms: 20 hours per week; \$1,320 per month; auto expense reimbursement at IRS rate; match Social Security withheld and pay half the cost of educational materials; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays). Responsibilities: Sunday worship, special services; Bible study; home and hospital visits; organize revivals; correspond with missionary, including Christmas boxes for children in other countries; pray for the church, ruling elders and congregation. Administer the Lord's Supper; administer the Sacrament of Baptism; moderate the Session of the congregation to which he is commissioned; officiate at marriages where permitted by state law; have a voice and vote in meetings of the presbytery (counted as an elder commissioner for purposes of parity). Mentor: Andrew Rice.

Terms: 30 hours per week: \$2,400/month; Social Security withheld; auto expense reimbursement at IRS rate; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays), \$250. Responsibilities: provide staff and administrative support; worship planning, pulpit supply at least twice/month; provide sacraments, weddings, funerals, visitation. Assist the session in developing monthly agendas, participate on committees, provide organizational and communication support to Session and Diaconate; assist with Food & Friends; lead adult Bible study; periodically teach adult Sunday school; confirmation class. Responsibilities: Worship at 9:30 a.m. each Sunday; visit shut-ins, hospitals, nursing homes and prospective members as needed; office hours one day per week. Administer the Lord's Supper first Sunday of each quarter and in homes as requested; administer the Sacrament of Baptism; lead funeral services; moderate the Session of the congregation to which she is commissioned every other month; officiate at marriages where permitted by state law; have a voice and vote in meetings of the presbytery (counted as an elder commissioner for purposes of parity). REPORT OF THE STEWARDSHIP COMMITTEE

Moderator Perry recognized Karen Kinney, Chair of the Stewardship Committee who presented the report. Rev. Kinney explained that the committee also addressed a second part of the Bluestone Committee's request, a reduction in the 6% interest rate on the existing Mission Development Fund (MDF) loan. MDF documents do not allow for an interest rate lower than 6%, but there is no prohibition on forgiving the remaining loan balance. Bluestone has repaid more than was originally borrowed; payments totaling \$51,264.90 have been made. The committee agreed that since the MDF had recouped the original \$45,000, and further, it was not the purpose of the MDF to be an income generator, the remaining balance of the current MDF loan to Bluestone should be forgiven. The committee, therefore, acted to forgive the remaining portion of a \$45,000 loan extended to Bluestone in 2005. The loan was forgiven as of December 21, 2016. Rockland Poole, Treasurer, presented the Financial Reports. Mr. Poole noted that the year-end figures are tentative pending a scheduled audit. (Appendix G, pages 42-58.)

INFORMATION:

1. The committee met on December 21, 2016 to discuss and take action on a request from the Bluestone Committee for funding from the Mission Development Fund (MDF) for necessary electrical improvements at the camp. The electrical service in place is basically the same as when it was first installed in the 1950s and not in compliance with current building codes, including the pool not being grounded. A preliminary estimate placed the total cost of electrical repairs/improvements and pool deck repairs at \$70,000.

- 2. The committee, which has authority over the MDF, noted that this was an appropriate use of these funds and that there was precedent in the form of loans being extended in the past, including to Bluestone. The Friends of Bluestone have committed \$15,000 with a goal of raising an additional \$10,000 to assist with the cost of these repairs.
- 3. The committee agreed to establish a line of credit of up to \$70,000 for Bluestone, with the following terms: 15-year term, 6% interest rate and an annual review by the Stewardship Committee. The Presbytery Treasurer was asked to draft documents and procedures for the line of credit for the committee to review at its next meeting (February).

REPORT OF THE BLUESTONE COMMITTEE

The Moderator recognized Denny Dodson, Acting Chair of Bluestone Committee. He gave thanks to the Stewardship Committee. Mark Miller, Director, Bluestone Camp and Retreat, also thanked the Stewardship Committee and shared the progress on improving the electrical system.

The commission was called to order by the chair, Susan Perry, who opened with prayer by Jim Musgrave. The commission was organized and Cinda Harkless was elected clerk. The order of service for the installation was approved. The minutes of the commission as written by the clerk were approved. The commission then joined the congregation in the sanctuary of the church where a service of worship was conducted.

The sermon on the texts John 14: 15-17 and Acts 8: 26-39 was preached by Paul Anderson. The constitutional questions were propounded to the minister by Susan Perry and to the congregation by Susan Conn. All were answered in the affirmative. The prayer of installation was offered by Susan Perry. The chairperson, Susan Perry, declared that William Long Hudson was duly elected and installed as pastor of the First Presbyterian Church, Williamson, West Virginia. APPENDIX E – PROCEDURAL MATTERS

Principles of Parliamentary Law

- Courtesy to all

Majority ruleJustice for all

- One Item at a time

- Respect the rights of the minority

- Partiality for none

- Usually pro and con speakers will alternate and individual speaking will identify his or her position.

- No one is allowed to speak more than once on a pending question until all wishing to speak have been heard; a person can then speak a second time, but no more than twice (unless the body gives special permission by two-thirds vote for a third speech).

B. Relevant Provisions of Presbytery's Manual (Section III of Manual)

- 1. "No new business shall be introduced after Presbytery recesses for lunch (unless by two-thirds vote Presbytery sets a different deadline for introduction of new business), and any new business not listed on the docket shall be presented in written form."
- 2. "...each elder elected an officer, General Presbyter, or a member of Leadership Team shall be enrolled as a member of the Presbytery for the term of office, whether or not commissioned by his or her session."
- 3. "The privilege of the floor without vote shall be granted to lay members of Presbytery's committees and to laypersons serving on Presbytery's staff, if not enrolled as members of the Presbytery."
- 4. "The privilege of the floor without vote shall be granted to certified church educators serving the churches of Presbytery, if not enrolled as members of the Presbytery. Certified church educators who are ruling elders and serving churches of Presbytery shall have voice and vote privileges. (G-2.1103b)"

<u>NOTE</u>: The phrase, "privilege of the floor without vote," means that the person has the privilege of speaking on the floor of Presbytery, including debating a motion under consideration, subject to rules and guidelines that govern discussion and debate. However, the person does not have the privilege to make motions or to vote.

Those who have "privilege of the floor without vote" are lay members of committees, lay members of Presbytery staff, church educators, and youth advisory delegates. Those with "voice and vote" privileges are member Teaching Elders, Ruling Elder commissioners, Certified Christian Educators*, Commissioned Ruling Elders, General Presbyter, Stated Clerk, Recording Clerk, Treasurer, Moderator, Members of Leadership Team and Presbytery Committee chairs.

C. Procedural Rules for the meeting of Presbytery (approval by two-thirds vote required to adopt #3).

- 1. Persons wishing to speak to the Presbytery giving a report, debating a motion, raising questions will do so by using the microphones.
- 2. Each speaker, after recognition by the Moderator, will give his or her name and church name (or other relationship to the Presbytery if not pastor or elder commissioner from a session).
- 3. Limitation of Debate 30 minutes per main motion, with each individual limited to 3 minutes per speech.
- 4. A recommendation from a committee or other entity elected by the Presbytery, upon being presented to Presbytery by an elected member of that entity, is considered to be on the floor for Presbytery's debate, amendment, and disposition without the necessity of a motion placing the recommendation on the floor.

APPENDIX F – BIOGRAPICAL STATEMENT & SATEMENT OF FAITH ELIZABETH STONE

I was born and raised in a suburb of Philadelphia to loving parents who brought me up in the Episcopal Church, wherein I was baptized and confirmed. Although I had always believed in God, I date my Christian faith from my junior year in high school, when I received Christ as my Savior through a school Bible Club. A tract written by John Stott, "Becoming a Christian," resonated with me because it not only clarified the Gospel, but also ministered to my Anglican background. I hold a BS in mathematics, *cum laude*, from Bethany College, WV, and two certificates of the French language from the Sorbonne University. My career in secondary education has spanned two and a half decades and four states, including five years in a home for pregnant and parenting teens in Wheeling.

My husband Greg and I have five children all of whom have gone on to college and careers. I worked briefly with the Coalition for Christian Outreach in campus ministry, but after our marriage I was hired by Fleming Memorial Church (Fairmont, WV), to do youth and college ministry, and in 1983 we joined the PCUSA. When we moved to Moundsville, WV, I was hired by First Presbyterian, to do youth work, and there I became a deacon. Greg became a teaching elder installed at Powhatan Point Presbyterian Church, Ohio, where I was elected an

elder.

My ministry has included teaching Sunday school to all ages, VBS, directing Junior Camp at Camp Presmont (13 years), Presbyterian Women, music ministry singing in choirs, solos, directing children's choir, writing and directing dramas and puppet shows. In the Upper Ohio Valley Presbytery I trained as a Commissioned Lay Pastor being authorized to preach in 2002, and certified as a CLP in 2004, and was pulpit supply until 2005 when I was commissioned to Limestone and Allen Grove Churches. Moving to Beckley, I provided pulpit supply until I was commissioned to Bradley and Mount Hope Churches, where I have been for the last 9 ½ years. As CRE I have performed baptisms, funerals, marriages, and attended deathbeds; I preach twice every Sunday, serve communion, moderate sessions, visit, participate in two ministerial associations and their community services, represent them at Presbytery, counsel, lead Bible Study, houseclean, and run off bulletins. I have written articles for the local paper, led a local charity drive for winter coats, blankets, and a fund for utility bills, taken youth on retreat, and played the piano for worship, tutored the children, taken members to doctor appointments, written letters of recommendation for jobs, scholarships, U.S. Citizenship, and legal dependent status. In conjunction with the mission base at Mount Hope I became active in local mission projects cooperating with WV-MAW.

At seventeen our daughter Erin attempted suicide, and this difficult experience has become a vital part of my ministry. Erin and I authored a book, *Valley of the Shadow*, and I have become a speaker and advocate for suicide prevention serving as a member of the West Virginia Suicide Prevention Council. During CPE I worked in hospice care and continue now as a volunteer chaplain. Because I have worked in ministry while I attended seminary, I have had invaluable on the job training, experience that has enabled me to excel in my classes and pass my ordination exams efficiently, while growing in ministry. At my graduation, I was unanimously chosen by the faculty of Gordon-Conwell Theological Seminary to speak representing the Master of Divinity candidates when my degree was conferred in 2015. In 2016 I have continued in ministry, completed a polity class for the Vocations committee through Dubuque, have continued writing and promoting my book ministry at www.wvlivingstone.com and have spoken at a women's retreat. I am looking forward to ordination and this new phase of ministry.

I believe in God: Father, Son, and Holy Spirit, eternally existent as a single Triune Godhead. God is the Creator, Sustainer, and Savior of our universe.

God created the world in perfection, and created people as the last and best creation, and as stewards of all other creatures and the environment. We were created for God's pleasure and for eternal communion with God. Human beings bear God's image and thus are spiritual, rational, articulate, and creative. As male and female people were created equal, and created into community with God and each other.

Humans fell from their state of created perfection through disobedience, becoming sinful and losing their intimate communion with God. God compensated for their destructive act by expelling them from their perfect environment and blessing them with mortality. God covenanted with them to redeem the creation. God further provided the Law, and covenanted with the ancients to choose a nation and bring from Israel a redeemer.

At the pivotal moment in history, God fulfilled the covenantal promises and prophecies by providing that Redeemer in God's own Self. God's Son, Jesus Christ, came to earth incarnated as a human child outside the natural order of biology, being both man and God, conceived in a virgin by the power of the Holy Spirit. He lived a sinless life, and taught, proclaiming the Kingdom of God among the people of Israel. He was arrested as a political prisoner, falsely accused and wrongfully convicted, tortured and crucified. This perfect and willing gift of Himself was not only a temporal act of ultimate obedience, but also a spiritual sacrifice in His own blood, that once for all satisfied the holiness of God, providing atonement and access for all people back into intimate communion with God. On the third day Jesus rose from the dead, and made a bridge from the mortal world back to the immortal perfection for which we were created. He ascended into Heaven to sit in victory at the Father's right hand. As He left, He will return, on clouds of glory to gather all of His own to Himself and to usher in an eternal age of paradise. The Son, now glorified at the Father's right hand, is also present to the Church in the Eucharist and in the person of the Holy Spirit.

The Holy Spirit is the Author and Interpreter of the Scriptures, the canon of the Old and New Testaments which are the ultimate standard of faith and practice for a Christian. In response to the Spirit's pervasive call, those who are called believe in and confess Jesus Christ as Savior receiving the indwelling Holy Spirit. God's Spirit is active in individual believers to empower our submission to the Lordship of Christ, to give, identify, and enable our gifts, and to direct us in ministry. Salvation of souls always brings people into the community of faith, the Church – a local church family as well as the Church Universal. Two sacraments define our faith community: baptism, the outward sign of inclusion in Christ; and communion, the common meal that unites us to Christ and each other in grateful commemoration of the death and sacrifice of our Lord Jesus Christ, and the joyous assurance of union with Christ now and in life eternal. The Holy Spirit is active in the Church (i.e. any gathered group of Christians) to unite us in love, guide us in truth, enable us in ministry, and send us out in mission. God reaches out to this fallen creation through believers who share the Gospel of reconciliation through their myriad gifts and contacts as the Spirit directs and enables them. Our task is to take the Gospel to the ends of the earth. At the end of the age, people of all nations and languages will gather at the throne of God to glorify Father, Son and Holy Spirit, and to celebrate the completion of all covenantal promises.
