ONE HUNDRED FORTY SIXTH STATED MEETING

CALL TO ORDER

The meeting was called to order at 10:00 a.m. by Moderator Stephen Hornbeck.

GREETINGS FROM RIVERLAWN PRESBYTERIAN CHURCH

Chris Kilbert, Pastor of Riverlawn Presbyterian Church, offered a prayer and extended a warm welcome to the Presbytery on behalf of the Session.

STATEMENT OF QUORUM

Stated Clerk Wright stated an official quorum with Commissioners from 43 churches and 25 ministers of Word and Sacrament present. (Attendance record in Appendix A, pages 20-25.)

DOCKET

The Clerk moved the docket be accepted. The motion was seconded and the docket was approved. (Appendix B, pages 26-27.)

INSTALLATION OF THE 2020 PRESBYTERY MODERATOR

Moderator Hornbeck led the Presbytery in the installation of Andrew Kent Rice as the 2020 Moderator. Moderator Hornbeck was thanked for his service and was presented with a gift from the Presbytery.

EDUCATIONAL FOCUS

Mr. David Staniunas, records archivist at the Presbyterian Historical Society in Philadelphia engaged Presbytery with reflections on historical records. He focused on preserving and sharing church archives, offering tips for making sense of church records, including best practices in considering paper records versus digital records. The choice between paper versus digital records includes the impact of these choices on climate change. Mr. Staniunas outlined a process for

sorting records into "three buckets": vital records (minutes and rolls/registers), commemorative items, and records of temporary value. He emphasized that the Presbyterian Historical Society is the best place for all vital records.

ANNOUNCEMENT

Nelle Howard, Resource Center Director, highlighted new resources and encouraged commissioners to visit the Resource Center Display and to come by the center at the Presbytery office. Amy Robinson, the Presbytery's Officer Administrator and Communications Director, asked that churches send in the requested information for the 2020 Presbytery directory so that the directory may be completed by mid-April.

WORSHIP

Morning worship was led by Todd Wright (minister, Village Chapel Presbyterian Church), who preached the sermon and Kari Preslar (ruling elder, First, Charleston) as liturgist. Minister of Word and Sacrament Glenn Coleman (First, Charleston) presided at the celebration of the Lord's Supper. Pam Johnson, Music Director, and the Riverlawn Choir provided music.

CONSENT AGENDA

The Moderator called on Stated Clerk Wright who presented the Consent Agenda.

The Leadership Team members present were appointed to serve as the Committee on Bills and Overtures.

REPORT OF THE STATED CLERK

The Moderator recognized the Stated Clerk. Stated Clerk Wright reported that Overture 20 to the General Assembly received concurrence from two Presbyteries and that an article, written by Amy Wallace Parker, regarding the overture will be in the upcoming issue of the Presbyterian Outlook.

INTRODUCTIONS

Ruling Elder Commissioners attending Presbytery for the first time were introduced and welcomed.

PRAYER AND HYMN

Following lunch, the Moderator and Stated Clerk led the Presbytery in a service of remembrance of ruling elders and ministers of Word and Sacrament deceased between January 1 and December 31, 2019. (Necrology, Appendix C, pages 28-30.)

The Moderator recognized Nancy Kahaian who made a motion that the text of the sermon from today's worship be included in the minutes of the meeting. The motion was seconded and approved. (Appendix D, pages 31-33.)

PROCEDURAL MATTERS

The Stated Clerk presented Procedural Matters and moved the adoption of Item C3, limiting debate to 30 minutes per main motion, with each individual limited to three minutes per speech. After receiving a second, Presbytery adopted the motion by a two-thirds vote. (Appendix E, page 34.)

INTRODUCTION OF A MINISTER OF THE WORD AND SACRAMENT

The Moderator called on the Stated Clerk, Maureen Wright, who introduced and welcomed new Minister of Word and Sacrament Stephen C. "Steve" Cort, Honorably Retired, who signed the Book of Obligations.

REPORT OF THE GENERAL PRESBYTER

The Moderator recognized Ed Thompson, General Presbyter, who thanked those in attendance for coming and Riverlawn Presbyterian Church for hosting the Presbytery. Dr. Thompson asked those present if their church had an adult baptism in 2019. He shared the importance of churches being intentional about inviting people to be baptized and become members of the church. Congregations were reminded to watch for information on the New Life Congregational Grants; these grants will be funded by the sale of church properties from dissolved and dismissed congregations.

Dr. Thompson asked those present to think about the answer to the question, what is essential about a Presbytery? Using the idea of Eight Word Mission Studies, his answer to the question is *Supporting Churches Living the Gospel in Changing Times*. He challenged those present by asking what eight words they would choose to describe the Presbytery of West Virginia.

REPORT OF THE VOCATIONS COMMITTEE

Moderator Rice recognized Nancy Didway of the Vocations Committee. Rev. Didway proceeded to the examination of Garland Dale Carey, an ordained minister in the Southern Baptist Church, seeking transfer as a minister of the Word and Sacrament to serve as pastor of First Presbyterian Church, Williamson. She invited Rev. Carey to introduce himself and briefly share his call to

ministry and desire to be transferred to the Presbyterian Church (U.S.A.). She then led Presbytery in the examination of Rev. Carey, asking questions in the areas of polity, worship and sacraments, reformed theology, Christian faith, and Bible content. Following his answers, Moderator Rice asked if there were questions from the floor. A motion was made to sustain the examination. The motion was seconded. Rev. Carey was excused. Rev. Didway made the following recommendations on behalf of the committee.

RECOMMENDATIONS:

The Vocations Committee has met since November 2018 with Garland Dale Carey, an ordained minister in the Southern Baptist Church, with regard to his desire to be transferred as a Minister of Word and Sacrament in the Presbyterian Church (U.S.A.) and in the Presbytery of West Virginia. Rev. Dr. Carey has been serving as the Stated Supply for the First Presbyterian Church, Williamson, West Virginia, as he completes the necessary requirements for transfer. In connection with G-2.0505 and G-2.0607, the committee recommends:

1. That the certification of Garland Dale Carey's ordination by First Baptist Church, Rose Hill, Virginia, of the Southern Baptist Church, be accepted as fulfillment of the constitutional requirement that he shall furnish credentials and evidence of good standing acceptable to the presbytery (G-2.0505). The Presbytery received a letter of good standing from the West Virginia Conference of Southern Baptists.

The motion was approved.

2. That Garland Dale Carey's Bachelor of Arts degree from Clear Creek Baptist Bible College, his Master of Theology degree from Campbellsville University, and his Doctor of Education degree from the University of the Cumberlands, be considered satisfactory fulfillment of the provisions of G-2.0505a and G-2.0607b-c, which require that he submit satisfactory evidence of scholarship required of candidates, waiving the requirement in G-2.0607c requiring a transcript from a theological institution accredited by the Association of Theological Schools.

Rationale: The Campbellsville University is accredited by the Southern Association of Schools Commission on Colleges, which is one of the six regional accreditation agencies that cover the United States and is recognized by U.S. Department of Education and by the Council for Higher Education Accreditation. The main difference is that these six regional accrediting agencies are institutional accreditors, not degree program accreditors, and focus on the stability and integrity of the institution as a whole.

The motion was approved unanimously, meeting the Book of Order standard of approval by a three-fourths vote.

3. That Garland Dale Carey's examination by the Vocations Committee and his successful completion of ordination examinations – Bible Content, Bible Exegesis, Church Polity, Theology, Worship and Sacraments – be considered satisfactory fulfillment of the provisions of G-2.0505a and G-2.0607a-d.

The motion was approved.

4. Pending approval at this meeting of Garland Dale Carey's call as pastor of the First Presbyterian Church, Williamson, West Virginia, be affirmed as evidence of call of work properly under the jurisdiction of the presbytery (G-2.0505a).

The motion was approved.

5. That the Presbytery examine Garland Dale Carey for membership in the Presbytery of West Virginia of the Presbyterian Church (U.S.A.) (G-2.0505a). His biographical statement and Statement of Faith follow this report. (Appendix F, pages 35-36.)

The motion was approved.

6. That under the provisions G-2.0505b, upon the acceptance of the ordination vows and with satisfactory evidence of having been removed from the roll of ministers of the Southern Baptist Church, that Garland Dale Carey be enrolled as a minister of the Presbytery of West Virginia.

The motion was approved.

Garland Dale Carey was welcomed by the body as he returned to the room. A large contingency of members of First Presbyterian Church, Williamson, was introduced. Moderator Rice asked Garland Dale Carey the constitutional questions as a minister of the Presbyterian Church (U.S.A.).

REPORT OF THE COMMITTEE ON MINISTRY

The Moderator recognized Peter Vial, Chair of the Committee on Ministry. He spoke to the designation of Validated Ministry outside of the congregation and asked those present who were engaged in validated ministries outside the congregation to stand in order to be recognized.

Moderator Rice and Dr. Vial led the Presbytery in the commissioning of John Yeager as Commissioned Pastor serving Enslow Park Presbyterian Church.

INFORMATION:

- 2. Appointed a listening team to visit and hear concerns from the Point Pleasant Presbyterian Church. Following the report of the team and communication with the session, appointed a Severance Negotiating Team according to Presbytery policy. The members of the team were Cinda Harkless, Sharon Gearing, Brad Hensley, Jim Robinson, Jean Summerfield, Rick Wilson (convener), and Jeff Wittman.
- 3. Approved the terms of the Severance Agreement between the Point Pleasant Presbyterian Church, and John Holland. Terms of the agreement: 100% salary (\$8,460), plus utilities (\$853), housing (\$2,556), SECA (\$981), and Board of Pensions (\$4,391) for three months; 75% salary (\$6,345), plus utilities (\$853), housing (\$2,556), SECA (\$7,26), and Board of Pensions (\$3,609) for three months. A one-time lump sum of \$11,851, paid at dissolution, in consideration of the years of service by the pastor. The church's responsibility for all payments or obligations under the dissolution agreement shall end when another call or other employment for the pastor begins.
- 4. Granted approval of the request for the waiver of rotation of officers (G-2.0404) for Smithers Presbyterian Church.
- 5. Reviewed a report of the visit by members of the committee to First Presbyterian Church, Ripley. Appointed a group of two to make a follow up visit with the session.
- 6. Reviewed the Triennial Visit to Beechwood Presbyterian Church by the Relations Committee.
- 7. Reviewed the Interim Pastor Report from Dana Sutton regarding his service at Highlawn Presbyterian Church, Huntington.
 - 8. Appointed the following ministers to serve as Moderators of churches without a pastor: Beulah Humble, Elizabeth Mike Seely; Community, Arthurdale David Bower; Centerville, Greenville Bob Carter; First, Dunbar Doug Jenkins.
 - 9. Appointed the following liaisons to work with churches in pastoral transition: First, Huntington Jean Summerfield; Point Pleasant Patterson Lyles.
- 10. Reviewed the six-month ministry review report from Beckley Presbyterian Church and Monte Mitchell.
- 11. Approved the match between First Presbyterian Church, Williamson, and Garland Dale Carey.
- 12. Pending the successful examination of Garland Dale Carey as minister of the Word and Sacrament, approved the following terms of call with First Presbyterian Church, Williamson. Terms: cash salary \$33,840; utilities \$6,000; manse equity allowance \$500; SECA \$3,796;

- auto reimbursement at the IRS rate up to \$7,000; continuing education \$1,500; Board of Pensions; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays). Fair market of manse \$6,000. The total for the terms of call is \$72,040.
- 13. Approved scholarship monies from the Committee on Ministry's Discretionary Fund to provide each Commissioned Pastor commissioned to a particular pastoral service up to \$1,000 to attend the *Empowering Commissioned Pastors Conference* sponsored by PC (USA) Co-Moderators Cindy Kohlmann and Vilmarie Cintron-Oliveri and the Synod of the Sun to be held May 13-16, 2020 in Richardson, Texas.
- 14. Approved Stephen Carter Cort for membership in the Presbytery of West Virginia. Steve comes to the Presbytery from Beaver-Butler Presbytery. His autobiographical statement and Statement of Faith follow this report. (Appendix G, pages 37-40.)
- 15. Reviewed the Commissioned Pastor reports received to date.
- 16. Heard a report on the appointment of the Designated Pastor Search Committee for First Presbyterian Church, Parkersburg. Medina Poole (RE, First, Williamstown), Ed Thompson (minister), and Peter Vial (minister) have agreed to serve. The committee will identify an additional ruling elder to serve.

- 18. Approved the Stated Supply Covenant between Davis Memorial, Gassaway, and James Riggs through January 31, 2021. Terms: cash salary \$1,590.42 per month, of which \$316.42 is designated as housing allowance; auto reimbursement at the IRS rate, up to \$1,088; continuing education \$1,500; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays). Responsibilities: provide weekly and special worship services and assist

- in their planning; provide pastoral care including home visits. The Session will maintain its individual and corporate duties in the government and discipline of the congregation and oversight of the church's spiritual interests.
- 19. Approved the Stated Supply Covenant between Kuhn Memorial, Barboursville, and Cinda Harkless through December 31, 2020. Terms: cash salary \$2,500 per month, of which \$1,000 is designated as housing allowance; auto reimbursement at the IRS rate, up to \$1,500; SECA \$2,485; continuing education \$1,500; Board of Pensions; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays). Responsibilities: provide weekly and special worship services; administer the sacraments; visit sick and homebound members; teach adult Sunday school; assist in establishing a youth group; provide officer training and install officers; moderate the session; moderate congregational meetings; supervise part-time staff; maintain office hours twice weekly; lead community outreach efforts.
- 20. Approved the Commissioned Pastor Covenant between Enslow Park, Huntington, and John Yeager through December 31, 2020. (Start date: March 29, 2020.) Terms: 19 hours per week; cash salary \$1,666.67 per month, of which \$800 is designated as housing allowance; auto reimbursement at the IRS rate; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays). Responsibilities: provide weekly and special worship services; moderate the session; provide spiritual guidance, counsel, and perspective; maintain presence at church two days per week; supervise church staff; provide pastoral care; support church events. Administer the Lord's Supper; administer the Sacrament of Baptism; moderate the Session of the congregation to which he is commissioned; officiate at marriages where permitted by state law; have a voice and vote in meetings of the presbytery. Mentor: Cinda Harkless.
- 21. The Presbytery will commission John Yeager to Enslow Park following this report.
- 22. Approved the renewal of the Interim Commissioned Pastor covenant between Rock Lake, South Charleston, and Jim Musgrave. Terms: 20 hours/week, salary: \$2,106/month of which \$500 is designated as housing allowance; \$174.38/SECA offset, continuing education \$1,000, auto reimbursement at IRS rate; vacation 4 weeks (including Sundays), continuing education 2 weeks (including Sundays). Responsibilities: weekly and special services, pastoral visits, Bible study, counseling, pastoral care, ecumenical relations, help re-evaluate church's mission. Administer the Lord's Supper; administer the Sacrament of Baptism; moderate the Session of the congregation to which he is commissioned; officiate at marriages where permitted by state law; have a voice and vote in meetings of the presbytery. Mentor: Cinda Harkless.
- 23. Approved the renewal of the Interim covenant between Highlawn, Huntington and Dana Sutton through January 31, 2021. Terms: cash salary \$6,435.50 per month, of which \$2,250 is designated as housing allowance; auto reimbursement at IRS rate; continuing education \$4,800; coaching \$1,200; vacation 4 weeks (including Sundays), continuing education 2 weeks

- (including Sundays), 5th Sundays off. Responsibilities: provide weekly and special worship services; teach Bible studies and Wednesday night programs; home, nursing home, and hospital visitation; interact with and support youth; moderate the session; lead the mission study process; supervise staff; maintain office hours; attend Presbytery meetings; attend Highlawn Alliance meetings; interact with area clergy; support church activities.
- 24. Approved the renewal of the Stated Supply Covenant between Rome, Proctorville, OH and Peter Barclay through January 31, 2021. Terms: 15 hours/week; salary \$180/week, of which \$120/week is designated as housing allowance; auto reimbursement at IRS rate; continuing education \$500; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays). Responsibilities: preach and lead weekly worship; conduct special worship services; moderate the session; share duties of visitation; keep the church a vital part of the Lord's work.
- 25. Approved the renewal of the Stated Supply Covenant between Winfield and David A. Bush through January 31, 2021. Terms: 10 hours/week; Salary \$500/month; auto reimbursement at IRS rate; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays); other items of finance or reimbursement as needed, approved by Session. Responsibilities: Conduct weekly worship services and special services as needed. Pastoral duties: visit the sick in hospitals, occasionally visit members and conduct funerals as needed. Assist the Session by moderating meetings, officer training and providing guidance on the Book of Order as needed. Other responsibilities as negotiated by the session.
- 26. Approved the renewal of the Stated Supply Covenant between Frankford and Susan Sharp Campbell through January 31, 2021. Terms: 10-12 hours/week; \$11,015/year, of which \$5,507.50/year is designated as housing allowance; utilities \$853/year; auto expense reimbursement at current IRS rate; pension, medical, death and disability \$5,090.83/year paid to presbytery; SECA offset of \$983; workers compensation coverage; vacation 5 weeks (including Sundays); continuing education 2 weeks (including Sundays), \$1,000. In acknowledgement of her work with PWV, Susan may be gone up to 4 additional weeks for retreats and other events. Responsibilities: conduct weekly worship, special services; attend fellowship events, visit sick and homebound members; assist the Session, moderate Session meetings, provide officer training as needed, moderate congregational meetings.
- 27. Approved the renewal of the Stated Supply Covenant between Belle and Denny Dodson through January 31, 2021. Terms: 15 hours/week; \$1,416/month, of which \$1,050 is designated as housing allowance, auto expense reimbursement at IRS rate; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays). Responsibilities: Worship on Sunday and special services; provide for Holy Communion at least 5 times a year. Provide pastoral care of congregation including home and hospital visits; funerals, weddings, baptisms; moderate Session meetings, install Elders, conduct children's church, participate in Belle

- Ministerial Association when possible; guide Session through prayer and wisdom, assist with setting goals for church with the help of the session.
- 28. Approved the renewal of the Stated Supply Covenant between Valley Bend, Beverly, and Ann Fretwell through January 31, 2021. Terms: time: 25-30 hours/week; salary: \$150/week; auto expense reimbursement at current IRS rate; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays). Responsibilities: 11 AM Sunday worship; weddings; funerals; communion; assist the session with spiritual guidance; home, hospital, shut-ins visitation; assist with special services such as revivals, gospel sings, etc. The Session will maintain its individual and corporate duties in the government and discipline of the congregation and oversight of the church's spiritual interests.
- 29. Approved the renewal of the Stated Supply Covenant between First, Welch, and Chuck Hammond through January 31, 2021. Terms: 10 hours/week; \$400 to \$500/month; auto expense reimbursement at IRS rate; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays). Responsibilities: provide worship each Sunday and special services; administer Lord's Supper, conduct funerals, do home and hospital visitation; assist Session in carrying out the mission of the church. The Session will maintain its individual and corporate duties in the government and discipline of the congregation and oversight of the church's spiritual interests.
- 30. Approved the renewal of the Stated Supply Covenant between Spencer and Julie Hitsman through January 31, 2021. Terms: 10 hours per week; cash salary: \$1,238.33 per month, of which \$800 is designated as housing allowance; reimbursement for travel at IRS rate; continuing education \$1,500; 4 weeks vacation (including Sundays) and 2 weeks study leave (including Sundays). Responsibilities: conduct weekly and special worship services, moderate session; occasional visitation; moderate session and congregational meetings; think and pray about the church, and help the church to grow spiritually and in service to the community.
- 31. Approved the renewal of the Stated Supply Covenant between Bates Memorial, Huntington and Scott Hoppe through January 31, 2021. Terms: 18 hours/week; \$1,085.71 bi-weekly; auto expense reimbursement at IRS rate; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays). Responsibilities: conduct Sunday worship, special services; visit hospitalized members and others as needed; assist the Moderator with Session meetings; maintain a relationship with Presbytery and the Committee on Ministry; other duties as mutually agreed upon and as time allows.
- 32. Approved the renewal of the Stated Supply Covenant between St. Marys and Kay Larsen through January 31, 2021. Terms: 20 hours/week; \$600/month; auto expense reimbursement at current IRS rate; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays). Responsibilities: conduct weekly worship; funerals, home, hospital, and nursing home visitation; assist with communion. The Session will maintain its individual and

- corporate duties in the government and discipline of the congregation and oversight of the church's spiritual interests.
- 33. Approved the renewal of the Stated Supply Covenant between Marlinton and David Lee through January 31, 2021. Terms: 30 hours per week; cash salary: \$20,000 per year of which \$12,000 is designated as housing allowance; SECA \$2,919; Medical/Pension; mileage reimbursement at current IRS rate up to \$1,400; continuing education \$1,500 annually; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays). Responsibilities: weekly worship and special services; celebrate baptisms and the Lord's Supper; moderate session; conduct officer training; assist in planning outreach ministry; hospital and in-home visits as needed; work with Ministerial Association on joint projects; be present in the community.
- 34. Approved the renewal of the Stated Supply Covenant between Church of Our Saviour, Clarksburg and Bruce A. Macbeth through January 31, 2021. Terms: 9 hours/week; \$200/week, of the salary, of which \$4,000/year is designated as housing allowance; auto expense reimbursement at IRS rate; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays). Responsibilities: Conduct worship at 11 a.m. each Sunday and special services such as Ash Wednesday, Maundy Thursday and the Community Lenten Service. Conduct weddings, funerals, Baptism, and Communion. Pastoral duties include member, hospital, and prospective member visitation; counseling. Receive new members. Moderate the session and Congregational meetings. Assist the session by working with Ruling Elders in fulfilling their responsibilities.
- 35. Approved the renewal of the Stated Supply Covenant between First, Weston, and Bruce A. Macbeth through January 31, 2021. Terms: 9 hours/week; \$200 per week of which \$4,000 per year is designated as housing allowance. Reimbursement for travel at current IRS mileage rate; four weeks vacation; two weeks study leave. Responsibilities: weekly 9 a.m. worship and special worship services including Good Friday, Christmas Eve; visitation of members, hospital, and prospective members; counsel as needed; moderate the session and congregational meetings.
- 36. Approved the renewal of the Stated Supply Covenant between Clifton, Maxwelton, and Ron Miller through January 31, 2021. Terms: 20 hours/week; cash salary \$2,000 per month, of which \$500 is designated as housing allowance; reimbursement for travel at IRS rate; 4 weeks vacation (including Sundays) and 2 weeks study leave (including Sundays). Responsibilities: provide weekly and special worship services; call on the sick and homebound members; officiate at weddings and funerals; work with committee chairs and assist the moderator with administrative leadership; represent the church with outside organizations when asked. The Session will maintain its individual and corporate duties in the government and discipline of the congregation and oversight of the church's spiritual interests.

- 37. Approved the renewal of the Stated Supply Covenant between First, Colcord and Gerald Pauley through January 31, 2021. Terms: cash salary: \$100/ week; auto expense reimbursement at IRS rate; vacation: 4 weeks (including Sundays); study leave: 2 weeks (including Sundays). Responsibilities: preach and lead weekly worship, conduct special worship services, conduct weddings and funerals, visitation as time permits. Celebrate the sacrament of communion.
- 38. Approved the renewal of the Stated Supply Covenant between Fayetteville and Bob Wood through December 31, 2020. Terms: 30 hours per week; cash salary \$3,080 per month, of which \$1,540 is designated as housing allowance; utilities \$200 per month; SECA \$2,328; auto expense reimbursement at IRS rate up to \$1,800 per year; Board of Pensions; continuing education \$1,000; vacation 4 weeks (including Sundays) and continuing education 2 weeks (including Sundays). Duties: weekly worship and special services; oversee staff; define program needs and committee oversight; oversee and participate in taking communion to shut ins; visitation as needed; regular office hours; officer training at least annually; occasional Bible Study; share children's sermons; interfaith/ecumenical activities at pastor's discretion.
- 39. Approved the renewal of the covenant as Commissioned Pastor between Trinity, Shady Springs and Jeff Barton through December 31, 2021. Terms: 18 hours/bi-weekly; 26 Sundays and up to six special services; cash salary \$7,800 year; auto expense reimbursement at IRS rate; out of pocket expenses incurred if requested to the Session; vacation 2 weeks (including Sundays); continuing education 2 weeks (including Sundays). Responsibilities: conduct worship service. Prepare the bulletin for worship services. Administer the Lord's Supper; administer the Sacrament of Baptism; moderate the Session of the congregation to which he is commissioned; officiate at marriages where permitted by state law; have a voice and vote in meetings of the presbytery. Mentor: Jim Walther.
- 40. Approved the renewal of the covenant as Commissioned Pastor between Union and Nancy Bulla through January 31, 2021. Terms: 20 hours/week; cash salary \$1,817/month; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays) reimbursement for costs included. Responsibilities: lead worship and preach 4/5 times per month and on Christmas Eve and Maundy Thursday; officiate at funerals. Visit members in hospitals, nursing homes, and private homes; lead outreach evangelism, and attend presbytery meetings. Administer the Lord's Supper; administer the Sacrament of Baptism; moderate the Session of the congregation to which she is commissioned; officiate at marriages where permitted by state law; have a voice and vote in meetings of the presbytery. Officiate at marriages where permitted by state law; have a voice and vote in meetings of the presbytery. Moderator: Skip Siebel. Mentor: John Holland.
- 43. Approved the renewal of the covenant as Commissioned Pastor between First, Oak Hill, and Nancy Martin through December 31, 2020. Terms: 12 hours/week; \$702.16/month; of which \$4,537.08/year is designated as housing allowance; auto expense reimbursement at IRS rate up to 2,000 miles per year; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays). Responsibilities: Worship including Sundays, Maundy Thursday, Ash Wednesday, Christmas Eve, and funerals. Visit shut-ins, potential members, and members in times of crisis. Provide a monthly report to the session on visits and recommendations. Provide Bible School classes within weekly time expectation and play active role in Vacation Bible School. Take active role in planning and executing congregational developmental activities. Participate in and report on the Fayette County Ministerial meetings. Assist the Session as Bible study leader on Monday mornings and keep office hours on Wednesday mornings. Administer the Lord's Supper and the Sacrament of Baptism; moderate the Session of the congregation to which she is commissioned; officiate at marriages where permitted by state law; have a voice and vote in meetings of the presbytery. Mentor: Barbara Accord.
- 44. Approved the renewal of the covenant as Commissioned Pastor between Falls View, Charlton Heights and Kari Preslar through January 31, 2021. Terms: Time flexible; \$815 per month; auto expense reimbursement at IRS rate; continuing education \$200; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays). Responsibilities: Worship on Sunday and special services. Assist the Clerk of Session to file reports; conduct funerals. Administer the Lord's Supper and the Sacrament of Baptism; moderate the Session of the congregation to which she is commissioned; officiate at marriages where permitted by state law; have a voice and vote in meetings of the presbytery. Mentor: Todd Wright.

- 45. Approved the renewal of the covenant as Lay Pastor between Kesler Memorial, Hico and James Dempsey through January 31, 2021. Terms: 10 hours/week; \$225/week; vacation 2 weeks (including Sundays). Responsibilities: conduct Sunday worship; special services as needed. Pastoral duties include visitation and funerals. Assist Session as advisor and keep the Session aware of Presbytery and General Assembly activities/events. Mentor: Joan Stewart.
- 46. Approve the renewal of the covenant as Lay Pastor between Smithers and James Dempsey through January 31, 2021. Terms: 15 hours/week; \$175/week; vacation 2 weeks (including Sundays). Responsibilities: conduct Sunday worship; special services as needed. Pastoral duties include visitations and funerals. Assist Session by advising and keeping ruling elders informed of Presbytery and General Assembly activities and events. Mentor: Joan Stewart.
- 47. Approved the renewal of the covenant as Lay Pastor between Gilbert and Jay Nunley through January 31, 2021. Terms: time: 18 hours/week; salary: \$1,000/month; reimbursement for travel at current IRS rate; vacation 4 weeks (including Sundays); continuing education 2 weeks (including Sundays); church will pay a portion of educational expenses/tuition. Responsibilities: conduct worship including special services such as Christmas Eve. Provide limited visitation and maintain office hours. Mentor: Kevin Geurink.

REPORT OF THE NURTURE COMMITTEE

Moderator Rice called on Sue Hollandsworth, Chair of the Nurture Committee, who encouraged attendees to take the packet fliers back to their churches and share upcoming events with congregational leaders and members. Committee member, Derek Hudson, invited Presbytery to attend the Festival of Faith.

REPORT OF THE STEWARDSHIP COMMITTEE

Moderator Rice called on Rockland Poole, Financial Administrator/Treasurer, who reported for the committee. He reported that both expenses and income were under budget, which resulted in a deficit of \$66,000 for 2019. This was covered by reserves. He reminded the body that he is available for consultation with churches. Mr. Poole presented the financial reports. (Appendix H, pages 41-57.)

REPORT OF THE ADMINISTRATIVE COMMISSION TO DISSOLVE BEVERLY HILLS PRESBYTERIAN CHURCH

The Moderator recognized David Richards, Chair of the Administrative Commission. He thanked the commission and the Stated Clerk for their work, and told the story of the Beverly Hills Presbyterian Church and moved the following.

RECOMMENDATIONS:

- 1. That the Beverly Hills Presbyterian Church be dissolved effective January 26, 2020.
- 2. That the Administrative Commission be dismissed with thanks.
- 3. That the following be entered into the minutes of the meeting: The Commission hereby asserts the claim of the Presbytery to any property of the church not known at this time or property which may come to the church as the beneficiary of a will or trust.

The recommendations were approved.

RATIONALE AND BACKGROUND:

At the August 24, 2019 meeting of the Presbytery, the Moderator was authorized to appoint an Administrative Commission to dissolve the Beverly Hills Presbyterian Church, Huntington, at their request.

Members of the Administrative Commission: Chris Bailey, minister of Word and Sacrament, Marshall UKIRK; Pat Collier, ruling elder, Bates Memorial; Terri Effingham, ruling elder, Beverly Hills; Pat Gebhart, ruling elder, First Huntington; David Richards, minister of Word and Sacrament, Honorably Retired; Trish Rorrer, ruling elder, Beverly Hills.

The AC met for its first time on September 12, 2019. As the decision had already been made by the session to seek closing as early as February of that year, the commission moved ahead accordingly. Assignments were made, and meetings began in earnest. As there was a pastor still in place, Cinda Harkless, some of the work was left for her and the session. The commission worked closely with Terri Effingham, who served as a liaison to the session. The session made the following decisions:

- to close the Child Care Center (CCC), which was actively serving the community and was under the auspices of the church;
- to send a pastoral letter to members of the church regarding the closure;
- to collect all records of the session;
- to make decisions to allocate some of its remaining funds.

During the course of the work of the commission, the Child Care Center was able to move to

another facility and continue operations. The pastor and a couple of members were able to get the building cleaned out, all groups using the building moved, the closing worship service was planned, and the property was given into the care of the Presbytery's Trustees.

The closing worship service was held on January 26, 2020 and was attended by a full house of guests, members, and friends. Rev. David Richards, Chair of the Administrative Commission, presented the Statement of Purpose; the pastor, Rev. Cinda Harkless, led an opening prayer, and pastors nurtured by the church gave personal reflections: the Rev. Dr. James McTyre, Lake Hills Presbyterian Church, Knoxville, TN; Rev. Robert Warren, First Presbyterian Church, Mt. Sterling, KY; and Rev. Robin Blakeman, Parish Associate at Beverly Hills Presbyterian Church, who spoke to the children. From the Presbytery, Maureen Wright, Stated Clerk, and the Rev. Dr. Edward Thompson, General Presbyter, also participated in the service.

Following the service, a catered lunch was provided, and guests were encouraged to browse old photo albums and church records.

REPORT OF THE MISSION COMMITTEE

The Moderator recognized Barbara Chalfant, Presbytery staff support to the Mission Committee, who highlighted numbers one and two of the information below. She shared information about available Hunger grants and seed money grants (up to \$2000) for special projects within churches. The committee is developing a video about mission projects from the churches of the Presbytery, and requests that churches contact her for inclusion in the video.

The Moderator announced that \$1,129 was collected in the morning offering to be used for the costs of hosting visitors from Nyeri Presbytery in August.

RECOMMENDATION:

1. (CA) Approve the Presbytery offering for the February 15, 2020 Presbytery Meeting be designated for the costs of hosting visitors from Nyeri Presbytery in August.

INFORMATION:

- 1. The Nyeri Visitors subcommittee, moderated by Rick Accord, is at work preparing to host visitors from Nyeri Presbytery in August 2020. It is not yet known how many visitors will visit West Virginia. Robert McCutcheon will be working on those details during his current excursion to Nyeri. The committee is looking for congregations who would be interested in having a part in this planned visit, and who could host the group or part of the group during their time with the Presbytery.
- 2. The committee is currently looking for host sites for screenings of "Flint," an award-

winning documentary produced by the PC (USA).

3. The committee approved the following hunger grants from Cents-Ability funds:

a. Elk Hills – LERMA

\$2,000

b. Davis Memorial, Gassaway - United Christian Food Pantry

\$2,000

4. The committee received a report concerning Davis-Stuart. The committee is working to invite a representative from the organization to report directly to the Presbytery at an upcoming stated meeting.

REPORT OF BLUESTONE CAMP AND RETREAT

Moderator Rice recognized Sarah Specht, Bluestone Camp and Retreat Program Director, as she briefly shared plans for the upcoming camping season. Sarah introduced John Leftwich, member of First Presbyterian Church, St. Albans, long time camper and now a member of Bluestone Summer staff. He spoke passionately about the importance of camp and the positive impact Bluestone has had on his life.

NEW BUSINESS

There was no new business.

ADJOURNMENT

The Moderator reminded the Presbytery to review the reports of the Administration Committee, Administrative Commissions, Bluestone Committee, Leadership Team, and the Trustees. (Appendix I, pages 58-61.)

Presbytery was adjourned with a benediction at 2:55 p.m. by the Moderator.

APPENDIX D

"There's History Behind Every Story"

1 Corinthians 11(17-22) 23-26 Dr. Todd R. Wright

I'll bet you have some traditions at each of your churches that are a mystery to visitors.

At Village, part of our history is that our first communion table was fashioned out of the extra leaf to someone's dining room table. Someone was so excited about the formation of a new church that they gave what they had; gave generously; gave sacrificially! When that first congregation gathered around that table they couldn't help but be inspired to follow suit.

Of course the power of that story evaporates if people don't know it. A table is just a table.

So I tell the story. And speculate that when Thanksgiving rolled around the other spouse must have wondered what happened to their extra leaf!

Another communion story that I tell involves an elder and her husband who baked the communion bread together for decades. They were not the only ones who had been asked; or who had taken a turn; but they were the only ones who enjoyed it enough to stick with it, month after month. Every time we ate that bread it was a witness to their faithfulness ... and to God's!

I like knowing the history behind a story.

In another church, we always had shortbread as part of communion. No one knew why. The person who had begun the practice had died and the next person just kept using her recipe. We did the best we could to explain – joking, "taste and see that the Lord is good!" (Psalm 34:8) But somehow not knowing made everyone feel like we were missing some important insight.

It's like that with Paul's words of institution. We've heard them more times than we can count.

But have you ever wondered about the history behind these words, the story behind the story?

Clearly there are several layers. Paul recommends that the Corinthians ground their celebration in what Jesus said and did on the night before his arrest. Jesus, of course, was putting his own spin on the Passover tradition. The Corinthians may or may not have realized the background of that meal —

how it celebrated a rushed affair the Israelites consumed before escaping Egypt;
how they painted their doorposts with the lamb's blood and ate unleavened bread;
how they ate with their hiking staffs in their hands and an eye on the door;
how they waited on YHWH's great and terrible tenth plague – the death of the first-borns –
and how that finally broke Pharaoh's resistance.

So when the Corinthians break the bread and share the cup, they are to remember the One who was the lamb who was slain; shutter at the terrible nearness of the threat of death; and give thanks for their own deliverance!

But there is more to these words that we so easily memorize. Listen to the verses that precede Paul's instructions, again from Eugene Peterson's *The Message*:

¹⁷⁻¹⁹ Regarding this next item, I'm not at all pleased. I am getting the picture that when you meet together it brings out your worst side instead of your best! First, I get this report on your divisiveness, competing with and criticizing each other. I'm reluctant to believe it, but there it is. The best that can be said for it is that the testing process will bring truth into the open and confirm it. ²⁰⁻²² And then I find that you bring your divisions to worship—you come together, and instead of eating the Lord's Supper, you bring in a lot of food from the outside and make pigs of yourselves. Some are left out, and go home hungry. Others have to be carried out, too drunk to walk. I can't believe it! Don't you have your own homes to eat and drink in? Why would you stoop to desecrating God's church? Why would you actually shame God's poor? I never would have believed you would stoop to this. And I'm not going to stand by and say nothing.

It is a <u>scathing</u> commentary!

This meal that is intended to bear witness to Jesus sacrifice is marred by selfishness; this meal that should draw the community together highlights their division; this meal that should harken back to God's wondrous deeds of power

is instead a reflection of the people's pettiness.

With that background, Paul's vanilla words of institution take on new power.

When he retells the origin story of the meal, he is trying to restore gravity to a mess;

when he links it to Jesus' betrayal, he is elbowing them in the ribs;

when he ties it to the Savior's broken body and shed blood,

he is reminding them of their freedom's cost; and

when he talks about remembering the holy meal every time they eat and drink,

he is trying to remodel their lives out in the world as much as within worship.

≪

Friends, when we celebrate communion in a few minutes, it will be drenched in history.

The words of Paul will echo those who have spoken them down through the ages – saints you have known and people you have heard stories about.

The taste of the bread on your tongue will remind you of meals shared in joy and in sadness.

The cup will bring back memories of forming the clay like a potter or gathering the discarded plastic vessels like a scavenger hunt as a child.

And those celebrating the sacrament with you will be the people who took you in when you were a stranger and whispered the love of God in your ear; the people who dared to live out the gospel and invited you to tag along; or perhaps, the people who illustrate how God can dwell in the midst of a broken people who only barely reflect the light of Christ.

So remember: the history behind this meal is greater than any one of us. It is the story of God feeding us, body and soul, better than we deserve. May the story continue! Amen.

APPENDIX E – PROCEDURAL MATTERS

- A. Principles of Parliamentary Law
 - Courtesy to all
 - Majority rule
 - Justice for all

- One Item at a time
- Respect the rights of the minority
- Partiality for none
- Usually pro and con speakers will alternate and individual speaking will identify his or her position.
- No one is allowed to speak more than once on a pending question until all wishing to speak have been heard; a person can then speak a second time, but no more than twice (unless the body gives special permission by two-thirds vote for a third speech).
- B. Relevant Provisions of Presbytery's Manual (Section III of Manual)
 - 1. "No new business shall be introduced after Presbytery recesses for lunch (unless by two-thirds vote Presbytery sets a different deadline for introduction of new business), and any new business not listed on the docket shall be presented in written form."
 - 2. "...each elder elected an officer, General Presbyter, or a member of Leadership Team shall be enrolled as a member of the Presbytery for the term of office, whether or not commissioned by his or her session."
 - 3. "The privilege of the floor without vote shall be granted to lay members of Presbytery's committees and to laypersons serving on Presbytery's staff, if not enrolled as members of the Presbytery."
 - 4. "The privilege of the floor without vote shall be granted to certified church educators serving the churches of Presbytery, if not enrolled as members of the Presbytery. Certified church educators who are ruling elders and serving churches of Presbytery shall have voice and vote privileges. (G-2.1103b)"

<u>NOTE</u>: The phrase, "privilege of the floor without vote," means that the person has the privilege of speaking on the floor of Presbytery, including debating a motion under consideration, subject to rules and guidelines that govern discussion and debate. However, the person does not have the privilege to make motions or to vote.

Those who have "privilege of the floor without vote" are lay members of committees, lay members of Presbytery staff, church educators, and youth advisory delegates. Those with "voice and vote" privileges are member Teaching Elders, Ruling Elder commissioners, Certified Christian Educators*, Commissioned Ruling Elders, General Presbyter, Stated Clerk, Recording Clerk, Treasurer, Moderator, Members of Leadership Team and Presbytery Committee chairs.

- C. Procedural Rules for the meeting of Presbytery (approval by two-thirds vote required to adopt #3).
 - 1. Persons wishing to speak to the Presbytery giving a report, debating a motion, raising questions will do so by using the microphones.
 - 2. Each speaker, after recognition by the Moderator, will give his or her name and church name (or other relationship to the Presbytery if not pastor or elder commissioner from a session).
 - 3. Limitation of Debate 30 minutes per main motion, with each individual limited to 3 minutes per speech.
 - 4. A recommendation from a committee or other entity elected by the Presbytery, upon being presented to Presbytery by an elected member of that entity, is considered to be on the floor for Presbytery's debate, amendment, and disposition without the necessity of a motion placing the recommendation on the floor.

I have three elder sisters: Debra Catron of Delbarton, WV; Brenda Messer of Kermit, WV; and Tamara Carey of Columbus, OH. I am a 1993 graduate of Mingo Christian School of Lenore, WV. At the conclusion of my senior year, I accepted a full-time position with my father's company, Carey Manufactured Home Sales, Inc. of Naugatuck, WV, where I served as vice president and sales manager for nine and a half years.

I married Melissa Dawn Earnest of Borderland, WV on July 7, 1995. We were high school sweethearts. Melissa is employed by First Baptist Church of Williamson, WV, where she serves as secretary and treasurer, and is also the treasurer of the Greater Williamson Ministerial Association (GWMA). Although Melissa and I have been married for over 24 years, we have not been blessed with children. We do, however, love children, but have accepted the fact that it was not God's will for us to have any of our own.

I surrendered my life to Jesus Christ on November 10, 1985. God called me to preach on July 16, 1997. I was first ordained a United Baptist minister and pastored America United Baptist Church in Delbarton, WV for a little over four years. I quickly learned, however, that my beliefs did not align with the United Baptist denomination as I wholeheartedly embraced the assurance of salvation. I gave up my credentials and moved to Pineville, KY to attend a Southern Baptist Bible college in 2002. We became great friends, and through these friendships, I ascertained that I could be more effective as a Presbyterian minister than a Baptist minister. I was, therefore, elected as the supply pastor by First Presbyterian Church of Williamson, WV in October 2018. I instantly discovered that my assumption was correct; I align much better with Presbyterian doctrine and polity than with Baptist.

In addition to my pastorates, I currently serve as president of the Greater Williamson Ministerial Association (GWMA), which is a position I have held since 2016. GWMA is a non-profit religious organization that exists to promote dialogue and fellowship between local clergy and partnership among the various denominations and churches extant in our region.

As it pertains to higher education, I earned a Bachelor of Arts (B.A.) from Clear Creek Baptist Bible College in 2006, a Master of Theology (M.Th.) from Campbellsville University in 2009, and a Doctor of Education (Ed.D.) from the University of the Cumberlands in 2013. I was inducted into the Kappa Delta Pi International Honor Society in Education in 2012 for outstanding academic achievements in higher learning.

I believe there is one and only one, eternally existent, true, and living God who is the creator, redeemer, preserver, and ruler of the entire universe, and is revealed in a triune manner as Father, Son, and Holy Spirit with distinct attributes but without division of nature or essence.

I believe God is the sovereign ruler over the universe, creatures, and the course of human history. God is eternally omnipotent, omniscient, and omnipresent. God is often designated Father to speak of God's creatorship of all things visible and invisible. To those who are called to faith in Jesus Christ, God is the Eternal Father.

I believe Jesus Christ is fully God but also became fully human. Jesus was conceived by the Holy Spirit and born into this world by the Virgin Mary. Jesus Christ's sacrificial death on the cross redeemed fallen humanity from sin. Jesus was buried, raised from the dead, and ascended into heaven where he is exalted as the mediator between God and humanity. Jesus Christ will return to this earth culminate his redemptive work and to also judge the world in righteousness.

I believe the Holy Spirit inspired devout humans to write the Scriptures, convicts individuals of sin, draws people to Christ the Savior, and justifies those called to faith in Christ. APPENDIX I – ADDITIONAL COMMITTEE REPORTS

REPORT OF THE ADMINISTRATION COMMITTEE George Lilley, Committee Chair

INFORMATION:

- 1. The annual performance review of the General Presbyter was conducted by two members of the Administration Committee and two members of the Leadership Team in accordance with the manual. With input from the General Presbyter, the goals for 2019 were reviewed and acknowledged as having been successfully achieved. Goals for 2020 were established as a continuation of those from 2019. The report also acknowledged that the General Presbyter was performing a myriad of other functions. The Administration Committee accepted the report and added its thanks to the General Presbyter for his devoted work to the Presbytery.
- 2. The committee established Budget Preparation Guidelines, in order to make future budgeting consistent and reporting to Presbytery complete.
- 3. Approved the Housing Allowance for the Associate for Educational Ministry.
- 4. Heard reports from the Treasurer and General Presbyter.
- 5. Had lunch and enjoyed casual conversation with the staff.

REPORT OF ADMINISTRATIVE COMMISSIONS

DISSOLUTION OF LAKEVIEW PRESBYTERIAN CHURCH

The commission continues to await information from the heirs who will accept the property back as per the original deed. Once the details of this conversation are clarified, the commission will work with the church to disburse its remaining assets.

DISSOLUTION OF PICKENS PRESBYTERIAN CHURCH

Rich Cardot, pastor of the Valley Parish, now chairs the commission. The commission met with Pickens Ruling Elder Charles Delaney at the Pickens Volunteer Fire Department on November 15, 2019. The group discussed the health and pastoral care of the remaining members of the church, the transfer of the records of the church, the finances of the church, the disposition of the real property, and possibilities to celebrate the life and ministry of the congregation. The Stated Clerk received a letter stating that the financial accounts of the church have been closed. The commission is working with the Trustees to sell or transfer the real property to a member of the church community. The commission plans a closing celebration to include the churches of the Valley Parish and Zion Presbyterian Church, Helvetia in the spring.

DISSOLUTION OF WESTMINSTER PRESBYTERIAN CHURCH, CHARLESTON

The commission is working with the session to conclude the business of the church. A sale of the church building and its surrounding property by the church is pending. The session record and other historical records have been delivered to the Stated Clerk. The remaining real property is being transferred to the Presbytery. The commission is in communication with the members of the church regarding pastoral care and their ongoing discipleship and future church membership.

REPORT OF THE BLUESTONE COMMITTEE Denny Dodson, Committee Chair

RECOMMENDATION:

1. (CA) Approval of the celebration of the Lord's Supper at the Guy's Weekend, April 24-26, 2020, Spring Getaway Retreat, May 1-3, 2020, and Fall Getaway Retreat, October 2-4, 2020, at Bluestone Camp & Retreat, with a Minister of Word and Sacrament member of Presbytery as officiant.

INFORMATION:

- 1. The committee asks for general support of the Bluestone programs from all the churches and members of Presbytery. We encourage all churches to allow the Spirit to move them to consider holding church retreats at Bluestone, as well as participating in the special retreats available throughout the year.
- 2. The committee lost two members due to attrition, and even with the Presbytery Manual's reduction of the number of committee members, we sometimes are struggling to keep a quorum for our meetings. We continue to work on motivating maximum participation from committee members, who have secular and church employment, which often overlaps with the committee's work.
- 3. The committee approved the 2020 budget for Bluestone as well as our annual request of the Friends of Bluestone for budgetary support. The committee as always wishes to thank all of Presbytery and leadership for its moral and financial support for the work of the Bluestone summer camps, retreats, and conferences.
- 4. The committee designated February 8 for a day-long workshop to solidify our role as a committee who we are, what we do, what we need to do, and how we reach our full potential as servants of God as we oversee and direct the work of Bluestone.
- 5. The committee is presently putting forth our efforts to maximize participation in the Guys Weekend, the Spring Getaway Retreat, the summer camping experience and the Fall Getaway Retreat, along with the other special weekends and weeklong functions happening at Bluestone in the spring, summer, and fall.

REPORT OF THE LEADERSHIP TEAM Steve Hornbeck, Chair

INFORMATION:

- 1. The Leadership Team Retreat was held on January 13-14, 2020. The team spent time in worship led by Tina Vial and team building led by Robin Ray. Our thanks to both for meaningful and interesting programs.
- 2. Amy Wallace Parker was designated as the Overture Advocate for the Presbytery's overture concerning the laying on of hands during ordinations and installations. The overture will be considered by the 2020 General Assembly.
- 3. A group has been assigned to plan locations, themes, and dates of Presbytery meetings for 2021. Congregations interested in hosting a presbytery meeting should contact the Stated Clerk or Leadership Team Chair Steve Hornbeck. Suggestions for themes/speakers for the educational portion of the meeting are also welcome.
- 4. A group was designated to recommend procedures for the New Life Congregational Grants including a name for the group who reviews and recommends awards. The grants are funded through the use of 80 percent of the funds gained from the closure and sale of churches. Tina Vial will serve as the convener of this group.
- 5. A group of former Presbytery Moderators was designated to review the three-year model for Moderator-Elect, Moderator, and Leadership Team Chair. Several former moderators have recommended a review of this process because of the varying skills required of the leaders and the brief time available to complete planned initiatives. Amy Wallace Parker will convene this group.
- 6. Approved a request by the Presbyterian Women to celebrate the Lord's Supper at their gathering on March 28, 2020.
- 7. Tentative meeting dates for the Leadership Team for 2020 were established for May 5, 2020; July 30, 2020, and November 3, 2020.
- 8. The team looked at evolving trends in membership and at budget realities that result from these trends. Stewardship will provide the team with the probable implications of reducing the draw on restricted funds for the near future.
- 9. Church security was discussed, and the Stated Clerk will contact insurers and legal representatives concerning security recommendations for the Presbytery and its churches.

REPORT OF THE TRUSTEES James Robinson, Trustees Chair

INFORMATION:

- 1. Met via conference call on January 17, 2020, and concurred with the recommendation from Westminster Presbyterian Church, Charleston, to sell the church property for \$135,000 cash. In accordance with lines 166-170 of the Manual of the Presbytery of West Virginia, met via conference call on January 20, 2020 with General Presbyter Ed Thompson, out-going Moderator Steve Hornbeck, and Stated Clerk Maureen Wright to approve the sale.
- 2. Expect to complete action soon on the transfer of the dissolved Richwood Presbyterian Church building and the sale of the Hurricane property.
- 3. The remaining lots of the soon to be dissolved Westminster Presbyterian Church, Charleston, property, and the Beverly Hills Presbyterian Church property are being transferred to the Presbytery in accordance with the Book of Order.
- 4. The sale of the dissolved Brush Creek Presbyterian Church, Ridgeview, property has been completed.
