The implication of taking these advantages is that a CP who does so must take on the responsibility of being self-employed. In this case Medicare and FICA are not collected. The church should provide a SECA allowance paid to the CP. Specific tax questions should be directed to a CPA or tax attorney.

This covenantal relationship is subject to the terms of the Leave Policy approved by the Presbytery of West Virginia at its meeting on November 18, 2023; the policy is available on the Presbytery website.

It is agreed that this covenant may be terminated without cause upon 30 days written notice either by the Commissioned Pastor or by the session.

## All pastoral leaders in the Presbytery of West Virginia are required to complete Sexual Misconduct Prevention training.
